11 Correctional Center shall be located at Lexington in Cleveland
12 County, State of Oklahoma; and the Howard C. McLeod Correctional
13 Center shall be located at Farris in Atoka County, State of
14 Oklahoma; and the Mack H. Alford Correctional Center shall be
15 located at Stringtown in Atoka County, State of Oklahoma; and the
16 Jim E. Hamilton Correctional Center shall be located at Hodgen in
17 LeFlore County, State of Oklahoma; and the Mabel Bassett
18 Correctional Center shall be located at McLoud, in Pottawatomie
19 County, State of Oklahoma; and the R.B. "Dick" Conner Correctional
20 Center shall be located at Hominy in Osage County, State of
21 Oklahoma; and the James Crabtree Correctional Center shall be
22 located at Helena in Alfalfa County, State of Oklahoma; and the Jess
23 Dunn Correctional Center shall be located at Taft in Muskogee
24 County, State of Oklahoma; and the Northeast Oklahoma Correctional

1 Center shall be located at Vinita in Craig County, State of
2 Oklahoma; and the John Lilley Correctional Center shall be located
3 at Boley in Okfuskee County, State of Oklahoma; and the William S.
4 Key Correctional Center shall be located at Fort Supply in Woodward
5 County, State of Oklahoma; and the Dr. Eddie Walter Warrior
6 Correctional Center shall be located at Taft in Muskogee County,
7 State of Oklahoma; and the Clara Waters and Kate Barnard Community
8 Corrections Centers shall be located at Oklahoma City in Oklahoma
9 County, State of Oklahoma; ~~and the Muskogee Community Corrections~~
10 ~~Center shall be located at Muskogee in Muskogee County, State of~~
11 ~~Oklahoma;~~ and the Lawton Community Corrections Center shall be
12 located at Lawton in Comanche County, State of Oklahoma; and the
13 Enid Community Corrections Center shall be located at Enid in
14 Garfield County, State of Oklahoma; and the Union City Community
15 Corrections Center shall be located at Union City in Canadian
16 County, State of Oklahoma; and the Charles E. "Bill" Johnson
17 Correctional Center shall be located east of Alva in Woods County,
18 State of Oklahoma; and the Southern Oklahoma Resource Center shall
19 be located at Pauls Valley in Garvin County, State of Oklahoma; and
20 said institutions and community corrections centers are hereby
21 established within the Department. Said Department shall be the
22 legal successor of and, except as otherwise provided in the Oklahoma
23 Corrections Act of 1967, shall have the powers and duties vested by
24 law in the Office of Management and Enterprise Services in all

1 matters relating to penal institutions, heretofore or hereafter
2 established by the Department, which institutions and community
3 corrections centers shall be under the administrative direction and
4 control of the Department."
