10 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

11 SECTION 1. AMENDATORY 47 O.S. 2011, Section 1104.11, as  
12 amended by Section 189, Chapter 304, O.S.L. 2012 (47 O.S. Supp.  
13 2014, Section 1104.11), is amended to read as follows:

14 Section 1104.11. A. Twenty Dollars (\$20.00) of the fee  
15 authorized by Section 1135.5 of this title for the Patriot License  
16 Plate shall be deposited in the Patriot License Plate Revolving Fund  
17 created in subsection B of this section.

18 B. There is hereby created in the State Treasury a revolving  
19 fund for the Military Department of Oklahoma to be designated the  
20 "Patriot License Plate Revolving Fund". The fund shall be a  
21 continuing fund, not subject to fiscal year limitations, and shall  
22 consist of all monies received by the Military Department of  
23 Oklahoma pursuant to the provisions of subsection A of this section.  
24 All monies accruing to the credit of the fund are hereby

1 appropriated and may be budgeted and expended by the Military  
2 Department of Oklahoma for any deployment-related purpose ~~for~~  
3 ~~Oklahoma residents who are members of the Oklahoma National Guard~~  
4 including, but not limited to, the production of historical  
5 documents, displays, videos, and books that capture the National  
6 Guard's involvement in overseas deployments and domestic operations  
7 within the United States for members of the Oklahoma National Guard,  
8 Oklahoma public school libraries, and civic leaders, as determined  
9 by the Adjutant General. Expenditures from the fund shall be made  
10 upon warrants issued by the State Treasurer against claims filed as  
11 prescribed by law with the Director of the Office of Management and  
12 Enterprise Services for approval and payment.

13 ~~SECTION 2. It being immediately necessary for the preservation~~  
14 ~~of the public peace, health and safety, an emergency is hereby~~  
15 ~~declared to exist, by reason whereof this act shall take effect and~~  
16 ~~be in full force from and after its passage and approval.~~
