9 AS INTRODUCED

10 An Act relating to the Oklahoma State Regents for  
11 Higher Education; making appropriations; authorizing  
12 expenditures of certain funds; stating purpose;  
13 requiring budgeting of certain funds in certain  
14 years; providing lapse dates; requiring certain  
15 budget procedures; prohibiting certain budget  
16 procedures; and providing an effective date.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. There is hereby appropriated to the Oklahoma State  
19 Regents for Higher Education from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury for  
21 the fiscal year ending June 30, 2016, the sum of \_\_\_\_\_  
22 Dollars (\$0.00) or so much thereof as may be necessary for  
23 allocation by the Oklahoma State Regents for Higher Education  
24 pursuant to the provisions of Article XIII-A of the Oklahoma  
Constitution for the education and general operating budgets of the

1 institutions and for other programs, construction, renovations or  
2 repairs administered by the Oklahoma State Regents for Higher  
3 Education. Of those funds appropriated, the sum of \_\_\_\_\_  
4 Dollars (\$0.00) shall be transferred to the Oklahoma Tuition  
5 Equalization Grant Trust Fund to implement the provisions of the  
6 Oklahoma Tuition Equalization Grant Act.

7 SECTION 2. There is hereby appropriated to the Oklahoma State  
8 Regents for Higher Education from any monies not otherwise  
9 appropriated from the Special Cash Fund of the State Treasury, the  
10 sum of \_\_\_\_\_ Dollars (\$0.00) or so much thereof as  
11 may be necessary for the education and general operating budgets of  
12 the institutions and for other programs, construction, renovations  
13 or repairs administered by the Oklahoma State Regents for Higher  
14 Education.

15 SECTION 3. The Oklahoma State Regents for Higher Education are  
16 hereby authorized to expend during the fiscal year ending June 30,  
17 2016, the sum of \_\_\_\_\_ Dollars (\$0.00) from the Higher  
18 Education Capital Revolving Fund of the State Treasury for  
19 allocation by the Oklahoma State Regents for Higher Education  
20 pursuant to the provisions of Article XIII-A of the Oklahoma  
21 Constitution for the education and general operating budgets of the  
22 institutions and for other programs, construction, renovations or  
23 repairs administered by the Oklahoma State Regents for Higher  
24 Education.

1 SECTION 4. The Oklahoma State Regents for Higher Education are  
2 hereby authorized to expend during the fiscal year ending June 30,  
3 2016, the sum of \_\_\_\_\_ Dollars (\$0.00) from the  
4 Oklahoma Student Aid Revolving Fund of the State Treasury for  
5 allocation by the Oklahoma State Regents for Higher Education  
6 pursuant to the provisions of Article XIII-A of the Oklahoma  
7 Constitution for the education and general operating budgets of the  
8 institutions and for other programs, construction, renovations or  
9 repairs administered by the Oklahoma State Regents for Higher  
10 Education.

11 SECTION 5. There is hereby appropriated to the Oklahoma State  
12 Regents for Higher Education from any monies not otherwise  
13 appropriated from the General Revenue Fund of the State Treasury for  
14 the fiscal year ending June 30, 2016, the sum of  
15 \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be  
16 necessary for expenditures for concurrent enrollment pursuant to  
17 Section 628.13 of Title 70 of the Oklahoma Statutes.

18 SECTION 6. There is hereby appropriated to the Oklahoma State  
19 Regents for Higher Education from any monies not otherwise  
20 appropriated from the Oklahoma Education Lottery Trust Fund of the  
21 State Treasury for the fiscal year ending June 30, 2016, the sum of  
22 \_\_\_\_\_ Dollars (\$0.00) pursuant to paragraph 2 of  
23 subsection C of Section 713 of Title 3A of the Oklahoma Statutes for  
24 allocation by the Oklahoma State Regents for Higher Education

1 pursuant to provisions of Article XIII-A of the Oklahoma  
2 Constitution for construction, renovations or repairs administered  
3 by the Oklahoma State Regents for Higher Education or for any other  
4 purpose authorized by paragraph 2 of subsection C of Section 713 of  
5 Title 3A of the Oklahoma Statutes.

6 SECTION 7. There is hereby appropriated to the Oklahoma State  
7 Regents for Higher Education from any monies not otherwise  
8 appropriated from the General Revenue Fund of the State Treasury for  
9 the fiscal year ending June 30, 2016, the sum of

10 \_\_\_\_\_ Dollars (\$0.00) or so much thereof as may be  
11 necessary for the general operating budget of the Administrative  
12 Offices of the Oklahoma State Regents for Higher Education.

13 SECTION 8. Appropriations made by this act, not including  
14 appropriations made for capital outlay purposes, may be budgeted for  
15 the fiscal year ending June 30, 2016 (hereafter FY-16) or may be  
16 budgeted for the fiscal year ending June 30, 2017 (hereafter FY-17).  
17 Funds budgeted for FY-16 may be encumbered only through June 30,  
18 2016, and must be expended by November 15, 2016. Any funds  
19 remaining after November 15, 2016, and not budgeted for FY-17, shall  
20 lapse to the credit of the proper fund for the then current fiscal  
21 year. Funds budgeted for FY-17 may be encumbered only through June  
22 30, 2017. Any funds remaining after November 15, 2017, shall lapse  
23 to the credit of the proper fund for the then current fiscal year.  
24 These appropriations may not be budgeted in both fiscal years

1 simultaneously. Funds budgeted in FY-16, and not required to pay  
2 obligations for that fiscal year, may be budgeted for FY-17, after  
3 the agency to which the funds have been appropriated has prepared  
4 and submitted a budget work program revision removing these funds  
5 from the FY-16 budget work program and after such revision has been  
6 approved by the Office of Management and Enterprise Services.

7 SECTION 9. This act shall become effective July 1, 2015.
