7 An Act relating to public finance; imposing duty on  
8 certain state government entities with respect to  
9 reduction of federal appropriations or federal block  
10 grant or other funds; requiring information to be  
11 provided to the Director of the Office of Management  
12 and Enterprise Services, the Governor, the Speaker of  
13 the Oklahoma House of Representatives and the  
14 President Pro Tempore of the Oklahoma State Senate;  
15 imposing requirements for disclosure of federal funds  
16 and analysis regarding reliance and costs for  
17 compliance; providing for codification; and providing  
18 an effective date.

1 B. The contingency plan and corresponding budget shall be  
2 submitted to the Director of the Office of Management and Enterprise  
3 Services, the Governor, the Speaker of the Oklahoma House of  
4 Representatives and the President Pro Tempore of the Oklahoma State  
5 Senate within thirty (30) days from the effective date of this act.

6 C. Every entity subject to the requirements of this section  
7 shall make an annual disclosure pursuant to a separate written  
8 report and information available through a website maintained by or  
9 on behalf of the entity of all federal funds under the control of  
10 the entity and the programs for which the federal funds are used by  
11 distinct expenditure categories and shall identify the priority or  
12 rank of the federal funds in descending order with the funding  
13 source the agency relies on to the greatest extent listed first and  
14 the funding source the agency relies on to the least extent listed  
15 last. The information required by this subsection shall include,  
16 but shall not be limited to:

17 1. A description of any action required to be taken by the  
18 state government entity as a condition for the receipt or continued  
19 receipt of federal funds;

20 2. A description of any action prohibited to be taken by the  
21 state government entity as a condition for the receipt or continued  
22 receipt of federal funds;

23 3. A description of any action required to be taken by any  
24 individual or lawfully recognized business entity or other entity as

1 a condition for the benefits purported to be conferred on the  
2 individual or other legal entity as a result of the use of the  
3 federal funds; and

4 4. A description of any action prohibited to be taken by any  
5 individual or lawfully recognized business entity or other entity as  
6 a condition for the benefits purported to be conferred on the  
7 individual or other legal entity as a result of the use of the  
8 federal funds.

9 D. Every entity subject to the requirements of this section  
10 shall make an annual disclosure either pursuant to a separate  
11 written report, information available through a website maintained  
12 by or on behalf of the entity or both, of the federal funds for  
13 which the agency must incur costs to implement and shall provide  
14 such information in descending order with the most costly federal  
15 funds listed first and the least costly federal funds listed last.

16 SECTION 2. This act shall become effective November 1, 2015.
