BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. NEW LAW A new section of law to be codified
in the Oklahoma Statutes as Section 5060.44 of Title 74, unless
there is created a duplication in numbering, reads as follows:

A. The Oklahoma Science and Technology Research and Development
Board (OSTRaD) shall establish a pilot program for purposes of
monitoring the progress of grant recipients, intern and business
owner demographics.

B. The Board shall provide a report not later than December 1
each year to the Speaker of the Oklahoma House of Representatives,
the President Pro Tempore of the Oklahoma State Senate and to the

1 minority leaders of both chambers summarizing the findings described
2 in subsection A of this section.

3 C. The purpose of the monitoring and reporting shall be to
4 provide more targeted services to women and economically
5 disadvantaged entrepreneurs.

6 SECTION 2. This act shall become effective July 1, 2015.

7 SECTION 3. It being immediately necessary for the preservation
8 of the public peace, health and safety, an emergency is hereby
9 declared to exist, by reason whereof this act shall take effect and
10 be in full force from and after its passage and approval.
