AS INTRODUCED

An Act relating to the Supreme Court; amending 20 O.S. 2011, Section 1310.1, as amended by Section 81, Chapter 304, O.S.L. 2012 (20 O.S. Supp. 2014, Section 1310.1), which relates to the Supreme Court Revolving Fund; modifying name; modifying authorization; amending 20 O.S. 2011, Section 1310.3, as amended by Section 83, Chapter 304, O.S.L. 2012 (20 O.S. Supp. 2014, Section 1310.3), which relates to the Supreme Court Administrative Revolving Fund; modifying procedure; modifying authorized expenditures; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 20 O.S. 2011, Section 1310.1, as amended by Section 81, Chapter 304, O.S.L. 2012 (20 O.S. Supp. 2014, Section 1310.1), is amended to read as follows:

Section 1310.1 There is hereby created in the State Treasury a revolving fund for the ~~State~~ Supreme Court, to be designated the "Supreme Court Revolving Fund". The fund shall be a continuing fund,

1 not subject to fiscal year limitations, and shall consist of monies
2 appropriated by the Legislature for the purposes specified in this
3 section. All monies accruing to the credit of said fund are hereby
4 appropriated and may be budgeted and expended by the Supreme Court
5 for refunds to bondsmen and for the purpose of paying expenses
6 authorized by Section 1809 of Title 12 of the Oklahoma Statutes,
7 Sections 103.1, 1311, 1507, ~~and~~ 1660 and 1707 of this title, and
8 Sections 562 and 1355.13A of Title 22 of the Oklahoma Statutes, and
9 to make any other expenditures determined by the State Supreme Court
10 to be necessary due to unforeseen emergencies impacting the
11 operation of state courts, as well as nonrecurring expenditures to
12 perform the duties imposed upon the State Supreme Court or Court of
13 Civil Appeals by law. Expenditures from said fund shall be made upon
14 warrants issued by the State Treasurer against claims filed as
15 prescribed by law with the Director of the Office of Management and
16 Enterprise Services for approval and payment.

17 SECTION 2. AMENDATORY 20 O.S. 2011, Section 1310.3, as
18 amended by Section 83, Chapter 304, O.S.L. 2012 (20 O.S. Supp. 2014,
19 Section 1310.3), is amended to read as follows:

20 Section 1310.3. There is hereby created in the State Treasury a
21 revolving fund for the Supreme Court to be designated as the
22 "Supreme Court Administrative Revolving Fund". The fund shall be a
23 continuing fund, not subject to fiscal year limitations, and shall
24 consist of all monies transferred by the Supreme Court ~~from~~

1 ~~legislative appropriations~~ in any given fiscal year or years. All
2 monies accruing to the credit of the fund are hereby appropriated
3 and may be budgeted and expended by the Supreme Court ~~for~~ as
4 necessary to perform the duties imposed upon the Supreme Court,
5 Court of Civil Appeals and district courts by law. Expenditures from
6 said fund shall be made upon warrants issued by the State Treasurer
7 against claims filed as prescribed by law with the Director of the
8 Office of Management and Enterprise Services for approval and
9 payment.

10 SECTION 3. It being immediately necessary for the preservation
11 of the public peace, health and safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
