1 codes currently adopted by the Uniform Building Commission of
2 Oklahoma shall be subject to the provisions of this act.

3 C. The construction, addition or alteration of a building no
4 more than two stories in height in the following Code Use Group or
5 buildings shall be exempt from this act:

6 1. Code Use Group U - Utility;

7 2. Incidental buildings or appurtenances associated with
8 subsection B of this section;

9 3. All uninhabitable, privately owned agricultural buildings;
10 and

11 4. One- and two-family dwellings and buildings consisting of
12 three or fewer townhouse units of any size or height as covered by
13 the codes.

14 D. The construction, addition or alteration of buildings where
15 the original Code Use Group was exempt shall remain exempt from this
16 act if the Code Use Group does not change.

17 SECTION 2. REPEALER 59 O.S. 2011, Section 46.21b, as
18 amended by Section 13, Chapter 234, O.S.L. 2014 (59 O.S. Supp. 2015,
19 Section 46.21b), is hereby repealed.

20 SECTION 3. This act shall become effective November 1, 2016.
