6 AS INTRODUCED

7 An Act relating to higher education; amending 70 O.S.
8 2011, Section 3218.2, which relates to setting
9 tuition and fees by the Oklahoma State Regents for
10 Higher Education; adding information to be included
11 in certain annual report; requiring each institution
of The Oklahoma State System of Higher Education to
submit an annual report to certain persons;
specifying information to be included in the annual
report; and providing an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. AMENDATORY 70 O.S. 2011, Section 3218.2, is
17 amended to read as follows:

18 Section 3218.2 A. Resident tuition, nonresident tuition, and
19 other fees to be required of students receiving instruction or other
20 academic services provided by institutions of The Oklahoma State
21 System of Higher Education shall be established by the Oklahoma
22 State Regents for Higher Education with due regard for the
23 provisions of Section 3218.14 of this title within limits prescribed
24 by the Legislature. Nothing in this act shall be construed as

1 limiting or prohibiting the requirement of payment for goods or
2 services provided by auxiliary enterprises operated by or in
3 conjunction with institutions of The Oklahoma State System of Higher
4 Education and authorized by the Oklahoma State Regents for Higher
5 Education.

6 B. By January 1 of each year, the Oklahoma State Regents for
7 Higher Education shall submit a report to the Governor, the
8 President Pro Tempore of the Senate, the Speaker of the House of
9 Representatives, and the minority floor leaders and education
10 committee chairs of both houses of the Oklahoma Legislature, ~~of the~~
11 actions. The annual report shall include the following information:

12 1. Actions taken in regard to and the schedule of tuition and
13 fees approved for The Oklahoma State System of Higher Education for
14 the current academic year. ~~The annual report shall include data;~~

15 2. Data on the impact of any tuition or fee increases on the
16 ability of students to meet the costs of attendance, enrollment
17 patterns, availability of financial aid, ~~and any;~~

18 3. The budget prepared by the State Regents setting out in
19 detail the necessary expenses of the State Regents for the next
20 fiscal year;

21 4. The budget requests or proposals submitted by each
22 institution to the State Regents for the next fiscal year;

23 5. The funding formula or allotment system used by the State
24 Regents to allocate money to each institution, including a

1 description of the functional goals of the formula or system for
2 distributing funds to each institution;

3 6. A calculation of any differences in the budget requests
4 amounts for each institution and the actual amounts allocated to
5 each institution, including an explanation for any differences; and

6 7. Any other data considered relevant by the State Regents.

7 C. By January 1 of each year, each institution of The Oklahoma
8 State System of Higher Education shall submit a report to the
9 Governor, the President Pro Tempore of the Senate, the Speaker of
10 the House of Representatives, and the minority floor leaders and
11 education committee chairs of both houses of the Oklahoma
12 Legislature. The annual report shall include the following
13 information:

14 1. A copy of reports submitted to the State Regents which
15 itemizes the tuition and fees for each institution by campus or
16 location; and

17 2. The total budget of each institution for the previous fiscal
18 year including the amount of revenue received from tuition and fee
19 and other sources and expenses for each campus or location.

20 SECTION 2. This act shall become effective November 1, 2016.
