6 AS INTRODUCED

7 An Act relating to emergency responders; creating the  
8 Oklahoma Incident Management Team Advisory Committee;  
9 setting duties and purpose; providing for membership;  
10 providing that members receive no compensation or  
11 travel reimbursement; providing for quorum; providing  
12 for naming of chair; providing for frequency of  
13 meetings; providing for codification; and providing  
14 an effective date.

15 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

16 SECTION 1. NEW LAW A new section of law to be codified  
17 in the Oklahoma Statutes as Section 2-108.4 of Title 47, unless  
18 there is created a duplication in numbering, reads as follows:

19 A. There is hereby created within the Oklahoma Department of  
20 Public Safety the Oklahoma Incident Management Team Advisory  
21 Committee. The purpose of the Committee shall be to:

22 1. Advise and assist the Commissioner in the development,  
23 administration and operation of setting of goals, objectives and  
24 priorities with respect to state-sponsored emergency incident  
management team functions;

1           2. Establish standards and credentialing guidelines for the  
2 emergency incident management functions and responders within the  
3 Team Advisory Committee's jurisdiction; and

4           3. Provide a forum or mediation point for resolution of issues  
5 between the organizations within the Team Advisory Committee.

6           B. The Team Advisory Committee shall be composed of the  
7 following seven (7) members as follows:

8           1. The Commissioner of Health, or designee;

9           2. The Director of the Oklahoma Forestry Services, or designee;

10           3. The Commissioner of the Oklahoma Department of Public  
11 Safety, or designee;

12           4. The Director of the Oklahoma Office of Homeland Security, or  
13 designee;

14           5. The Director of the Office of Emergency Management, or  
15 designee;

16           6. One member appointed by the Oklahoma Fire Chiefs Association  
17 to represent a statewide association of fire chiefs in this state;  
18 and

19           7. The Director of the Oklahoma State University Fire Safety  
20 Training, or designee.

21           In addition to the seven (7) members, membership may be expanded  
22 by a majority vote of the Committee.

23           C. The members of the Team Advisory Committee shall receive no  
24 compensation or travel reimbursement.

1 D. A majority of the Team Advisory Committee shall constitute a  
2 quorum to transact official business.

3 E. The members of the Team Advisory Committee may elect from  
4 among its membership a chair and vice chair to preside at all  
5 meetings.

6 F. The Committee shall meet within ninety (90) days after the  
7 effective date of this act and shall meet at least twice a year or  
8 more frequently at the discretion of the chair.

9 SECTION 2. This act shall become effective November 1, 2016.
