6 AS INTRODUCED

7 An Act relating to school superintendents;
8 establishing maximum salary schedule for
9 superintendents; prohibiting school district boards
10 of education from entering into or renewing contracts
11 above certain caps; allowing the State Board of
12 Education to approve waivers to certain maximum
13 amounts for certain districts; providing definition;
14 providing for promulgation of rules; providing for
15 codification; providing an effective date; and
16 declaring an emergency.

17 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

18 SECTION 1. NEW LAW A new section of law to be codified
19 in the Oklahoma Statutes as Section 18-114.15 of Title 70, unless
20 there is created a duplication in numbering, reads as follows:

21 A. Beginning with the 2016-2017 school year, superintendents in
22 the public schools of Oklahoma shall receive in compensation not
23 more than the amounts specified in the following schedule:

24 1. One Hundred Thousand Dollars (\$100,000.00) for the
superintendent of a district or districts with an average daily
membership (ADM) of two hundred fifty (250) or less;

1 2. One Hundred Ten Thousand Dollars (\$110,000.00) for the
2 superintendent of a district or districts with an ADM of seven
3 hundred fifty (750) or less but more than two hundred fifty (250);

4 3. One Hundred Twenty Thousand Dollars (\$120,000.00) for the
5 superintendent of a district or districts with an ADM of one
6 thousand five hundred (1,500) or less but more than seven hundred
7 fifty (750);

8 4. One Hundred Thirty Thousand Dollars (\$130,000.00) for the
9 superintendent of a district or districts with an ADM of three
10 thousand (3,000) or less but more than one thousand five hundred
11 (1,500);

12 5. One Hundred Forty Thousand Dollars (\$140,000.00) for the
13 superintendent of a district or districts with an ADM of six
14 thousand five hundred (6,500) or less but more than three thousand
15 (3,000); and

16 6. One Hundred Fifty Thousand Dollars (\$150,000.00) for the
17 superintendent of a district or districts with an ADM of more than
18 six thousand five hundred (6,500).

19 B. A school district board of education shall not enter into a
20 new contract or renew a contract with a superintendent after the
21 effective day of this act that exceeds the maximum compensation
22 amounts provided for in subsection A of this section.

23 C. The State Board of Education, upon written application by
24 the school district board of education, may approve a waiver of the

1 maximum compensation amounts for any district or districts with an
2 ADM of ten thousand (10,000) or more.

3 D. For the purposes of this section, "compensation" shall mean
4 base salary and fringe benefits.

5 E. The State Board of Education shall promulgate rules
6 necessary to implement the provisions of this act.

7 SECTION 2. This act shall become effective July 1, 2016.

8 SECTION 3. It being immediately necessary for the preservation
9 of the public peace, health and safety, an emergency is hereby
10 declared to exist, by reason whereof this act shall take effect and
11 be in full force from and after its passage and approval.
