6 AS INTRODUCED

7 An Act relating to the Roofing Contractor
8 Registration Act; amending 59 O.S. 2011, Section
9 1151.22, which relates to workers' compensation
10 insurance; modifying use of affidavit of exemption;
11 requiring certain affidavit be attached to contract;
12 permitting affidavit of exemption only on certain
13 construction; requiring all workers be covered under
14 workers' compensation insurance; providing for day
15 laborer's affidavit under certain conditions;
16 prohibiting hiring certain company or persons not
17 registered or without workers' compensation coverage;
18 determining certain workers to be employees for
19 purpose of workers' compensation insurance; granting
20 certain immunity from liability for homeowners; and
21 providing an effective date.

24 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

25 SECTION 1. AMENDATORY 59 O.S. 2011, Section 1151.22, is
26 amended to read as follows:

27 Section 1151.22. A. Any contract entered into under the
28 Roofing Contractor Registration Act shall include a statement that
29 all individuals performing work under the contract are covered by
30 workers' compensation insurance.

31 B. If ~~the individuals performing work under the contract are~~
32 ~~not covered by~~ an affidavit of exemption for workers' compensation

1 insurance, ~~the contractor shall provide a written statement to the~~
2 ~~homeowner advising that the individuals performing work under the~~
3 ~~contract are not covered by workers' compensation insurance, which~~
4 is used by a legitimately exempt person, it shall be signed by all
5 parties to the contract and attached to the contract and it shall be
6 used only for residential construction projects. All commercial
7 projects shall require all individuals performing work on such
8 project to be covered by workers' compensation insurance as
9 employees of the person registered under the Roofing Contractor
10 Registration Act. However, any day laborer who can show proof of
11 being covered by workers' compensation insurance under the temporary
12 labor agency for whom he or she is hired-out may provide an
13 affidavit from the temporary labor agency to meet the requirement of
14 this section for authority to use an affidavit of exemption. No
15 roofing contractor required to be registered under the Roofing
16 Contractor Registration Act shall hire any out-of-state company or
17 person or use any person or independent contractor that is not
18 registered under the Roofing Contractor Registration Act with the
19 required workers' compensation insurance or who is not deemed his or
20 her employee for purposes of workers' compensation insurance.

21 C. In no event shall a homeowner be held liable for injury or
22 death to any person who performs work under a contract with a person
23 required by law to be registered under the Roofing Contractor
24

1 Registration Act and have workers' compensation on all persons
2 performing work on the roofing project.

3 SECTION 2. This act shall become effective November 1, 2016.
