1 dialing capacity or access shall be required to configure the
2 telephone or equivalent system to allow a person initiating a 9-1-1
3 call on the system to directly access 9-1-1 without an additional
4 code, digit, prefix, postfix, or trunk-access code.

5 B. A business owner or operator that provides residential or
6 business facilities utilizing a telephone system or equivalent
7 system as described in subsection A, shall configure the telephone
8 or equivalent system to provide a notification to a central location
9 on the site of the residential or business facility when a person
10 within the residential or business facility dials 9-1-1, provided
11 the business owner or operator's system is able to be configured to
12 provide such notification without an improvement to the system's
13 hardware. The requirement of this subsection does not require a
14 business owner or operator to have a person available at the central
15 location to receive such notification.

16 C. Telephone service providers and Interconnected VoIP Service
17 providers shall, within sixty (60) days following the enactment of
18 this act, and at least once annually thereafter, provide written
19 notification detailing the provisions of this act to any current
20 commercial customers operating in this state who may be affected by
21 this act. Such providers shall inform any new commercial customers
22 of the requirements of this act at the time service is initiated.

23 D. The provisions of this act shall apply to the extent such
24 provisions are not inconsistent with or preempted by federal law.

1 SECTION 3. This act shall become effective January 1, 2017.
