7 An Act relating to statutes; amending 75 O.S. 2011,
8 Section 14, as amended by Section 2, Chapter 361,
9 O.S.L. 2014 (75 O.S. Supp. 2014, Section 14), which
relates to free copies of statutes; authorizing
Boards of county commissioners to receive free copies
of statutes; and providing an effective date.

12 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

13 SECTION 1. AMENDATORY 75 O.S. 2011, Section 14, as
14 amended by Section 2, Chapter 361, O.S.L. 2014 (75 O.S. Supp. 2014,
15 Section 14), is amended to read as follows:

16 Section 14. A. The following officers shall be entitled to
17 receive, as soon as available from the state, without cost, copies
18 of the printed volumes of the statutes and session laws of the state
19 purchased by the Secretary of State, or under the authority of the
20 Secretary of State, for distribution to:

21 1. Each state officer, including the Governor and Lieutenant
22 Governor, the chief administrative officers and assistants of state
23 departments, boards, and commissions, upon written application and
24 request submitted to the Secretary of State, within sixty (60) days

1 of January 1 of each year, and said volumes shall be distributed at
2 the discretion of the Secretary of State; ~~and~~

3 2. Each member of the Legislature; ~~and~~

4 3. The Justices of the Supreme Court and the Judges of the
5 Court of Criminal Appeals, and the clerk of said Courts; ~~and~~

6 4. The chief administrative officers of the state educational,
7 benevolent, and penal institutions; ~~and~~

8 5. The judges of the district courts and district court clerks;
9 ~~and~~

10 6. Each board of county commissioners;

11 7. County clerks; ~~and~~

12 ~~7.~~ 8. County treasurers; ~~and~~

13 ~~8.~~ 9. County assessors; ~~and~~

14 ~~9.~~ 10. District attorneys and one assistant district attorney
15 in each county; ~~and~~

16 ~~10.~~ 11. Sheriffs; ~~and~~

17 ~~11.~~ 12. All members of the Oklahoma Congressional Delegation;
18 ~~and~~

19 ~~12.~~ 13. Each library association organized in any county, city,
20 or town in this state for the benefit of the public.

21 B. Fifty-five (55) copies of the statutes and session laws
22 shall be furnished to the law library of the College of Law of the
23 University of Oklahoma, five (5) copies to be kept for use therein
24 and fifty (50) copies for purposes of exchange.

1 C. Five (5) copies of the statutes and session laws shall be
2 placed in the library of Oklahoma State University at Stillwater,
3 Oklahoma, for use therein.

4 D. One hundred ten (110) copies of the statutes and session
5 laws shall be furnished to the Oklahoma Department of Libraries for
6 its use and exchange purposes.

7 E. The Secretary of State may, in his or her discretion,
8 furnish from any copies of such laws on hand to state officers other
9 than those specified in this section for the use of their offices.

10 SECTION 2. This act shall become effective November 1, 2015.
