6 AS INTRODUCED

7 An Act relating to schools; creating the Athletic
8 Association Oversight Board; setting duties of the
9 board; providing for membership of the board;
10 providing for the naming of chair; requiring
11 compliance with certain act; prohibiting compensation
and travel reimbursement; requiring submission of
certain report by certain date; providing for
codification; providing an effective date; and
declaring an emergency.

14 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

15 SECTION 1. NEW LAW A new section of law to be codified
16 in the Oklahoma Statutes as Section 27-104 of Title 70, unless there
17 is created a duplication in numbering, reads as follows:

18 A. There is hereby created the Athletic Association Oversight
19 Board to oversee the activities of any school athletic association
20 of which Oklahoma public schools are members.

21 B. The Oversight Board shall consist of three (3) members as
22 follows:

23 1. One member to be appointed by the Governor, who shall serve
24 as the chair of the Oversight Board;

1 2. One member to be appointed by the President Pro Tempore of
2 the Senate; and

3 3. One member to be appointed by the Speaker of the House of
4 Representatives.

5 C. Appointments to the Oversight Board shall be made within
6 thirty (30) days after the effective date of this act. The
7 Oversight Board shall conduct an organizational meeting not later
8 than sixty (60) days after the effective date of this act.

9 D. The Oversight Board shall oversee the functions and review
10 the annual budget of any school athletic association of which
11 Oklahoma public schools are members.

12 E. The Oversight Board may meet as often as may be required in
13 order to perform the duties imposed upon it.

14 F. The meetings of the Oversight Board shall be subject to the
15 Oklahoma Open Meeting Act.

16 G. Members of the Oversight Board shall receive no compensation
17 or travel reimbursement for serving on the Oversight Board.

18 H. Beginning December 31, 2015, and every December 31
19 thereafter, the Oversight Board shall submit a report of its
20 findings to the Governor, the President Pro Tempore of the Senate
21 and the Speaker of the House of Representatives.

22 SECTION 2. This act shall become effective July 1, 2015.

23 SECTION 3. It being immediately necessary for the preservation
24 of the public peace, health and safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
