SENATE BILL 867

AS INTRODUCED

An Act relating to barbers; amending 59 O.S. 2011, Section 199.14, as last amended by Section 11, Chapter 260, O.S.L. 2014 (59 O.S. Supp. 2015, Section 199.14), which relates to license fees; removing certain fee; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 59 O.S. 2011, Section 199.14, as last amended by Section 11, Chapter 260, O.S.L. 2014 (59 O.S. Supp. 2015, Section 199.14), is amended to read as follows:

Section 199.14. A. The following fees shall be charged by the State Board of Cosmetology and Barbering:

1 B. In addition to the fees specified in subsection A of this
2 section, the Board shall charge a total penalty of Ten Dollars
3 (\$10.00), as provided for in Section 199.10 of this title.

4 C. Any person licensed as an advanced operator prior to July 1,
5 1985, may renew the advanced cosmetologist license annually by
6 payment of the fee required by this section and by being in
7 compliance with the rules promulgated by the State Board of
8 Cosmetology and Barbering.

9 D. Any person having a valid license as a barber who was
10 required to be licensed a barber establishment beginning on November
11 1, 2014, upon the transfer of authority from the State Board of
12 Health to the State Board of Cosmetology and Barbering, is hereby
13 exempt from the barber establishment license upon the effective date
14 of this act.

15 SECTION 2. This act shall become effective November 1, 2016.
