1 B. The Department shall cancel all contracts and other
2 agreements for the provision of services by the OMI at the earliest
3 feasible date following the effective date of this act, and shall
4 not renew any contract relating to the OMI.

5 C. The Department of Human Services shall promulgate rules to
6 implement the provisions of this act.

7 SECTION 2. REPEALER Section 1, Chapter 231, O.S.L. 2013
8 (56 O.S. Supp. 2015, Section 230.78), is hereby repealed.

9 SECTION 3. This act shall become effective July 1, 2016.

10 SECTION 4. It being immediately necessary for the preservation
11 of the public peace, health and safety, an emergency is hereby
12 declared to exist, by reason whereof this act shall take effect and
13 be in full force from and after its passage and approval.
