An Act relating to the Bill of Rights Monument Display Act; creating the Bill of Rights Monument Display Act; providing short title; authorizing the State Capitol Preservation Commission to permit placement of certain monument on the State Capitol grounds; providing for design, construction, payment and placement of monument; and providing for codification.
