Fortieth Legislative Day, Tuesday, April 12, 2016

Colonel Wilham recognized Oklahoma National Guard Members with a medal presentation.

Colonel Wilham read a formal Proclamation from Governor Fallin recognizing 45th Infantry Division Appreciation Day and presented the Proclamation to Brigadier General Thompson.
