MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 1052, 1058, 1072, 1077, 1083, 1294, 1331, 1408, 1619, 1687 and 1986.**

HB 1052 – By McDaniel (Randy) of the House and Jolley of the Senate.

An Act relating to the Oklahoma State Pension Commission; amending 74 O.S. 2011, Section 941, as amended by Section 930, Chapter 304, O.S.L. 2012 (74 O.S. Supp. 2014, Section 941), which relates to membership and duties of the Commission; modifying provisions related to legislative appointees; providing legislative members nonvoting; modifying membership; modifying certain qualifications; and providing an effective date.

HB 1058 – By Casey of the House and Halligan of the Senate.

An Act relating to public finance; amending 62 O.S. 2011, Section 34.64, as amended by Section 387, Chapter 304, O.S.L. 2012 (62 O.S. Supp. 2014, Section 34.64), which relates to payment of claims or payrolls; authorizing institutions within the Oklahoma State System of Higher Education to process certain claims without forms; providing an effective date; and declaring an emergency.

HB 1072 – By Cleveland of the House and Dahm of the Senate.

An Act relating to higher education; repealing 70 O.S. 2011, Section 3214, which relates to a study of higher education institution employee benefit programs; repealing 70 O.S. 2011, Section 3215, which relates to a study of salary and other remunerative benefits for higher education institution faculty and staff; and providing an effective date.

HB 1077 – By Morrisette of the House and Pittman of the Senate.

An Act relating to railroads; requiring certain reports by the Department of Transportation and the Interstate Midwest Regional Passenger Rail Compact; specifying content of reports; requiring delivery of reports to certain officials; requiring periodic updating of reports; requiring certain requests for proposals; facilitating unbundling of present passenger rail service contracts; and providing for codification.

HB 1083 – By Ownbey of the House and Simpson of the Senate.

An Act relating to technology; establishing the Criminal Justice Information Systems Center for Excellence; stating purpose; stating administrative control; authorizing collaboration with agencies; allowing utilization of system for certain purposes; providing for codification; and providing an effective date.

HB 1294 – By Wesselhoft of the House and Stanislawski of the Senate.

An Act relating to the Employment Security Administration Fund; making an appropriation; specifying source; specifying programs and amounts of appropriation; requiring expenditure by certain date; requiring certain federal standards; requiring compliance with Social Security Act; and providing an effective date.

HB 1331 – By Coody (Ann) and Hoskin of the House and Simpson of the Senate.

An Act relating to schools; amending Section 1, Chapter 356, O.S.L. 2013 (70 O.S. Supp. 2014, Section 3-168), which relates to the Student Data Accessibility, Transparency and Accountability Act of 2013; modifying definition of student data; adding definition; adding exception for the release of confidential student data for students with a military student identifier; directing the State Board of Education to include a military student identifier in the state student data system; excluding a military student identifier from certain category of student data; providing an effective date; and declaring an emergency.

HB 1408 – By Billy of the House and Justice of the Senate.

An Act relating to public health and safety; amending 63 O.S. 2011, Section 1-1118, which requires a license for establishments selling food or drink; providing certain exceptions from licensing requirements; permitting State Board of Health to provide fee-exempt license to certain organizations; and providing an effective date.

HB 1619 – By Derby of the House and Standridge of the Senate.

An Act relating to lotteries; requiring Oklahoma Lottery Commission to notify Oklahoma Health Care Authority of certain individuals; requiring Oklahoma Lottery Commission to develop certain guidelines and procedures; providing for codification; and providing an effective date.

HB 1687 – By Denney of the House and Halligan of the Senate.

An Act relating to adult education; amending 70 O.S. 2011, Section 3-110.1, as amended by Section 1, Chapter 164, O.S.L. 2014 (70 O.S. Supp. 2014, Section 3-110.1), which relates to the allocation of funds for adult education; modifying name of certain diploma; amending Section 5, Chapter 164, O.S.L. 2014 (70 O.S. Supp. 2014, Section 14-132), which relates to certain contracts; authorizing contracts for certain assessment; updating statutory language; amending Section 6, Chapter 164, O.S.L. 2014 (70 O.S. Supp. 2014, Section 14-133), which relates to the Adult Education Revolving Fund; providing fund to consist of fee for certain purpose; updating statutory language; amending 57 O.S. 2011, Sections 138, as amended by Section 6, Chapter 228, O.S.L. 2012, 510.7 and 510.8 (57 O.S. Supp. 2014, Section 138), which relate to education programs for inmates; updating statutory language; providing an effective date; and declaring an emergency.

HB 1986 – By Ortega of the House and Brooks of the Senate.

An Act relating to public buildings and public works; amending Section 1, Chapter 248, O.S.L. 2014 (61 O.S. Supp. 2014, Section 327.1), which relates to certain redevelopment proposals; providing for representation on certain committee by a designee of the Long Range Capital Planning Commission; providing an effective date; and declaring an emergency.
