## First Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

**Twenty-fourth Legislative Day, Wednesday, March 11, 2015**

If an insurer for a transportation network company makes a payment for a claim covered under comprehensive or collision insurance coverage, the transportation network company shall cause its insurer to issue the payment directly to the business repairing the vehicle or jointly to the owner of the vehicle and the primary lienholder.” and by re-lettering subsequent subsections, which amendment was declared adopted.
