## First Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

**Thirty-eighth Legislative Day, Wednesday, April 8, 2015**

Senator Sharp moved to amend **HB 1965**, Page 3, Line 23, after the word "include" and before the ";" on Page 4, Line 2, by striking all language and inserting in lieu thereof the following: "a device that is physically or electronically integrated into a motor vehicle, or a voice-operated global positioning or navigation system that is affixed to a motor vehicle, or a hands-free device that allows the user to write, send, or read a text message without the use of either hand except to activate, deactivate, or initiate a feature or function" which amendment was declared adopted.
