Oklahoma Oil and Natural Gas License Plate – such plates shall be issued to any person wishing to demonstrate support for the Oklahoma oil and natural gas industry and such plates shall be designed in consultation with the Oklahoma Energy Resources Board As provided in this section, an amount of the fee collected shall be deposited in the Energy Resources Revolving Fund created in Section 288.7 of Title 52 of the Oklahoma Statutes.”; and Page 30, Line 14½, by adding a NEW SECTION 2 to read as follows:

“SECTION 2. AMENDATORY 52 O.S. 2011, Section 288.7, as amended by Section 215, Chapter 304, O.S.L. 2012 (52 O.S. Supp. 2015, Section 288.7), is amended to read as follows:

Section 288.7.

A. There is hereby created in the State Treasury a revolving fund for the Oklahoma Energy Resources Board to be designated the "Energy Resources Revolving Fund". The fund shall be a continuing fund, not subject to fiscal year limitations and shall consist of all monies received by the Oklahoma Energy Resources Board from assessments received and collected pursuant to Section 288.8A of this title, donations, grants, contributions and gifts from any public or private source and monies deposited pursuant to the provisions of Section 1135.5 of Title 47 of the Oklahoma Statutes. The Board may expend funds as provided for by law. Expenditures from said fund shall be made upon warrants issued by

the State Treasurer against claims filed as prescribed by law with the Director of the Office of Management and Enterprise Services for approval and payment.

B. Of the monies collected and not refunded pursuant to Sections 288.8A and 288.9A of this title, a minimum of fifty percent (50%) of said monies collected, including a prorated share of administrative costs incurred from the effective date of this act, and not subsequently refunded, shall be expended on environmental cleanup and remediation projects related to oil and gas pollution authorized by the Board from a priority list of projects submitted by the Corporation Commission or, only in the absence of Corporation Commission jurisdiction, projects submitted by other appropriate state agencies.

C. None of the monies collected and not refunded pursuant to Sections 288.8A and 288.9A of this title shall be used for travel expenses of any member of the Oklahoma Legislature.”; and by renumbering subsequent sections, which amendment was declared adopted.

MESSAGE FROM THE HOUSE

Advising passage of and transmitting for consideration Engrossed **HBs 2444, 3017, 3102** and **3103**.

HB 2444 – By ODonnell of the House and Smalley of the Senate.

An Act relating to pipeline safety; amending 17 O.S. 2011, Section 6.1, which relates to penalties for violations of pipeline safety rules, regulations and orders; modifying civil penalty for violations; amending 52 O.S. 2011, Section 47.6, which relates to the Hazardous Liquid Transportation System Safety Act; modifying administrative penalties for violations; providing an effective date; and declaring an emergency.

HB 3017 – By Calvey of the House and Sykes of the Senate.

An Act relating to healthcare; creating the Physician Orders for Life-Sustaining Treatment Act; providing short title; providing definitions; directing State Board of Medical Licensure and Supervision to establish format for certain form; requiring certain orders to conform to certain requirements; requiring certain information to be provided to patient or patient representative; prohibiting validity of certain forms under certain circumstances; prescribing contents, phrasing, and format of certain form; providing immunity from certain liability; providing liability for certain persons; permitting court enjoinder under certain circumstances; requiring certain orders under certain circumstances; amending 58 O.S. 2011, Section 1072.1, which relates to durable power of attorney; providing certain exception; clarifying language; directing State Board of Medical Licensure and Supervision to establish and publish certain format; providing for codification; providing for noncodification; and providing an effective date.

HB 3102 – By Caldwell and Kern of the House and Smalley of the Senate.

An Act relating to schools; amending 70 O.S. 2011, Section 6-122.3, as last amended by Section 7, Chapter 124, O.S.L. 2014 (70 O.S. Supp. 2015, Section 6-122.3), which relates to alternative placement teaching certification and programs; changing classroom teaching hours limit for adjunct teachers; providing an effective date; and declaring an emergency.

HB 3103 – By Caldwell of the House and Griffin of the Senate.

An Act relating to school elections; amending 26 O.S. 2011, Section 13A-110, as amended by Section 8, Chapter 380, O.S.L. 2015 (26 O.S. Supp. 2015, Section 13A-110), which relates to vacancies on boards of education; providing for the filling of certain vacancies on the board of education by appointment; allowing the appointment of persons who do not reside in certain districts; requiring appointed persons to reside in the school district and meet other eligibility qualifications; limiting service; and requiring certain boards of education to give preference to certain persons.
