

# Senate Journal

## Second Regular Session of the Fifty-fifth Legislature of the State of Oklahoma

**Twenty-sixth Legislative Day, Tuesday, March 15, 2016**

The Senate was called to order by Senator Stanislawski.

**HB 1697** by Denney et al of the House and Griffin et al of the Senate was called up for consideration.

Senator Griffin moved to amend **HB 1697**, by striking the title, the enacting clause and the entire body of the bill and substituting the floor substitute, which amendment was declared adopted. (Copies were provided for all Senators.)

Senator Griffin moved to amend the floor substitute to **HB 1697**, Page 1, by restoring the title and the enacting clause, which amendment was declared adopted.

Senator Griffin moved that **HB 1697** be advanced, which motion was declared adopted.
