13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. NEW LAW A new section of law to be codified
15 in the Oklahoma Statutes as Section 724.5 of Title 3A, unless there
16 is created a duplication in numbering, reads as follows:

17 The Oklahoma Lottery Commission shall notify the Oklahoma Health
18 Care Authority of individuals who win lottery prize monies pursuant
19 to Section 710 of Title 3A of the Oklahoma Statutes. The Oklahoma
20 Lottery Commission shall develop guidelines and procedures for
21 timely notifying the Oklahoma Health Care Authority of such
22 individuals, including identification of the individuals (including
23 social security number), amount of monies won, and the date money
24 was or is to be distributed.
