1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 SECTION 1. AMENDATORY Section 2, Chapter 208, O.S.L.
3 2013, as amended by Section 1, Chapter 150, O.S.L. 2018 (85A O.S.
4 Supp. 2018, Section 2), is amended to read as follows:

5 Section 2. As used in the Administrative Workers' Compensation 6 Act:

7 1. "Actually dependent" means a surviving spouse, a child or 8 any other person who receives one-half (1/2) or more of his or her 9 support from the employee;

"Carrier" means any stock company, mutual company, or
 reciprocal or interinsurance exchange authorized to write or carry
 on the business of workers' compensation insurance in this state.
 Whenever required by the context, the term "carrier" shall be deemed
 to include duly qualified self-insureds or self-insured groups;

15 3. "Case management" means the ongoing coordination, by a case 16 manager, of health care services provided to an injured or disabled 17 worker, including but not limited to systematically monitoring the 18 treatment rendered and the medical progress of the injured or 19 disabled worker; ensuring that any treatment plan follows all 20 appropriate treatment protocols, utilization controls and practice 21 parameters; assessing whether alternative health care services are 22 appropriate and delivered in a cost-effective manner based upon 23 acceptable medical standards; and ensuring that the injured or 24 disabled worker is following the prescribed health care plan;

4. "Case manager" means a person who is a registered nurse with
 a current, active unencumbered license from the Oklahoma Board of
 Nursing, or possesses one or more of the following certifications
 which indicate the individual has a minimum number of years of case
 management experience, has passed a national competency test and
 regularly obtains continuing education hours to maintain
 certification:

a. Certified Disability Management Specialist (CDMS),
b. Certified Case Manager (CCM),
c. Certified Rehabilitation Registered Nurse (CRRN),
d. Case Manager - Certified (CMC),
e. Certified Occupational Health Nurse (COHN), or

13 f. Certified Occupational Health Nurse Specialist (COHN-14 S);

15 5. "Certified workplace medical plan" means an organization of 16 health care providers or any other entity, certified by the State 17 Commissioner of Health, that is authorized to enter into a 18 contractual agreement with an employer, group self-insurance 19 association plan, an employer's workers' compensation insurance 20 carrier, third-party administrator or an insured to provide medical 21 care under the Administrative Workers' Compensation Act. Certified 22 plans shall only include plans which provide medical services and 23 payment for services on a fee-for-service basis to medical 24 providers;

1 6. "Child" means a natural or adopted son or daughter of the 2 employee under eighteen (18) years of age; or a natural or adopted son or daughter of an employee eighteen (18) years of age or over 3 who is physically or mentally incapable of self-support; or any 4 5 natural or adopted son or daughter of an employee eighteen (18) years of age or over who is actually dependent; or any natural or 6 7 adopted son or daughter of an employee between eighteen (18) and 8 twenty-three (23) years of age who is enrolled as a full-time 9 student in any accredited educational institution. The term "child" 10 includes a posthumous child, a child legally adopted or one for whom 11 adoption proceedings are pending at the time of death, an actually 12 dependent stepchild or an actually dependent acknowledged child born 13 out of wedlock;

14 7. "Claimant" means a person who claims benefits for an injury 15 or occupational disease pursuant to the provisions of the 16 Administrative Workers' Compensation Act;

17 8. "Commission" means the Workers' Compensation Commission; 18 9. "Compensable injury" means damage or harm to the a. 19 physical structure of the body, or damage or harm to 20 prosthetic appliances, including eyeqlasses, contact 21 lenses, or hearing aids, caused solely as the result 22 of which the major cause is either an accident, 23 cumulative trauma or occupational disease arising out 24 of the course and scope of employment. - d. A compensable injury shall be established by medical
   evidence supported by objective findings as defined in
   paragraph 31 of this section.
- 4 e. d. The injured employee shall prove by a preponderance of
  5 the evidence that he or she has suffered a compensable
  6 injury.
- 7 f. e. Benefits shall not be payable for a condition which 8 results from a non-work-related independent 9 intervening cause following a compensable injury which 10 causes or prolongs disability, aggravation, or 11 requires treatment. A non-work-related independent 12 intervening cause does not require negligence or 13 recklessness on the part of a claimant.
- 14g. f.An employee who suffers a compensable injury shall be15entitled to receive compensation as prescribed in this16act. Notwithstanding other provisions of law, if it17is determined that a compensable injury did not occur,18the employee shall not be entitled to compensation19under this act;

20 10. "Compensation" means the money allowance payable to the 21 employee or to his or her dependents and includes the medical 22 services and supplies provided for in Section 50 of this title and 23 funeral expenses;

1 11. "Consequential injury" means injury or harm to a part of 2 the body that is a direct result of the injury or medical treatment 3 to the part of the body originally injured in the claim. The 4 Commission shall not make a finding of a consequential injury unless 5 it is established by objective medical evidence that medical 6 treatment for such part of the body is required;

7 "Continuing medical maintenance" means medical treatment 12. that is reasonable and necessary to maintain claimant's condition 8 9 resulting from the compensable injury or illness after reaching 10 maximum medical improvement, but in no event shall such treatment 11 continue for longer than one (1) year from the date of maximum 12 medical improvement. Continuing medical maintenance shall not 13 include diagnostic tests, surgery, injections, counseling, physical 14 therapy, or pain management devices or equipment;

15 "Course and scope of employment" means an activity of any 13. 16 kind or character for which the employee was hired and that relates 17 to and derives from the work, business, trade or profession of an 18 employer, and is performed by an employee in the furtherance of the 19 affairs or business of an employer. The term includes activities 20 conducted on the premises of an employer or at other locations 21 designated by an employer and travel by an employee in furtherance 22 of the affairs of an employer that is specifically directed by the 23 employer. This term does not include:

- a. an employee's transportation to and from his or her
   place of employment,
  - b. travel by an employee in furtherance of the affairs of an employer if the travel is also in furtherance of personal or private affairs of the employee,
- c. any injury occurring in a parking lot or other common
  area adjacent to an employer's place of business
  before the employee clocks in or otherwise begins work
  for the employer or after the employee clocks out or
  otherwise stops work for the employer <u>unless the</u>
  <u>employer owns or maintains exclusive control over the</u>
  <u>area</u>, or
- 13d. any injury occurring while an employee is on a work14break, unless the injury occurs while the employee is15on a work break inside the employer's facility or in16an area owned by or exclusively controlled by the17employer and the work break is authorized by the18employee's supervisor;

19 14. "Cumulative trauma" means an injury to an employee that is 20 caused by the combined effect of repetitive physical activities 21 extending over a period of time in the course and scope of 22 employment. Cumulative trauma shall not mean fatigue, soreness or 23 general aches and pain that may have been caused, aggravated, 24 exacerbated or accelerated by the employee's course and scope of

1 employment. Cumulative trauma shall have resulted directly and 2 independently of all other causes and the employee shall have 3 completed at least one hundred eighty (180) days of continuous 4 active employment with the employer;

5 15. "Death" means only death resulting from compensable injury
6 as defined in paragraph 9 of this section;

7 16. "Disability" means incapacity because of compensable injury 8 to earn, in the same or any other employment, substantially the same 9 amount of wages the employee was receiving at the time of the 10 compensable injury;

11 17. "Drive-away operations" includes every person engaged in 12 the business of transporting and delivering new or used vehicles by 13 driving, either singly or by towbar, saddle-mount or full-mount 14 method, or any combination thereof, with or without towing a 15 privately owned vehicle;

"Employee" means any person, including a minor, in the a. 17 service of an employer under any contract of hire or 18 apprenticeship, written or oral, expressed or implied, 19 but excluding one whose employment is casual and not 20 in the course of the trade, business, profession, or 21 occupation of his or her employer and excluding one 22 who is required to perform work for a municipality or 23 county or the state or federal government on having 24 been convicted of a criminal offense or while

incarcerated. Any person or entity who, in good faith and exercising due 17 care, reports suspected workers' compensation fraud or insurance 18 fraud, or who allows access to medical records or other information 19 pertaining to suspected workers' compensation or insurance fraud, by 20 persons authorized to investigate a report concerning the workers' 21 compensation and insurance fraud, shall have immunity from any civil 22 or criminal liability for such report or access. Any such person or 23 entity shall have the same immunity with respect to participation in 24 any judicial proceeding resulting from such reports. For purposes

of any civil or criminal proceeding, there shall be a presumption of good faith of any person making a report, providing medical records or providing information pertaining to a workers' compensation or insurance fraud investigation by the Attorney General, and participating in a judicial proceeding resulting from a subpoena or a report.

AMENDATORY Section 18, Chapter 208, O.S.L. 15 2013 (85A O.S. Supp. 2018, Section 18), is amended to read as 16 follows:

No hospital, physician, or other health care 18 provider shall bill or attempt to collect any fee or any portion of 19 a fee for services rendered to an employee due to a work-related 20 injury or report to any credit-reporting agency any failure of the 21 employee to make the payment, when a claim for compensation has been 22 filed under this act and the hospital, physician, or health care 23 provider has received actual notice given in writing by the employee 24 or the employee's representative. Actual notice shall be deemed

The notice shall be filed by the insurer within thirty 18 (30) days after the effective date of the policy. Any insurer who 19 does not file the notice required by this paragraph shall be subject 20 to a fine by the Commission of not more than One Thousand Dollars 21 (\$1,000.00);

22 2. By obtaining and keeping in force guaranty insurance with 23 any company authorized to do guaranty business in this state. Each 24 company that issues workers' compensation guaranty insurance shall

file a copy of the contract with the Commission within thirty (30) days after the effective date of the contract. Any company that does not file a copy of the contract as required by this paragraph shall be subject to a fine by the Commission of not more than One Thousand Dollars (\$1,000.00);

By furnishing satisfactory proof to the Commission of the
employer's financial ability to pay the compensation. The

Commission, shall require any employer that has:

10 a. less than one hundred employees or less than One 11 Million Dollars (\$1,000,000.00) in net assets to: deposit with the Commission securities, an 12 (1)irrevocable letter of credit or a surety bond 13 14 payable to the state, in an amount determined by 15 the Commission which shall be at least an average 16 of the yearly claims for the last three (3) 17 years, or 18 provide proof of excess coverage with such terms (2)19 and conditions as is commensurate with their 20 ability to pay the benefits required by the 21 provisions of this act, and

b. one hundred or more employees and One Million Dollars
 (\$1,000,000.00) or more in net assets to:

- (1) secure a surety bond payable to the state, or an irrevocable letter of credit, in an amount determined by the Commission which shall be at least an average of the yearly claims for the last three (3) years, or
- 6 (2) provide proof of excess coverage with terms and 7 conditions that are commensurate with their 8 ability to pay the benefits required by the 9 provisions of this act;

10 4. By forming a group self-insurance association consisting of 11 two or more employers which shall have a common interest and which 12 shall have entered into an agreement to pool their liabilities under 13 the Administrative Workers' Compensation Act. Such agreement shall 14 be subject to rules of the Commission. Any employer, upon 15 application to become a member of a group self-insurance 16 association, shall file with the Commission a notice, in such form 17 as prescribed by the Commission, acknowledging that the employer 18 accepts joint and several liability. Upon approval by the 19 Commission of such application for membership, said member shall be 20 a qualified self-insured employer; or

5. By any other security as may be approved by the Commissionand the Insurance Department.

B. The Commission may waive the requirements of this section in
an amount which is commensurate with the ability of the employer to

pay the benefits required by the provisions of this act.
 Irrevocable letters of credit required by this subsection shall
 contain such terms as may be prescribed by the Commission and shall
 be issued for the benefit of the state by a financial institution
 whose deposits are insured by the Federal Deposit Insurance

C. An employer who does not fulfill the requirements of this section is not relieved of the obligation to pay compensation under this act. The security required under this section, including any interest, shall be maintained by the Commission as provided in this act until each claim for benefits is paid, settled, or lapses under this act, and costs of administration of such claims are paid.

D. Failure on the part of any employer to secure the payment of compensation provided in this act shall have the effect of enabling the Commission to assert the rights of an injured employee against the employer.

E. Any employer that knowingly provides false information to the Commission for purposes of securing or maintaining a selfinsurance permit shall be guilty of a felony and subject to a maximum fine of Ten Thousand Dollars (\$10,000.00).

SECTION 18. AMENDATORY Section 43, Chapter 208, 0.S.L.
2013, as amended by Section 2, Chapter 390, O.S.L. 2015 (85A O.S.
Supp. 2018, Section 45), is amended to read as follows:

10 Section 45. A. Temporary Total Disability.

11 1. If the injured employee is temporarily unable to perform his 12 or her job or any alternative work offered by the employer, he or she shall be entitled to receive compensation equal to seventy 13 14 percent (70%) of the injured employee's average weekly wage, but not 15 to exceed seventy percent (70%) of the state average weekly wage, 16 for one hundred four (104) one hundred fifty-six (156) weeks. 17 Provided, there shall be no payment for the first three (3) days of 18 the initial period of temporary total disability. If an 19 administrative law judge finds that a consequential injury has 20 occurred and that additional time is needed to reach maximum medical 21 improvement, temporary total disability may continue for a period of 22 not more than an additional fifty-two (52) weeks. Such finding 23 shall be based upon a showing of medical necessity by clear and 24 convincing evidence. An employer shall have the right to recover

1 <u>any overpayment of temporary total disability payments from a</u> 2 <u>subsequent permanent partial disability award if the offset is</u> 3 deemed justified by the Commission.

4 2. When the injured employee is released from active medical 5 treatment by the treating physician for all body parts found by the 6 Commission to be injured, or in the event that the employee, without 7 a valid excuse, misses three consecutive medical treatment 8 appointments, fails to comply with medical orders of the treating 9 physician, or otherwise abandons medical care, the employer shall be 10 entitled to terminate temporary total disability by notifying the 11 employee, or if represented, his or her counsel. If, however, an 12 objection to the termination is filed by the employee within ten 13 (10) days of termination, the Commission shall set the matter within 14 twenty (20) days for a determination if temporary total disability 15 compensation shall be reinstated. The temporary total disability 16 shall remain terminated unless the employee proves the existence of 17 a valid excuse for his or her failure to comply until such time as 18 the employee complies with medical orders of the treating physician 19 or his or her abandonment of medical care. Notwithstanding the 20 provisions of this paragraph, benefits under this subsection shall 21 be permanently terminated by order of the Commission if the employee 22 is noncompliant or abandons treatment for sixty (60) days, or if 23 benefits under this subsection have been suspended under this 24 paragraph at least two times. The administrative law judge may

1 appoint an independent medical examiner to determine if further 2 medical treatment is reasonable and necessary. The independent 3 medical examiner shall not provide treatment to the injured worker, 4 unless agreed upon by the parties.

B. Temporary Partial Disability.

If the injured employee is temporarily unable to perform his 6 1. 7 or her job, but may perform alternative work offered by the employer, he or she shall be entitled to receive compensation equal 8 9 to the greater of seventy percent (70%) of the difference between 10 the injured employee's average weekly wage before the injury and his 11 or her weekly wage for performing alternative work after the injury, 12 but only if his or her weekly wage for performing the alternative 13 work is less than the temporary total disability rate. The injured 14 employee's actual earnings plus temporary partial disability 15 compensation shall not exceed the temporary total disability rate.

16 2. Compensation under this subsection may not exceed fifty-two 17 (52) weeks.

18 3. If the employee refuses to perform the alternative work
19 offered by the employee, he or she shall not be entitled to benefits
20 under subsection A of this section or under this section.

21 C. Permanent Partial Disability.

1. A permanent partial disability award or combination of awards granted an injured worker may not exceed a permanent partial disability rating of one hundred percent (100%) to any body part or

1 to the body as a whole. The determination of permanent partial 2 disability shall be the responsibility of the Commission through its administrative law judges. Any claim by an employee for 3 4 compensation for permanent partial disability must be supported by 5 competent medical testimony of a medical doctor, osteopathic physician, or chiropractor, and shall be supported by objective 6 7 medical findings, as defined in this act. The opinion of the 8 physician shall include employee's percentage of permanent partial 9 disability and whether or not the disability is job-related and 10 caused by the accidental injury or occupational disease. A 11 physician's opinion of the nature and extent of permanent partial 12 disability to parts of the body other than scheduled members must be 13 based solely on criteria established by the current edition Sixth 14 Edition of the American Medical Association's "Guides to the 15 Evaluation of Permanent Impairment". A copy of any written 16 evaluation shall be sent to both parties within seven (7) days of 17 issuance. Medical opinions addressing compensability and permanent 18 disability must be stated within a reasonable degree of medical 19 certainty. Any party may submit the report of an evaluating 20 physician.

21 2. Permanent partial disability shall not be allowed to a part 22 of the body for which no medical treatment has been received. A 23 determination of permanent partial disability made by the Commission 24 or administrative law judge which is not supported by objective

1 medical findings provided by a treating physician who is a medical 2 doctor, doctor of osteopathy, chiropractor or a qualified 3 independent medical examiner shall be considered an abuse of 4 discretion.

5 3. The examining physician shall not deviate from the Guides6 except as may be specifically provided for in the Guides.

4. In cases of permanent partial disability, the compensation
shall be seventy percent (70%) of the employee's average weekly
wage, not to exceed Three Hundred Twenty-three Dollars (\$323.00)
Three Hundred Fifty-five Dollars (\$355.00) per week which shall
increase to Three Hundred Sixty-five Dollars (\$365.00) per week on
July 1, 2021, for a term not to exceed a total of three hundred
fifty (350) weeks for the body as a whole.

Previous Disability: The fact that an employee has suffered 2 previous disability or received compensation therefor shall not 3 preclude the employee from compensation for a later accidental 4 personal injury or occupational disease. In the event there exists 5 a previous permanent partial disability, including a previous nonwork-related injury or condition which produced permanent partial 6 7 disability and the same is appravated or accelerated by an 8 accidental personal injury or occupational disease, compensation for 9 permanent partial disability shall be only for such amount as was 10 caused by such accidental personal injury or occupational disease 11 and no additional compensation shall be allowed for the preexisting 12 disability or impairment. D. Permanent Total Disability.

2 In case of total disability adjudged to be permanent, 1. 3 seventy percent (70%) of the employee's average weekly wages, but 4 not in excess of the state's average weekly wage, shall be paid to 5 the employee during the continuance of the disability until such time as the employee reaches the age of maximum Social Security 6 7 retirement benefits or for a period of fifteen (15) years, whichever 8 is longer. In the event the claimant dies of causes unrelated to 9 the injury or illness, benefits shall cease on the date of death. 10 Provided, however, any person entitled to revive the action shall 11 receive a one-time lump-sum payment equal to twenty-six (26) weeks of weekly benefits for permanent total disability awarded the 12 13 claimant. If more than one person is entitled to revive the claim, 14 the lump-sum payment shall be evenly divided between or among such 15 In the event the Commission awards both permanent partial persons. 16 disability and permanent total disability benefits, the permanent 17 total disability award shall not be due until the permanent partial 18 disability award is paid in full. If otherwise qualified according 19 to the provisions of this act, permanent total disability benefits 20 may be awarded to an employee who has exhausted the maximum period 21 of temporary total disability even though the employee has not 22 reached maximum medical improvement.

disability against the last employer. The Commission shall require the employee to annually file an affidavit under penalty of perjury stating that he or she is not and has not been gainfully employed and is not capable of gainful employment. Failure to file such fidavit shall result in suspension of benefits; provided, however, reinstatement of benefits may occur after proper hearing before the Commission.

8 E. 1. The Workers' Compensation Commission shall <u>may</u> hire or 9 contract for a Vocational Rehabilitation Director to oversee the 10 vocational rehabilitation program of the Commission.

11 The Vocational Rehabilitation Director shall help injured 2. 12 workers return to the work force. If the injured employee is unable 13 to return to his or her pre-injury or equivalent position due to 14 permanent restrictions as determined by the treating physician, upon 15 the request of either party, the Vocational Rehabilitation Director 16 shall determine if it is appropriate for a claimant to receive 17 vocational rehabilitation training or services, and will oversee 18 such training. If appropriate, the Vocational Rehabilitation 19 Director shall issue administrative orders, including, but not 20 limited to, an order for a vocational rehabilitation evaluation for 21 any injured employee unable to work for at least ninety (90) days. 22 In addition, the Vocational Rehabilitation Director may assign 23 injured workers to vocational rehabilitation counselors for 24 coordination of recommended services. The cost of the services

Payment shall 15 be based upon a sum of the allowable fee for each ingredient plus a 16 dispensing fee of Five Dollars (\$5.00) per prescription. Compounded 17 medications shall be billed by the compounding pharmacy.

18 10. Implantables are paid in addition to procedural 19 reimbursement paid for medical or surgical services. A 20 manufacturer's invoice for the actual cost to a physician, hospital 21 or other entity of an implantable device shall be adjusted by the 22 physician, hospital or other entity to reflect, at the time 23 implanted, all applicable discounts, rebates, considerations and 24 product replacement programs and shall be provided to the payer by

1 the physician or hospital as a condition of payment for the 2 implantable device. If the physician, or an entity in which the 3 physician has a financial interest other than an ownership interest 4 of less than five percent (5%) in a publically traded company, 5 provides implantable devices, this relationship shall be disclosed 6 to patient, employer, insurance company, third-party commission, 7 certified workplace medical plan, case managers, and attorneys 8 representing claimant and defendant. If the physician, or an entity 9 in which the physician has a financial interest other than an 10 ownership interest of less than five percent (5%) in a publically 11 publicly traded company, buys and resells implantable devices to a 12 hospital or another physician, the markup shall be limited to ten 13 percent (10%) above cost.

In the absence of a good-faith reason for missing the appointment, the Commission shall order the employee to reimburse the employer or insurance company for the charge.

Physicians providing treatment under this act shall 10 disclose under penalty of perjury to the Commission, on a form 11 prescribed by the Commission, any ownership or interest in any 12 health care facility, business, or diagnostic center that is not the 13 physician's primary place of business. The disclosure shall include 14 any employee leasing arrangement between the physician and any 15 health care facility that is not the physician's primary place of 16 business. A physician's failure to disclose as required by this 17 section shall be grounds for the Commission to disqualify the 18 physician from providing treatment under this act.
