15	SECTION 1. AMENDATORY 36 O.S. 2011, Section 6751, as
16	amended by Section 37, Chapter 150, O.S.L. 2012 (36 O.S. Supp. 2020,
17	Section 6751), is amended to read as follows:
18	Section 6751. A. The purpose of the Oklahoma Home Service
19	Contract Act is to create an independent legal framework within
20	which home service contracts and home warranties are defined, may be
21	sold and are regulated in this state. The Oklahoma Home Service
22	Contract Act declares that home service contracts and home
23	warranties, as defined in Section 6752 of this title, are not
24	insurance and not otherwise subject to the Insurance Code. The

1 Oklahoma Home Service Contract Act requires simple registration, 2 financial assurance options and enforcement by the Insurance 3 Commissioner. Proper registration under the Oklahoma Home Service Contract Act exempts applicability under the Service Warranty Act, 4 5 which may regulate extended warranty, retail, automobile and agreements not defined in the Oklahoma Home Service Contract Act. 6 7 Nothing in the Service Warranty Act is changed or amended by the Oklahoma Home Service Contract Act. 8

9 B. The following items are exempt from the provisions of the10 Oklahoma Home Service Contract Act:

Warranties as defined in Section 6752 of this title;
 Maintenance agreements as defined in Section 6752 of this
 title; and

3. Service contracts sold or offered for sale to persons other than consumers, consumer product (extended warranty) service contracts on new retail goods if made at the time of sale and motor vehicle service contracts, all of which may be separately regulated elsewhere in the Oklahoma Statutes.

19 C. The types of agreements covered by the Oklahoma Home Service 20 Contract Act are not insurance and do not have to comply with any 21 other provision of the Insurance Code outside of the Oklahoma Home 22 Service Contract Act.

23 SECTION 2. AMENDATORY 36 O.S. 2011, Section 6752, is 24 amended to read as follows:

Page 2

Section 6752. As used in the Oklahoma Home Service Contract
 Act:

1. "Administrator" means the person who is responsible for the
 administration of home service contracts or the home service
 contracts plan, who may promote the contract under their own private
 label or brand as long as the provider is clearly identified on the
 contract, or who is responsible for any submission required by the
 Oklahoma Home Service Contract Act;

2. "Commissioner" means the Insurance Commissioner;

3. "Consumer" means a natural person who buys other than for purposes of resale any tangible personal property that is distributed in commerce and that is normally used for personal, family or household purposes and not for business or research purposes;

15 4. "Maintenance agreement" means a contract of limited duration 16 that provides for scheduled maintenance only and does not include 17 repair or replacement;

18 5. "Person" means an individual, partnership, corporation,
19 incorporated or unincorporated association, joint stock company,
20 reciprocal, syndicate or any similar entity or combination of
21 entities acting in concert;

6. "Provider" means the person who is the contractually named obligor to the home service contract holder under the terms of the service contract;

 service contract;

8. "Reimbursement insurance policy" means a policy of insurance
issued to a provider to either provide reimbursement to the provider
under the terms of the insured home service contracts issued or sold
by the provider or, in the event of the provider's nonperformance,
to pay on behalf of the provider all covered contractual obligations
incurred by the provider under the terms of the insured home service
contracts issued or sold by the provider;

10 9. "Home service contract" or "home warranty" means a contract 11 or agreement for a separately stated consideration for a specific 12 duration to perform the service, repair, replacement or maintenance of property or indemnification for service, repair, replacement or 13 maintenance, for the operational or structural failure of any 14 15 residential property due to a defect in materials, workmanship, inherent defect or normal wear and tear, with or without additional 16 provisions for incidental payment or indemnity under limited 17 circumstances. Home service contracts may provide for the service, 18 repair, replacement, or maintenance of property for damage resulting 19 from power surges or interruption and accidental damage from 20 handling and may provide for leak or repair coverage to house 21 roofing systems. Home service contracts and home warranties are not 22 insurance in this state or otherwise regulated under the Insurance 23 24 Code;

1 10. "Service contract holder" or "contract holder" means a 2 person who is the purchaser or holder of a home service contract; 3 and

"Warranty" means a warranty made solely by the 4 11. 5 manufacturer, importer or seller of property or services τ including builders on new home construction, without consideration, that is 6 7 not negotiated or separated from the sale of the product and is incidental to the sale of the product, that guarantees indemnity for 8 9 defective parts, mechanical or electrical breakdown, labor or other 10 remedial measures, such as repair or replacement of the property or 11 repetition of services.

12 SECTION 3. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 632.1 of Title 36, unless there 13 is created a duplication in numbering, reads as follows: 14 15 Home service contracts and home warranties, as defined in Section 6752 of Title 36 of the Oklahoma Statutes, are not insurance 16 in this state or otherwise regulated under the Insurance Code. 17 SECTION 4.
