11 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

12 SECTION 1. AMENDATORY 63 O.S. 2001, Section 1-1939, as
13 amended by Section 2, Chapter 429, O.S.L. 2003 (63 O.S. Supp. 2009,
14 Section 1-1939), is amended to read as follows:

15 Section 1-1939. A. The owner and licensee are liable to a
16 resident for any intentional or negligent act or omission of their
17 agents or employees which injures the resident. In addition, any
18 state employee that aids, abets, assists, or conspires with an owner
19 or licensee to perform an act that causes injury to a resident shall
20 be individually liable.

21 B. A resident may maintain an action under the Nursing Home
22 Care Act for any other type of relief, including injunctive and
23 declaratory relief, permitted by law.

1 C. Any damages recoverable under this section, including
2 minimum damages as provided by this section, may be recovered in any
3 action which a court may authorize to be brought as a class action.
4 The remedies provided in this section, are in addition to and
5 cumulative with any other legal remedies available to a resident.
6 Exhaustion of any available administrative remedies shall not be
7 required prior to commencement of suit hereunder.

8 D. Any waiver by a resident or the legal representative of the
9 resident of the right to commence an action under this section,
10 whether oral or in writing, shall be null and void, and without
11 legal force or effect.

12 E. Any party to an action brought under this section shall be
13 entitled to a trial by jury and any waiver of the right to a trial
14 by a jury, whether oral or in writing, prior to the commencement of
15 an action, shall be null and void, and without legal force or
16 effect.

17 F. A licensee or its agents or employees shall not transfer,
18 discharge, evict, harass, dismiss or retaliate against a resident, a
19 resident's guardian or an employee or agent who makes a report,
20 brings, or testifies in, an action under this section, or files a
21 complaint because of a report, testimony or complaint.

22 G. Any person, institution or agency, under the Nursing Home
23 Care Act, participating in good faith in the making of a report, or
24 in the investigation of such a report shall not be deemed to have

1 violated any privileged communication and shall have immunity from
2 any liability, civil or criminal, or any other proceedings, civil or
3 criminal, as a consequence of making such report. The good faith of
4 any persons required, or permitted to report cases of suspected
5 resident abuse or neglect under this act shall be presumed.

6 H. A facility employee or agent who becomes aware of abuse,
7 neglect or exploitation of a resident prohibited by the Nursing Home
8 Care Act shall immediately report the matter to the facility
9 administrator. A facility administrator who becomes aware of abuse,
10 neglect, or exploitation of a resident shall immediately act to
11 rectify the problem and shall make a report of the incident and its
12 correction to the Department.

13 I. 1. The facility shall be responsible for reporting the
14 following serious incidents to the Department within twenty-four
15 (24) hours:

- 16 a. communicable diseases,
- 17 b. deaths by unusual occurrence, including accidental
18 deaths or deaths other than by natural causes, and
19 deaths that may be attributed to a medical device,
- 20 c. missing residents. In addition, the facility shall
21 make a report to local law enforcement agencies within
22 two (2) hours if the resident is still missing,
- 23 d. situations arising where a rape or a criminal intent
24 act is suspected. Such situations shall also be

1 reported to local law enforcement immediately. The
2 facility shall make every effort to preserve the scene
3 of the suspected rape or crime until local law
4 enforcement has arrived, and

5 e. resident abuse, neglect and misappropriation of the
6 property of a resident.

7 2. All other incident reports shall be made in accordance with
8 federal law.

9 3. All initial written reports of incidents or situations shall
10 be mailed to the Department within five (5) working days after the
11 incident or situation. The final report shall be filed with the
12 Department when the full investigation is complete.

13 SECTION 2. This act shall become effective November 1, 2010.
