13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. For the fiscal year ending June 30, 2011, the
15 Oklahoma Center for the Advancement of Science and Technology shall
16 budget all funds in the following categories and amounts:

1 SECTION 2. The duties and compensation of employees, not
2 otherwise prescribed by law, necessary to perform the duties imposed
3 upon the Oklahoma Center for the Advancement of Science and
4 Technology by law shall be set by the Oklahoma Center for the
5 Advancement of Science and Technology. The salary of the Executive
6 Director of the Oklahoma Center for the Advancement of Science and
7 Technology shall not exceed _____ Dollars (\$0.00) per
8 annum, payable monthly for the fiscal year ending June 30, 2011.
9 The Oklahoma Center for the Advancement of Science and Technology
10 for the fiscal year ending June 30, 2011, shall be subject to the
11 following budgetary limitations on full-time-equivalent employees
12 and expenditures excluding expenditures for capital and special
13 projects, except as may be authorized pursuant to the provisions of
14 Section 3603 of Title 74 of the Oklahoma Statutes:
