9 A Joint Resolution directing the Secretary of State
10 to refer to the people for their approval or
11 rejection the repeal of Sections 3 and 4 of Article
12 XXV of the Constitution of the State of Oklahoma and
13 a proposed amendment to the Constitution of the State
14 of Oklahoma by adding a new section to Article XXV to
15 be designated as Section 6; authorizing the
16 Legislature to determine composition and duties of
17 Human Services Commission; providing ballot title;
18 and directing filing.

19 BE IT RESOLVED BY THE HOUSE OF REPRESENTATIVES AND THE SENATE OF THE
20 2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

21 SECTION 1. The Secretary of State shall refer to the people for
22 their approval or rejection, as and in the manner provided by law,
23 the repeal of Sections 3 and 4 of Article XXV of the Constitution of
24 the State of Oklahoma which relate to the Oklahoma Public Welfare
Commission and the Director of Public Welfare.

SECTION 2. The Secretary of State shall refer to the people for their approval or rejection, as and in the manner provided by law, the following proposed amendment to the Constitution of the State of Oklahoma by adding a new Section 6 to Article XXV thereof, to read as follows:

Section 6. The Legislature shall have the authority and duty to determine the composition and duties of the Human Services Commission.

SECTION 3. The Ballot Title for the proposed Constitutional amendment as set forth in SECTION 2 of this resolution shall be in the following form:

THE GIST OF THE PROPOSITION IS AS FOLLOWS:

This measure amends the State Constitution. It provides for the repeal of Sections 3 and 4 of Article 25 which relate to the Oklahoma Public Welfare Commission and the Director of Public Welfare. This measure grants the Legislature the authority to oversee the Human Services Commission.
