[Joint Resolution - proposed amendment to Oklahoma
Constitution - directing filing]

BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
2ND SESSION OF THE 53RD OKLAHOMA LEGISLATURE:

SECTION 1. The Secretary of State shall refer to the people for
their approval or rejection, as and in the manner provided by law,
the following proposed amendment to Section 6A of Article X of the
Oklahoma Constitution to read as follows:

Section 6A. ~~Intangible as below defined~~ A. Beginning January
1, 2013, the following intangible personal property of a railroad,
air carrier or public service corporation shall not be subject to ad
valorem tax or to any other tax in lieu of ad valorem tax within
this ~~State~~ state:

~~(a) Money~~

1 a. money and cash on hand, including currency, gold,
2 silver, and other coin, bank drafts, certified checks,
3 and cashier's checks-1

5 b. money on deposit in any bank, trust company, or other

15 B. Beginning January 1, 2013, intangible personal property,
16 other than any intangible personal property of a railroad, air
17 carrier or public service corporation subject to ad valorem taxation
18 pursuant to subsection A of this section, shall not be subject to ad
19 valorem tax or any other tax in lieu of ad valorem tax within this
20 state.

21 SECTION 2. The Ballot Title for the proposed Constitutional
22 amendment as set forth in SECTION 1 of this resolution shall be in
23 the following form:

2 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

3 This measure amends the Oklahoma Constitution. It amends
4 Section 6A of Article 10. The section is a list of personal
5 property not subject to property tax. The exempt property is
6 not real or tangible. It is intangible. This measure would
7 exempt certain intangible property. It would exempt property
8 which is not owned by a railroad, air carrier or public service
9 corporation. It would also delete obsolete language.
