14 Mr./Madame President:

15 I move to AMEND THE FLOOR AMENDMENT to House Bill No. 2388, as follows:

16

17 On Page 6, Line 9, by inserting after the word “TANF” the words “or tax preferences specifically
18 identified in Title 68 of the Oklahoma Statutes or which receives incentive payments from the
19 Oklahoma Quality Jobs Program Act”; and

20 On Page 6, Line 12, by inserting after the word “benefits” and before the word “shall” the words “or
21 tax preferences specifically identified in Title 68 of the Oklahoma Statutes or which receives
incentive payments from the Oklahoma Quality Jobs Program Act”; and

22 On Page 6, Line 13, by inserting after the word “Services” and before the word “shall” the words
“and the Oklahoma Tax Commission”; and

23 On Page 6, Line 15, by inserting after the letter “a.” and before the word “The” the following:

24 “For the purposes of paragraph 14 of this Section, an applicant for state tax credits shall be a
25 naturalized person or corporate entity which is applying to participate, enroll or otherwise avail itself
26 of any of the tax preferences specifically identified in Title 68 of the Oklahoma Statutes or which
receives incentive payments from the Oklahoma Quality Jobs Program Act. An applicant subject to
27 the same type of drug testing which is required of any recipients of TANF payments shall include
28 the: owner of sole proprietorships; chief executive officer, corporate officers and board members of
29 any corporation; managing member of any limited liability company; general partner and partners of
30 any partnership, the trustees of any trust or other naturalized person who controls any other lawfully
31 organized business entity,” and by renumbering subsequent subparagraphs; and

32 On Page 7, Line 2, by inserting after the word “benefits” and before the period “.” the words “or tax
33 preferences specifically identified in Title 68 of the Oklahoma Statutes or which receives incentive
34 payments from the Oklahoma Quality Jobs Program Act”; and

35 On Page 7, Line 5, by inserting after the word “benefits” and before the word “shall” the words “or
36 tax preferences specifically identified in Title 68 of the Oklahoma Statutes or which receives
incentive payments from the Oklahoma Quality Jobs Program Act”; and

1 On Page 7, Line 22, by inserting after the word “benefits” and before the second word “for” the
2 words “or tax preferences specifically identified in Title 68 of the Oklahoma Statutes or which
3 receives incentive payments from the Oklahoma Quality Jobs Program Act”.
