12 An Act relating to schools; amending 70 O.S. 2011,
13 Section 3-104, which relates to the powers and duties
14 of the State Board of Education; deleting authority
15 and requirement to review school construction and
16 alteration plans; amending 70 O.S. 2011, Section 3-
17 153, which relates to reporting plans to the State
18 Board of Education; amending 70 O.S. 2011, Section 3-
19 156, which relates to local school district
20 assessment; deleting references to the Comprehensive
21 Local Education Plan; amending 70 O.S. 2011, Section
22 5-117.4, which relates to the school improvement
23 plan; adding certain content to the plan; amending 70
24 O.S. 2011, Section 18-153, which relates to a four-
 year capital improvement plan; deleting reference to
 certain law; amending 70 O.S. 2011, Section 1210.508,
 which relates to the development and administration
 of criterion-referenced tests for third through
 eighth grade; changing manner of recording certain
 test results on a high school transcript; amending 70
 O.S. 2011, Section 1210.508C, which relates to the
 Reading Sufficiency Act; deleting reference to the
 Comprehensive Local Education Plan; repealing 70 O.S.
 2011, Section 3-104.2, which relates to the

1 Comprehensive Local Education Plan; providing an
2 effective date; and declaring an emergency.

4 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

5 SECTION 1. AMENDATORY 70 O.S. 2011, Section 3-104, is
6 amended to read as follows:

7 Section 3-104. The supervision of the public school system of
8 Oklahoma shall be vested in the State Board of Education and,
9 subject to limitations otherwise provided by law, the State Board of
10 Education shall:

11 1. Adopt policies and make rules for the operation of the
12 public school system of the state;

13 2. Appoint, prescribe the duties and fix the compensation of a
14 secretary, an attorney and all other personnel necessary for the
15 proper performance of the functions of the State Board of Education.
16 The secretary shall not be a member of the Board;

17 3. Submit to the Governor a departmental budget based upon
18 major functions of the Department as prepared by the State
19 Superintendent of Public Instruction and supported by detailed data
20 on needs and proposed operations as partially determined by the
21 budgetary needs of local school districts filed with the State Board
22 of Education for the ensuing fiscal year. Appropriations therefor
23
24

1 shall be made in lump-sum form for each major item in the budget as
2 follows:

- 3 a. State Aid to schools,
- 4 b. the supervision of all other functions of general and
5 special education including general control, free
6 textbooks, school lunch, Indian education and all
7 other functions of the Board and an amount sufficient
8 to adequately staff and administer these services, and
- 9 c. the Board shall determine the details by which the
10 budget and the appropriations are administered.
11 Annually, the Board shall make preparations to
12 consolidate all of the functions of the Department in
13 such a way that the budget can be based on two items,
14 administration and aid to schools. A maximum amount
15 for administration shall be designated as a part of
16 the total appropriation;

17 4. On the first day of December preceding each regular session
18 of the Legislature, prepare and deliver to the Governor and the
19 Legislature a report for the year ending June 30 immediately
20 preceding the regular session of the Legislature. The report shall
21 contain:

- 22 a. detailed statistics and other information concerning
23 enrollment, attendance, expenditures including State

1 Aid, and other pertinent data for all public schools
2 in this state,

3 b. reports from each and every division within the State
4 Department of Education as submitted by the State
5 Superintendent of Public Instruction and any other
6 division, department, institution or other agency
7 under the supervision of the Board,

8 c. recommendations for the improvement of the public
9 school system of the state,

10 d. a statement of the receipts and expenditures of the
11 State Board of Education for the past year, and

12 e. a statement of plans and recommendations for the
13 management and improvement of public schools and such
14 other information relating to the educational
15 interests of the state as may be deemed necessary and
16 desirable;

17 5. Provide for the formulation and adoption of curricula,
18 courses of study and other instructional aids necessary for the
19 adequate instruction of pupils in the public schools;

20 6. Have authority in matters pertaining to the licensure and
21 certification of persons for instructional, supervisory and
22 administrative positions and services in the public schools of the
23 state subject to the provisions of Section 6-184 of this title, and
24

1 shall formulate rules governing the issuance and revocation of
2 certificates for superintendents of schools, principals,
3 supervisors, librarians, clerical employees, school nurses, school
4 bus drivers, visiting teachers, classroom teachers and for other
5 personnel performing instructional, administrative and supervisory
6 services, but not including members of boards of education and other
7 employees who do not work directly with pupils, and may charge and
8 collect reasonable fees for the issuance of such certificates:

9 a. the State Department of Education shall not issue a
10 certificate to and shall revoke the certificate of any
11 person who has been convicted, whether upon a verdict
12 or plea of guilty or upon a plea of nolo contendere,
13 or received a suspended sentence or any probationary
14 term for a crime or an attempt to commit a crime
15 provided for in Section 843.5 of Title 21 of the
16 Oklahoma Statutes if the offense involved sexual abuse
17 or sexual exploitation as those terms are defined in
18 Section 1-1-105 of Title 10A of the Oklahoma Statutes,
19 Sections 741, 843.1, if the offense included sexual
20 abuse or sexual exploitation, 865 et seq., 885, 888,
21 891, 1021, 1021.2, 1021.3, 1040.13a, 1087, 1088,
22 1111.1, 1114 or 1123 of Title 21 of the Oklahoma
23 Statutes or who enters this state and who has been
24

1 convicted, received a suspended sentence or received a
2 deferred judgment for a crime or attempted crime
3 which, if committed or attempted in this state, would
4 be a crime or an attempt to commit a crime provided
5 for in any of said laws,

6 b. all funds collected by the State Department of
7 Education for the issuance of certificates to
8 instructional, supervisory and administrative
9 personnel in the public schools of the state shall be
10 deposited in the "Teachers' Certificate Fund" in the
11 State Treasury and may be expended by the State Board
12 of Education to finance the activities of the State
13 Department of Education necessary to administer the
14 program, for consultative services, publication costs,
15 actual and necessary travel expenses as provided in
16 the State Travel Reimbursement Act incurred by persons
17 performing research work, and other expenses found
18 necessary by the State Board of Education for the
19 improvement of the preparation and certification of
20 teachers in Oklahoma. Provided, any unobligated
21 balance in the Teachers' Certificate Fund in excess of
22 Ten Thousand Dollars (\$10,000.00) on June 30 of any
23 fiscal year shall be transferred to the General
24

1 Revenue Fund of the State of Oklahoma. Until July 1,
2 1997, the State Board of Education shall have
3 authority for approval of teacher education programs.
4 The State Board of Education shall also have authority
5 for the administration of teacher residency and
6 professional development, subject to the provisions of
7 the Oklahoma Teacher Preparation Act;

8 7. Promulgate rules governing the classification, inspection,
9 supervision and accrediting of all public nursery, kindergarten,
10 elementary and secondary schools and on-site educational services
11 provided by public school districts or state-accredited private
12 schools in partial hospitalization programs, day treatment programs,
13 and day hospital programs as defined in this act for persons between
14 the ages of three (3) and twenty-one (21) years of age in the state.
15 However, no school shall be denied accreditation solely on the basis
16 of average daily attendance.

17 Any school district which maintains an elementary school and
18 faces the necessity of relocating its school facilities because of
19 construction of a lake, either by state or federal authority, which
20 will inundate the school facilities, shall be entitled to receive
21 probationary accreditation from the State Board of Education for a
22 period of five (5) years after the effective date of this act and
23 any school district, otherwise qualified, shall be entitled to

1 receive probationary accreditation from the State Board of Education
2 for a period of two (2) consecutive years to attain the minimum
3 average daily attendance. The Head Start and public nurseries or
4 kindergartens operated from Community Action Program funds shall not
5 be subjected to the accrediting rules of the State Board of
6 Education. Neither will the State Board of Education make rules
7 affecting the operation of the public nurseries and kindergartens
8 operated from federal funds secured through Community Action
9 Programs even though they may be operating in the public schools of
10 the state. However, any of the Head Start or public nurseries or
11 kindergartens operated under federal regulations may make
12 application for accrediting from the State Board of Education but
13 will be accredited only if application for the approval of the
14 programs is made. The status of no school district shall be changed
15 which will reduce it to a lower classification until due notice has
16 been given to the proper authorities thereof and an opportunity
17 given to correct the conditions which otherwise would be the cause
18 of such reduction.

19 Private and parochial schools may be accredited and classified
20 in like manner as public schools or, if an accrediting association
21 is approved by the State Board of Education, by procedures
22 established by the State Board of Education to accept accreditation
23
24

1 by such accrediting association, if application is made to the State
2 Board of Education for such accrediting;

3 8. Be the legal agent of the State of Oklahoma to accept, in
4 its discretion, the provisions of any Act of Congress appropriating
5 or apportioning funds which are now, or may hereafter be, provided
6 for use in connection with any phase of the system of public
7 education in Oklahoma. It shall prescribe such rules as it finds
8 necessary to provide for the proper distribution of such funds in
9 accordance with the state and federal laws;

10 9. Be and is specifically hereby designated as the agency of
11 this state to cooperate and deal with any officer, board or
12 authority of the United States Government under any law of the
13 United States which may require or recommend cooperation with any
14 state board having charge of the administration of public schools
15 unless otherwise provided by law;

16 10. Be and is hereby designated as the "State Educational
17 Agency" referred to in Public Law 396 of the 79th Congress of the
18 United States, which law states that said act may be cited as the
19 "National School Lunch Act", and said State Board of Education is
20 hereby authorized and directed to accept the terms and provisions of
21 said act and to enter into such agreements, not in conflict with the
22 Constitution of Oklahoma or the Constitution and Statutes of the
23 United States, as may be necessary or appropriate to secure for the
24

1 State of Oklahoma the benefits of the school lunch program
2 established and referred to in said act;

3 11. Have authority to secure and administer the benefits of the
4 National School Lunch Act, Public Law 396 of the 79th Congress of
5 the United States, in the State of Oklahoma and is hereby authorized
6 to employ or appoint and fix the compensation of such additional
7 officers or employees and to incur such expenses as may be necessary
8 for the accomplishment of the above purpose, administer the
9 distribution of any state funds appropriated by the Legislature
10 required as federal matching to reimburse on children's meals;

11 12. Accept and provide for the administration of any land,
12 money, buildings, gifts, donation or other things of value which may
13 be offered or bequeathed to the schools under the supervision or
14 control of said Board;

15 13. Have authority to require persons having administrative
16 control of all school districts in Oklahoma to make such regular and
17 special reports regarding the activities of the schools in said
18 districts as the Board may deem needful for the proper exercise of
19 its duties and functions. Such authority shall include the right of
20 the State Board of Education to withhold all state funds under its
21 control, to withhold official recognition, including accrediting,
22 until such required reports have been filed and accepted in the
23
24

1 office of said Board and to revoke the certificates of persons
2 failing or refusing to make such reports;

3 14. Have general supervision of the school lunch program. The
4 State Board of Education may sponsor workshops for personnel and
5 participants in the school lunch program and may develop, print and
6 distribute free of charge or sell any materials, books and bulletins
7 to be used in such school lunch programs. There is hereby created
8 in the State Treasury a revolving fund for the Board, to be
9 designated the School Lunch Workshop Revolving Fund. The fund shall
10 consist of all fees derived from or on behalf of any participant in
11 any such workshop sponsored by the State Board of Education, or from
12 the sale of any materials, books and bulletins, and such funds shall
13 be disbursed for expenses of such workshops and for developing,
14 printing and distributing of such materials, books and bulletins
15 relating to the school lunch program. The fund shall be
16 administered in accordance with ~~the Revolving Fund Procedures Act~~
17 Section 155 of Title 62 of the Oklahoma Statutes;

18 15. Prescribe all forms for school district and county officers
19 to report to the State Board of Education where required. The State
20 Board of Education shall also prescribe a list of appropriation
21 accounts by which the funds of school districts shall be budgeted,
22 accounted for and expended; and it shall be the duty of the State
23
24

1 Auditor and Inspector in prescribing all budgeting, accounting and
2 reporting forms for school funds to conform to such lists;

3 16. Provide for the establishment of a uniform system of pupil
4 and personnel accounting, records and reports;

5 17. Have authority to provide for the health and safety of
6 school children and school personnel while under the jurisdiction of
7 school authorities;

8 18. Provide for the supervision of the transportation of
9 pupils;

10 19. Have authority, upon request of the local school board, to
11 act in behalf of the public schools of the state in the purchase of
12 transportation equipment;

13 20. Have authority and is hereby required to perform all duties
14 necessary to the administration of the public school system in
15 Oklahoma as specified in the Oklahoma School Code; and, in addition
16 thereto, those duties not specifically mentioned herein if not
17 delegated by law to any other agency or official;

18 21. Administer the State Public Common School Building
19 Equalization Fund established by Section 32 of Article X of the
20 Oklahoma Constitution. Any royalties, bonuses, rentals or other
21 monies derived from oil and gas and all other mineral leases on
22 lands that have been or may be granted by the United States to the
23 state for the use and benefit of the common schools, or lands that
24

1 are or may be held by the Commissioners of the Land Office for the
2 use and benefit of the common schools, the proceeds of the sale of
3 easements, improvements and sand and gravel on any such lands, any
4 monies as may be appropriated or designated by the Legislature,
5 other than ad valorem taxes, any other funds identified by the State
6 Department of Education, which may include, but not be limited to,
7 grants-in-aid from the federal government for building purposes, the
8 proceeds of all property that shall fall to the state by escheat,
9 penalties for unlawful holding of real estate by corporations, and
10 capital gains on assets of the permanent school funds, shall be
11 deposited in the State Public Common School Building Equalization
12 Fund. The fund shall be used to aid school districts in acquiring
13 buildings, subject to the limitations fixed by Section 32 of Article
14 X of the Oklahoma Constitution. It is hereby declared that the term
15 "acquiring buildings" as used in Section 32 of Article X of the
16 Oklahoma Constitution shall mean acquiring or improving school
17 sites, constructing, repairing, remodeling or equipping buildings,
18 or acquiring school furniture, fixtures, or equipment. If
19 sufficient monies are available in the fund, the Board shall solicit
20 proposals for grants from school districts and shall determine the
21 process for consideration of proposals. Grants shall be awarded
22 only to school districts which have a total assessed property
23 valuation per average daily membership that is less than the state

1 average total assessed property valuation per average daily
2 membership and, at the time of application, the district has voted
3 the five-mill building fund levy authorized in Section 10 of Article
4 X of the Oklahoma Constitution, and has voted indebtedness through
5 the issuance of new bonds for at least eighty-five percent (85%)
6 within the last three (3) years of the maximum allowable pursuant to
7 the provisions of Section 26 of Article X of the Oklahoma
8 Constitution as shown on the school district budget filed with the
9 State Board of Equalization for the current school year and
10 certifications by the Attorney General prior to April 1 of the
11 school year. The amount of each grant awarded by the Board each
12 year shall not exceed One Million Dollars (\$1,000,000.00). The
13 Board shall give priority consideration to school districts which
14 have a total assessed property valuation per average daily
15 membership that is equal to or less than twenty-five percent (25%)
16 of the state average total assessed property valuation per average
17 daily membership. The Board is authorized to prorate grants awarded
18 if monies are not sufficient in the fund to award grants to
19 qualified districts. The State Board of Education shall prescribe
20 rules for making grants of aid from, and for otherwise
21 administering, the fund pursuant to the provisions of this
22 paragraph, and may employ and fix the duties and compensation of
23 technicians, aides, clerks, stenographers, attorneys and other

24

1 personnel deemed necessary to carry out the provisions of this
2 paragraph. The cost of administering the fund shall be paid from
3 monies appropriated to the State Board of Education for the
4 operation of the State Department of Education;

5 22. Recognize that the Director of the Oklahoma Department of
6 Corrections shall be the administrative authority for the schools
7 which are maintained in the state reformatories and shall appoint
8 the principals and teachers in such schools. Provided, that rules
9 of the State Board of Education for the classification, inspection
10 and accreditation of public schools shall be applicable to such
11 schools; and such schools shall comply with standards set by the
12 State Board of Education; and

13 23. Have authority to administer a revolving fund which is
14 hereby created in the State Treasury, to be designated the
15 Statistical Services Revolving Fund. The fund shall consist of all
16 monies received from the various school districts of the state, the
17 United States Government, and other sources for the purpose of
18 furnishing or financing statistical services and for any other
19 purpose as designated by the Legislature. The State Board of
20 Education is hereby authorized to enter into agreements with school
21 districts, municipalities, the United States Government, foundations
22 and other agencies or individuals for services, programs or research
23 projects. The Statistical Services Revolving Fund shall be

1 administered in accordance with ~~the Revolving Fund Procedures Act,~~
2 Section 155 ~~et seq.~~ of Title 62 of the Oklahoma Statutes; and

3 ~~24. Have authority to review preliminary plans for new~~
4 ~~construction and major alteration of public school buildings where~~
5 ~~structural changes are proposed. No bids shall be let for the~~
6 ~~construction or major alteration of any public school building until~~
7 ~~preliminary plans and specifications for such construction or~~
8 ~~alteration have been submitted to and reviewed by the State~~
9 ~~Department of Education. The period of time during which such~~
10 ~~review is conducted by the State Department of Education shall not~~
11 ~~exceed thirty (30) days. The State Department of Education shall~~
12 ~~advise each local school district regarding said review of~~
13 ~~preliminary plans and specifications. Provided, nothing in this~~
14 ~~subsection shall be construed as repealing any ordinance or building~~
15 ~~code of any city, town or county.~~

16 SECTION 2. AMENDATORY 70 O.S. 2011, Section 3-153, is
17 amended to read as follows:

18 Section 3-153. Except for school districts with one or more
19 school sites which are identified for school improvement as
20 determined by the State Board of Education pursuant to the
21 requirements of the No Child Left Behind Act of 2001, P.L. No. 107-
22 110, all school districts shall be exempt from reporting to the
23 Board the following plans:

1 1. ~~The Comprehensive Local Education Plan as required in~~
2 ~~Section 3-104.2 of this title;~~

3 ~~2.~~ The school improvement plan as required in Section 5-117.4
4 of this title;

5 ~~3.~~ 2. The capital improvement plan as required in Section 18-
6 153 of this title; and

7 ~~4.~~ 3. The reading sufficiency plan as required in Section
8 1210.508C of this title, subject to the requirements of paragraph 1
9 of subsection F of Section 1210.508C of this title; provided the
10 last reading sufficiency plan submitted by the school district was
11 approved by the State Department of Education and expenditures for
12 the program include only expenses relating to individual and small
13 group tutoring, purchase of and training in the use of screening and
14 assessment measures, summer school programs, and Saturday school
15 programs. Prior approval from the State Department of Education
16 shall be required for other types of expenditures.

17 SECTION 3. AMENDATORY 70 O.S. 2011, Section 3-156, is
18 amended to read as follows:

19 Section 3-156. Each local school district may study and assess
20 ways to eliminate, reduce, consolidate, and simplify the number,
21 type, and length of reports, data, statistics, and other information
22 required of any school district personnel by federal or state law.
23 In conducting research for the study, the school district shall
24

1 provide for the input and participation of school district
2 personnel.

3 Each local school district may also study and assess ways to
4 eliminate, reduce, consolidate, and simplify the number of tests
5 required by students enrolled in school.

6 Findings and recommendations of both studies shall be ~~included~~
7 ~~in the Comprehensive Local Education Plan of the school district and~~
8 ~~shall be~~ forwarded to the State Department of Education.

9 SECTION 4. AMENDATORY 70 O.S. 2011, Section 5-117.4, is
10 amended to read as follows:

11 Section 5-117.4 A. Each local board of education shall, after
12 convening an advisory council that includes teachers and parents,
13 and after holding at least one public hearing, adopt a six-year
14 school improvement plan for the district. Each school improvement
15 plan shall include stated goals that clearly delineate educational
16 expectations, and shall be annually monitored and updated as
17 necessary. The alternative education plan for the school district
18 as required in subsection B of Section 1210.566 of this title shall
19 be included in the school improvement plan. The plan shall also
20 include a specific program of improvement through academic skill
21 reinforcement and/or remediation pursuant to the provisions of the
22 Oklahoma School Testing Program Act. ~~Such~~ The plan shall include an
23 evaluation of the instructional program in the basic skills areas as
24

1 specified in paragraphs 1 and 2 of subsection A of Section 11-103 of
2 this title and specific plans whereby schools within the district
3 will initiate the planning process of meeting or exceeding the
4 accreditation requirements in Section 3-104.4 of this title. The
5 six-year school improvement plan shall include a consideration of
6 the feasibility of participation in any programs which consist of
7 state exemption from educational-related statutes or rules.

8 B. ~~The school improvement plan shall be submitted to~~ As set
9 forth in Section 1210.544 of this title, the State Board of
10 Education ~~as provided in Section 3-104.2 of this title~~ shall
11 establish a process to identify schools in the state that are
12 consistently listed as a persistently low-achieving school in
13 accordance with subsection (g)(6) of Section 1003 of Title I of the
14 Elementary and Secondary Education Act of 1965 (ESEA), as amended.
15 A school district board of education with a school identified as
16 being among the persistently lowest-achieving schools in the state
17 shall, in addition to the requirements set forth in Section 1210.544
18 of this title, submit an annual update to the school improvement
19 plan to the State Board of Education. The annual update to the
20 school improvement plan shall be submitted electronically.

21 C. The State Board of Education shall promulgate rules for
22 monitoring compliance with the provisions of this section by school
23 districts.

1 D. The State Department of Education shall provide training for
2 regional accreditation officers in alternative education program
3 compliance.

4 SECTION 5. AMENDATORY 70 O.S. 2011, Section 18-153, is
5 amended to read as follows:

6 Section 18-153. A. Each local school district shall develop
7 and adopt a four-year capital improvement plan for the public
8 schools in the district and shall submit such plan to the State
9 Board of Education ~~as provided for in Section 1 of this act.~~ Each
10 local school district shall review and update their plans annually.
11 Capital improvement plans shall be based upon guidelines developed
12 by the State Department of Education.

13 B. The State Department of Education shall develop and the
14 State Board of Education shall adopt a statewide four-year capital
15 improvement master plan for the public common schools of this state.
16 Such master plan shall be subject to the provisions of Section 308
17 of Title 75 of the Oklahoma Statutes. All plans specified in this
18 section shall be reviewed by the Common School Capital Improvement
19 Needs Assessment Committee as established by this act.

20 SECTION 6. AMENDATORY 70 O.S. 2011, Section 1210.508, is
21 amended to read as follows:

22 Section 1210.508 A. 1. The State Board of Education shall
23 develop and administer a series of criterion-referenced tests
24

1 designed to indicate whether the state academic content standards,
2 as defined by the State Board of Education in the Priority Academic
3 Student Skills Curriculum, which Oklahoma public school students are
4 expected to have attained have been achieved. The Board may develop
5 and administer any criterion-referenced test in any subject not
6 required by federal law, contingent upon the availability of
7 funding. Students who do not perform at least at the proficient
8 level on tests shall be remediated, subject to the availability of
9 funding.

10 2. Contingent upon the availability of state and federal funds,
11 the Board, in accordance with federal law, shall administer
12 criterion-referenced tests for grades three and four in:

- 13 a. reading, and
- 14 b. mathematics.

15 3. Contingent upon the availability of funds, the Board shall
16 administer criterion-referenced tests for grade five in:

- 17 a. reading,
- 18 b. mathematics,
- 19 c. science,
- 20 d. social studies, which shall consist of the history,
21 Constitution and government of the United States, and
22 geography, and
- 23 e. writing of English.

1 4. Contingent upon the availability of state and federal funds,
2 the Board, in accordance with federal law, shall administer
3 criterion-referenced tests for grades six and seven in:

- 4 a. reading, and
- 5 b. mathematics.

6 In addition, the Board shall administer a criterion-referenced
7 test in geography in grade seven.

8 5. Contingent upon the availability of funds, the Board shall
9 administer criterion-referenced tests for grade eight in:

- 10 a. reading,
- 11 b. mathematics,
- 12 c. science,
- 13 d. social studies, which shall consist of the history,
14 Constitution, and government of the United States, and
- 15 e. writing of English.

16 The Board shall administer the tests for grade eight in reading
17 and mathematics online with raw score test results reported
18 immediately and complete results reported in less than two (2) weeks
19 beginning in the 2007-08 school year.

20 6. Each student who completes the instruction for English II,
21 English III, United States History, Biology I, Algebra I, Geometry,
22 and Algebra II at the secondary level shall complete an end-of-
23 instruction test, when implemented, to measure for attainment in the

1 appropriate state academic content standards in order to graduate
2 from a public high school with a standard diploma. All students
3 shall take the tests prior to graduation, unless otherwise exempt by
4 law. The State Board of Education shall administer the criterion-
5 referenced tests. The Board shall develop and field test the end-
6 of-instruction tests in English III, Geometry, and Algebra II during
7 the 2006-07 school year, implement the tests during the 2007-08
8 school year, and administer them each year thereafter. The Board
9 shall administer the multiple choice portion of the end-of-
10 instruction tests online with raw score test results reported
11 immediately and complete results reported in less than two (2) weeks
12 beginning in the 2008-09 school year.

13 The end-of-instruction tests shall serve the purpose of the
14 criterion-referenced tests as provided in paragraph 1 of this
15 subsection. The English II and English III end-of-instruction tests
16 shall include a writing component. Students who do not score at
17 least at the proficient level shall be afforded the opportunity to
18 retake each test up to three (3) times each calendar year until at
19 least achieving at the proficient level. In order to provide an
20 indication of the levels of competency attained by the student in a
21 permanent record for potential future employers and institutions of
22 higher education, for students who enter the ninth grade in or prior
23 to the 2007-08 school year, school districts shall report the

1 highest achieved state test performance level on the end-of-
2 instruction tests on the student's high school transcript.
3 Beginning with students who enter the ninth grade in the 2008-09
4 school year, school districts shall report the ~~student's performance~~
5 ~~levels~~ highest achieved state test performance level on the end-of-
6 instruction tests and any business and industry-recognized
7 endorsements attained on the student's high school transcript. Any
8 student at the middle school level who completes the instruction in
9 a secondary course specified in this paragraph shall be administered
10 the appropriate end-of-instruction test.

11 7. a. Each school district shall administer to each student
12 in the school district in grades three through eight
13 an assessment designed to assess the student in the
14 fine arts area in which the student has received
15 instruction.

16 b. Each school district shall prepare an annual report
17 for approval by the State Board of Education outlining
18 the fine arts assessment strategies used by the
19 district, when the assessments were administered, how
20 many students were assessed during the previous year,
21 and the results of the assessments.

22 B. 1. All criterion-referenced tests required by this section
23 shall measure academic competencies in correlation with the state
24

1 academic content standards adopted by the Board pursuant to Section
2 11-103.6 of this title and known as the Priority Academic Student
3 Skills Curriculum. The State Board of Education shall evaluate the
4 academic content standards to ensure the competencies reflect high
5 standards, are specific, well-defined, measurable, challenging, and
6 will prepare elementary students for next-grade-level course work
7 and secondary students for postsecondary studies at institutions of
8 higher education or technology center schools without the need for
9 remediation in core curriculum areas. All state academic content
10 standards shall reflect the benchmarks of the American Diploma
11 Project and the goal of improving the state average ACT score.

12 2. The State Department of Education shall annually evaluate
13 the results of the criterion-referenced tests. The State Board of
14 Education shall ensure that test results are reported to districts
15 in a manner that yields detailed, diagnostic information for the
16 purpose of guiding instruction and student remediation. As
17 improvements are made to the criterion-referenced tests required by
18 this section, the Board shall seek to increase the depth of
19 knowledge assessed for each subject. The State Board of Education
20 shall seek to ensure that data yielded from the tests required in
21 this section are utilized at the school district level to prescribe
22 reinforcement and/or remediation by requiring school districts to

23

24

1 develop and implement a specific program of improvement based on the
2 test results.

3 3. The State Board of Education in coordination with the
4 Educational Quality and Accountability Board shall review, realign,
5 and recalibrate, as necessary, the tests in reading and mathematics
6 in third through eighth grade and the end-of-instruction tests. The
7 State Board of Education shall determine the cut scores for the
8 performance levels on the end-of-instruction tests developed
9 pursuant to paragraph 6 of subsection A of this section, which shall
10 be phased in over a multi-year period. The State Board of Education
11 shall conduct an ongoing review to compare the end-of-instruction
12 test content and performance descriptors with those of other states.
13 Upon receipt of the review, the State Board of Education may adjust
14 the cut scores as necessary.

15 4. The State Board of Education, for the purposes of conducting
16 reliability and validity studies, monitoring contractor adherence to
17 professionally accepted testing standards, and providing
18 recommendations for testing program improvement, shall retain the
19 services of an established, independent agency or organization that
20 is nationally recognized for its technical expertise in educational
21 testing but is not engaged in the development of aptitude or
22 achievement tests for elementary or secondary level grades. These
23 national assessment experts shall annually conduct studies of the

1 reliability and validity of the end-of-instruction tests
2 administered pursuant to this section. Validity studies shall
3 include studies of decision validity, concurrent validity and the
4 validity of performance level cut scores.

5 C. 1. The State Board of Education shall set the testing
6 window dates for each criterion-referenced test required in
7 paragraphs 1 through 5 of subsection A of this section for grades
8 three through eight so that, with the exception of the writing
9 assessments, the tests are administered to students no earlier than
10 April 10 each year and so that the test results are reported back to
11 school districts in a timely manner. Each criterion-referenced test
12 required in paragraph 6 of subsection A of this section may be
13 administered to students at a time set by the State Board of
14 Education as near as possible to the end of the course; provided, if
15 a school district is unable to administer the tests online to all
16 students taking the test for the first time and all students
17 retaking the test during the testing window time set by the Board,
18 the school district may elect to administer any of the tests to
19 students retaking the test at any time not more than two (2) weeks
20 prior to the start of the testing window time set by the Board. All
21 results and reports of the criterion-referenced test series required
22 in paragraphs 1 through 5 of subsection A of this section for grades
23 three through eight shall be returned to each school district prior
24

1 to the beginning of the next school year. The vendor shall provide
2 a final electronic data file of all school site, school district,
3 and state results to the State Department of Education and the
4 Office of Accountability prior to September 1 of each year. The
5 Department shall forward the final data files for each school
6 district and each school site in that district to the school
7 district. The Board shall ensure the contract with the testing
8 vendor includes a provision that the vendor report test results
9 directly to the Office of Accountability at the same time it is
10 reported to the Board.

11 2. State, district, and site level results of all tests
12 required in this section shall be disaggregated by gender, race
13 ethnicity, disability status, migrant status, English proficiency,
14 and status as economically disadvantaged, except that such
15 disaggregation shall not be required in a case in which the number
16 of students in a category is insufficient to yield statistically
17 reliable information or the results would reveal personally
18 identifiable information about an individual student. Each school
19 site shall notify the student's parents of the school's performance
20 levels in the Oklahoma School Testing Program as reported in the
21 Oklahoma Educational Indicators Program at the end of each school
22 year.

23

24

1 D. The State Board of Education shall be responsible for the
2 development, field-testing, and validation of the criterion-
3 referenced test series required in subsection A of this section. In
4 the interest of economy the Board shall adapt criterion-referenced
5 tests that have been developed by or in collaboration with other
6 states or are otherwise commercially available, or portions of such
7 tests, to the extent that such tests are appropriate for use in the
8 testing program to be administered to Oklahoma students.

9 E. The State Board of Education shall develop, administer, and
10 incorporate as a part of the Oklahoma School Testing Program, other
11 testing programs or procedures, including appropriate accommodations
12 for the testing of students with disabilities as required by the
13 Individuals with Disabilities Education Act (IDEA), 20 USC, Section
14 1400 et seq.

15 SECTION 7. AMENDATORY 70 O.S. 2011, Section 1210.508C,
16 is amended to read as follows:

17 Section 1210.508C A. 1. Each student enrolled in kindergarten
18 in a public school in this state shall be screened for reading
19 skills including, but not limited to, phonological awareness, letter
20 recognition, and oral language skills as identified in the Priority
21 Academic Student Skills (PASS) adopted by the State Board of
22 Education. A screening instrument approved by the State Board shall
23 be utilized for the purposes of this section.

1 2. For those kindergarten children at risk for reading
2 difficulties, teachers shall emphasize reading skills as identified
3 in the PASS, monitor progress throughout the year and measure year-
4 end reading progress.

5 3. Classroom assistants, which may include parents,
6 grandparents, or other volunteers, shall be provided in kindergarten
7 classes to assist with the screening of students if a teacher aide
8 is not already employed to assist in a kindergarten classroom.

9 B. 1. Each student enrolled in first, second and third grade
10 of the public schools of this state shall be assessed at the
11 beginning of each school year using a screening instrument approved
12 by the State Board of Education for the acquisition of reading
13 skills including, but not limited to, phonological awareness,
14 phonics, spelling, reading fluency, vocabulary, and comprehension.

15 2. Any student who is assessed and found not to be reading at
16 the appropriate grade level shall be provided a program of reading
17 instruction designed to enable the student to acquire the
18 appropriate grade level reading skills. Beginning with students
19 entering the first grade in the 2011-2012 school year, the program
20 of reading instruction shall include provisions of the READ
21 Initiative adopted by the school district as provided for in
22 subsection N of this section. If a student is found not to be
23 reading at the appropriate grade level and teachers, in

1 collaboration with others, are concerned that undiagnosed health
2 problems may affect the ability of the student to read, the school
3 district may make a recommendation to the parents or legal guardians
4 for medical evaluation without being liable for cost of the
5 evaluation or any associated costs.

6 3. Throughout the year progress monitoring shall continue, and
7 diagnostic assessment, if determined appropriate, shall be provided.
8 Year-end reading skills shall be measured to determine reading
9 success.

10 C. The State Board of Education shall approve no more than
11 three screening instruments for use at the beginning of the school
12 year, for monitoring of progress, and for measurement of reading
13 skills at the end of the school year as required in subsections A
14 and B of this section; provided, one of the screening instruments
15 shall be recommended by the Oklahoma Commission for Teacher
16 Preparation. The State Board shall also determine other comparable
17 reading assessments for diagnostic purposes and for periodic and
18 post assessments to be used for students at risk of reading failure.
19 The State Board shall ensure that any assessments approved are in
20 alignment with the PASS.

21 D. The program of reading instruction required in subsection B
22 of this section shall align with the PASS, shall include provisions
23 of the READ Initiative adopted by the school district as provided
24

1 for in subsection N of this section beginning with students entering
2 the first grade in the 2011-2012 school year and may include, but is
3 not limited to:

4 1. Sufficient additional in-school instructional time for the
5 acquisition of phonological awareness, phonics, spelling, reading
6 fluency, vocabulary, and comprehension;

7 2. If necessary, tutorial instruction after regular school
8 hours, on Saturdays and during summer; however, such instruction may
9 not be counted toward the one-hundred-eighty-day school year
10 required in Section 1-109 of this title; and

11 3. Assessments identified for diagnostic purposes and periodic
12 monitoring to measure the acquisition of reading skills including,
13 but not limited to, phonological awareness, phonics, spelling,
14 reading fluency, vocabulary, and comprehension, as identified in the
15 student's program of reading instruction.

16 E. The program of reading instruction shall continue until the
17 student is determined by the results of approved reading assessments
18 to be reading on grade level.

19 F. 1. Every school district shall adopt, implement, and
20 annually update a district reading sufficiency plan which has had
21 input from school administrators, teachers, and parents and if
22 possible a reading specialist, and which shall be submitted to and
23 approved by the State Board of Education ~~as a part of each~~

1 ~~district's Comprehensive Local Education Plan.~~ The district reading
2 sufficiency plan shall include a plan for each site which includes
3 an analysis of the data provided by the Oklahoma School Testing
4 Program and other reading assessments utilized as required in this
5 section, and which outlines how each school site will comply with
6 the provisions of the Reading Sufficiency Act.

7 2. Each school site shall establish a committee, composed of
8 educators, which if possible shall include a certified reading
9 specialist, to develop the required programs of reading instruction.
10 A parent or guardian of the student shall be included in the
11 development of the program of reading instruction for that student.

12 3. The State Board of Education shall adopt rules for the
13 implementation and evaluation of the provisions of the Reading
14 Sufficiency Act. The evaluation shall include, but not be limited
15 to, an analysis of the data required in subsection R of this
16 section.

17 G. For any third-grade student found not to be reading at grade
18 level as determined by reading assessments administered pursuant to
19 this section, a new program of reading instruction, including
20 provisions of the READ Initiative adopted by the school district as
21 provided for in subsection N of this section, shall be developed and
22 implemented as specified in this section. If possible, a fourth-
23 grade teacher shall be involved in the development of the program of
24

1 reading instruction. In addition to other requirements of the
2 Reading Sufficiency Act, the plan may include specialized tutoring.

3 H. Beginning with students entering the first grade in the
4 2011-2012 school year, if the reading deficiency of a student, as
5 identified based on assessments administered as provided for in
6 subsection B of this section, is not remedied by the end of third
7 grade, as demonstrated by scoring at the unsatisfactory level on the
8 reading portion of the third-grade criterion-referenced test
9 administered pursuant to Section 1210.508 of this title, the student
10 shall be retained in the third grade.

11 I. The parent of any student who is found to have a reading
12 deficiency and is not reading at the appropriate grade level and has
13 been provided a program of reading instruction as provided for in
14 subsection B of this section shall be notified in writing of the
15 following:

16 1. That the student has been identified as having a substantial
17 deficiency in reading;

18 2. A description of the current services that are provided to
19 the student;

20 3. A description of the proposed supplemental instructional
21 services and supports that will be provided to the student that are
22 designed to remediate the identified area of reading deficiency;

1 4. That the student will not be promoted to the fourth grade if
2 the reading deficiency is not remediated by the end of the third
3 grade, unless the student is exempt for good cause as set forth in
4 subsection K of this section;

5 5. Strategies for parents to use in helping their child succeed
6 in reading proficiency;

7 6. That while the results of the criterion-referenced test
8 administered pursuant to Section 1210.508 of this title are the
9 initial determinant, it is not the sole determiner of promotion and
10 that portfolio reviews and assessments are available; and

11 7. The specific criteria and policies of the school district
12 for midyear promotion implemented as provided for in paragraph 4 of
13 subsection M of this section.

14 J. No student may be assigned to a grade level based solely on
15 age or other factors that constitute social promotion.

16 K. For those students who do not meet the academic requirements
17 for promotion, a school district may promote the student for good
18 cause only. Good-cause exemptions for promotion shall be limited to
19 the following:

20 1. Limited-English-proficient students who have had less than
21 two (2) years of instruction in an English language learner program;

22 2. Students with disabilities whose individualized education
23 ~~plan~~ program (IEP), consistent with state law, indicates that

1 participation in the statewide criterion-referenced tests
2 administered pursuant to Section 1210.508 of this title is not
3 appropriate;

4 3. Students who demonstrate an acceptable level of performance
5 on an alternative standardized reading assessment approved by the
6 State Board of Education;

7 4. Students who demonstrate, through a student portfolio, that
8 the student is reading on grade level as evidenced by demonstration
9 of mastery of the state standards beyond the retention level;

10 5. Students with disabilities who participate in the statewide
11 criterion-referenced tests and who have an individualized education
12 plan that reflects that the student has received intensive
13 remediation in reading for more than two (2) years but still
14 demonstrates a deficiency in reading and was previously retained in
15 kindergarten, first grade, second grade, or third grade; and

16 6. Students who have received intensive remediation in reading
17 through a program of reading instruction for two (2) or more years
18 but still demonstrate a deficiency in reading and who were
19 previously retained in kindergarten, first grade, second grade, or
20 third grade for a total of two (2) years. A student who is
21 promoted as provided for in this paragraph shall be provided
22 intensive reading instruction during an altered instructional day
23 that includes specialized diagnostic information and specific

1 reading strategies for each student. The school district shall
2 assist schools and teachers to implement reading strategies for the
3 promoted students that research has shown to be successful in
4 improving reading among low-performing readers.

5 L. In addition to the good-cause exemptions as set forth in
6 subsection K of this section, requests to exempt students from the
7 academic requirements for promotion to the next grade shall only be
8 made upon documentation submitted from the teacher of the student to
9 the school principal that indicates that the promotion of the
10 student is appropriate and is based upon the record of the student.
11 In order to minimize paperwork requirements, documentation shall
12 consist only of a student portfolio.

13 M. Beginning with the 2011-2012 school year, each school
14 district shall:

15 1. Conduct a review of the program of reading instruction for
16 all students who score at the unsatisfactory level on the reading
17 portion of the criterion-referenced test administered pursuant to
18 Section 1210.508 of this title and did not meet the criteria for one
19 of the good-cause exemptions as set forth in subsection K of this
20 section. The review shall address additional supports and services,
21 as described in this subsection, needed to remediate the identified
22 areas of reading deficiency. The school district shall require a
23 student portfolio to be completed for each retained student;

1 2. Provide to students who have been retained as set forth in
2 subsection H of this section with intensive interventions in
3 reading, intensive instructional services and supports to remediate
4 the identified areas of reading deficiency, including a minimum of
5 ninety (90) minutes of daily, uninterrupted, scientific-research-
6 based reading instruction. Retained students shall be provided
7 other strategies prescribed by the school district, which may
8 include, but are not limited to:

- 9 a. small group instruction,
- 10 b. reduced teacher-student ratios,
- 11 c. more frequent progress monitoring,
- 12 d. tutoring or mentoring,
- 13 e. transition classes containing third- and fourth-grade
- 14 students,
- 15 f. extended school day, week, or year, and
- 16 g. summer reading academies as provided for in Section
- 17 1210.508E of this title, if available;

18 3. Provide written notification to the parent or guardian of
19 any student who is to be retained as set forth in subsection H of
20 this section that the student has not met the proficiency level
21 required for promotion and the reasons the student is not eligible
22 for a good-cause exemption. The notification shall include a
23 description of proposed interventions and intensive instructional

1 supports that will be provided to the student to remediate the
2 identified areas of reading deficiency;

3 4. Implement a policy for the midyear promotion of a retained
4 student who can demonstrate that the student is a successful and
5 independent reader, is reading at or above grade level, and is ready
6 to be promoted to the fourth grade. Tools that school districts may
7 use in reevaluating any retained student may include subsequent
8 assessments, alternative assessments, and portfolio reviews, in
9 accordance with rules of the State Board of Education. Retained
10 students may only be promoted midyear prior to November 1 and only
11 upon demonstrating a level of proficiency required to score above
12 the unsatisfactory level on the third-grade statewide criterion-
13 referenced test and upon showing progress sufficient to master
14 appropriate fourth-grade-level skills, as determined by the school.
15 A midyear promotion shall be made only upon agreement of the parent
16 or guardian of the student and the school principal;

17 5. Provide students who are retained with a high-performing
18 teacher who can address the needs of the student, based on student
19 performance data and above-satisfactory performance appraisals; and

20 6. In addition to required reading enhancement and acceleration
21 strategies, provide students who are retained with at least one of
22 the following instructional options:
23
24

- a. supplemental tutoring in scientific-research-based reading services in addition to the regular reading block, including tutoring before or after school,
- b. a parent-guided "Read at Home" assistance plan, as developed by the State Department of Education, the purpose of which is to encourage regular parent-guided home reading, or
- c. a mentor or tutor with specialized reading training.

N. Beginning with the 2011-2012 school year, each school district shall establish a Reading Enhancement and Acceleration Development (READ) Initiative. The focus of the READ Initiative shall be to prevent the retention of third-grade students by offering intensive accelerated reading instruction to third-grade students who failed to meet standards for promotion to fourth grade and to kindergarten through third-grade students who are exhibiting a reading deficiency. The READ Initiative shall:

1. Be provided to all kindergarten through third-grade students at risk of retention as identified by the assessments administered pursuant to the Reading Sufficiency Act. The assessment used shall measure phonemic awareness, phonics, fluency, vocabulary, and comprehension;
2. Be provided during regular school hours in addition to the regular reading instruction; and

1 3. Provide a state-approved reading curriculum that, at a
2 minimum, meets the following specifications:

- 3 a. assists students assessed as exhibiting a reading
4 deficiency in developing the ability to read at grade
5 level,
- 6 b. provides skill development in phonemic awareness,
7 phonics, fluency, vocabulary, and comprehension,
- 8 c. provides scientifically based and reliable assessment,
- 9 d. provides initial and ongoing analysis of the reading
10 progress of each student,
- 11 e. is implemented during regular school hours,
- 12 f. provides a curriculum in core academic subjects to
13 assist the student in maintaining or meeting
14 proficiency levels for the appropriate grade in all
15 academic subjects,
- 16 g. establishes at each school, where applicable, an
17 Intensive Acceleration Class for retained third-grade
18 students who subsequently score at the unsatisfactory
19 level on the reading portion of the statewide
20 criterion-referenced tests. The focus of the
21 Intensive Acceleration Class shall be to increase the
22 reading level of a child at least two grade levels in
23
24

one (1) school year. The Intensive Acceleration Class shall:

- (1) be provided to any student in the third grade who scores at the unsatisfactory level on the reading portion of the statewide criterion-referenced tests and who was retained in the third grade the prior year because of scoring at the unsatisfactory level on the reading portion of the statewide criterion-referenced tests,
- (2) have a reduced teacher-student ratio,
- (3) provide uninterrupted reading instruction for the majority of student contact time each day and incorporate opportunities to master the fourth-grade state standards in other core subject areas,
- (4) use a reading program that is scientific-research-based and has proven results in accelerating student reading achievement within the same school year,
- (5) provide intensive language and vocabulary instruction using a scientific-research-based program, including use of a speech-language therapist,

- 1 (6) include weekly progress monitoring measures to
2 ensure progress is being made, and
- 3 (7) provide reports to the State Department of
4 Education, in the manner described by the
5 Department, outlining the progress of students in
6 the class at the end of the first semester,
- 7 h. provide reports to the State Board of Education, upon
8 request, on the specific intensive reading
9 interventions and supports implemented by the school
10 district. The State Superintendent of Public
11 Instruction shall annually prescribe the required
12 components of the reports, and
- 13 i. provide to a student who has been retained in the
14 third grade and has received intensive instructional
15 services but is still not ready for grade promotion,
16 as determined by the school district, the option of
17 being placed in a transitional instructional setting.
18 A transitional setting shall specifically be designed
19 to produce learning gains sufficient to meet fourth-
20 grade performance standards while continuing to
21 remediate the areas of reading deficiency.

22 O. In addition to the requirements set forth in this section,
23 each school district board of education shall annually report to the
24

parent or guardian of each student in the district the progress of the student toward achieving state and district expectations for proficiency in reading, writing, science, and mathematics. The school district board of education shall report to the parent or guardian of each student the results on each statewide criterion-referenced test. The evaluation of the progress of each student shall be based upon classroom work, observations, tests, district and state assessments, and other relevant information. Progress reporting shall be provided to the parent or guardian in writing.

P. 1. Each school district board of education shall annually publish on the school website, and report in writing to the State Board of Education by September 1 of each year, the following information on the prior school year:

- a. the provisions of this section relating to public school student progression and the policies and procedures of the school district on student retention and promotion,
- b. by grade, the number and percentage of all students in grades three through ten performing at the unsatisfactory level on the reading portion of the statewide criterion-referenced tests,
- c. by grade, the number and percentage of all students retained in grades three through ten,

- 1 d. information on the total number and percentage of
2 students who were promoted for good cause, by each
3 category of good cause as specified above, and
4 e. any revisions to the policies of the school district
5 on student retention and promotion from the prior
6 year.

7 2. The State Department of Education shall establish a uniform
8 format for school districts to report the information required in
9 this subsection. The format shall be developed with input from
10 school districts and shall be provided not later than ninety (90)
11 days prior to the annual due date. The Department shall annually
12 compile the information required along with state-level summary
13 information, and report the information to the public, the Governor,
14 the President Pro Tempore of the Senate, and the Speaker of the
15 House of Representatives.

16 Q. The State Department of Education shall provide technical
17 assistance as needed to aid school districts in administering the
18 provision of the Reading Sufficiency Act.

19 R. On or before December 1 of each year, the State Department
20 of Education shall issue to the Governor and members of the Senate
21 and House of Representatives Education Committees a Reading Report
22 Card for the state and each school district and elementary site
23 which shall include, but is not limited to, trend data detailing
24

1 three (3) years of data, disaggregated by student subgroups to
2 include economically disadvantaged, major racial or ethnic groups,
3 students with disabilities, and English language learners, as
4 appropriate for the following:

5 1. The number and percentage of students in kindergarten
6 through third grade determined to be at risk for reading
7 difficulties compared to the total number of students enrolled in
8 each grade;

9 2. The number and percentage of students in kindergarten who
10 continue to be at risk for reading difficulties as determined by the
11 year-end measurement of reading progress;

12 3. The number and percentage of students in first through third
13 grade who have successfully completed their program of reading
14 instruction and are reading on grade level as determined by the
15 results of approved reading assessments;

16 4. The number and percentage of students scoring at each
17 performance level on the third-grade criterion-referenced test in
18 reading;

19 5. The amount of funds for reading remediation received by each
20 district;

21 6. An evaluation and narrative interpretation of the report
22 data analyzing the impact of the Reading Sufficiency Act on
23 students' ability to read at grade level; and

1 7. Any recommendations for improvements or amendments to the
2 Reading Sufficiency Act.

3 The State Department of Education may contract with an
4 independent entity for the reporting and analysis requirements of
5 this subsection.

6 S. Copies of the results of the assessments administered shall
7 be made a part of the permanent record of each student.

8 SECTION 8. REPEALER 70 O.S. 2011, Section 3-104.2, is
9 hereby repealed.

10 SECTION 9. This act shall become effective July 1, 2012.

11 SECTION 10. It being immediately necessary for the preservation
12 of the public peace, health and safety, an emergency is hereby
13 declared to exist, by reason whereof this act shall take effect and
14 be in full force from and after its passage and approval.
