requiring certain deposit; and providing  
effective dates.

1 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

2 COMMON EDUCATION

3 SECTION 1. There is hereby appropriated to the State Board  
4 of Education from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2015, the sum of One Billion Fifty-five Million  
7 Two Hundred Ninety-four Thousand Five Hundred Forty-seven  
8 Dollars (\$1,055,294,547.00) or so much thereof as may be  
9 necessary for the financial support of public schools.

10 SECTION 2. There is hereby appropriated to the State Board  
11 of Education from any monies not otherwise appropriated from the  
12 Education Reform Revolving Fund created in Section 34.89 of  
13 Title 62 of the Oklahoma Statutes, the sum of Seven Hundred  
14 Thirty-eight Million Six Hundred Twenty-five Thousand Four  
15 Hundred Seventy-four Dollars (\$738,625,474.00) or so much  
16 thereof as may be necessary for the financial support of public  
17 schools.

18 SECTION 3. The State Board of Education is hereby  
19 authorized to expend during the fiscal year ending June 30,  
20 2015, from the Common Education Technology Revolving Fund of the  
21 State Treasury, the sum of Forty-seven Million Three Hundred  
22 Seventy-two Thousand Two Hundred Ninety-nine Dollars  
23 (\$47,372,299.00) or so much thereof as may be necessary for the  
24 financial support of public schools.

1       SECTION 4. There is hereby appropriated to the State Board  
2 of Education from any monies not otherwise appropriated from the  
3 Mineral Leasing Fund of the State Treasury for the fiscal year  
4 ending June 30, 2015, the sum of Three Million Eight Hundred  
5 Thousand Dollars (\$3,800,000.00) or so much thereof as may be  
6 necessary for the financial support of public schools.

7       SECTION 5. There is hereby appropriated to the State Board  
8 of Education from any monies not otherwise appropriated from the  
9 Mineral Leasing Fund of the State Treasury for the fiscal year  
10 ending June 30, 2013, the sum of One Million Thirty-two Thousand  
11 Two Hundred Fifty-eight Dollars (\$1,032,258.00) or so much  
12 thereof as may be necessary for the financial support of public  
13 schools.

14       SECTION 6. There is hereby appropriated to the State Board  
15 of Education from any monies not otherwise appropriated from the  
16 Oklahoma Education Lottery Trust Fund of the State Treasury for  
17 the fiscal year ending June 30, 2015, the sum of Twenty-five  
18 Million Seven Hundred Sixty-eight Thousand Four Hundred Eighteen  
19 Dollars (\$25,768,418.00) or so much thereof as may be necessary  
20 for the financial support of public schools.

21       SECTION 7. There is hereby appropriated to the State Board  
22 of Education from any monies not otherwise appropriated from the  
23 Oklahoma Education Lottery Trust Fund of the State Treasury for  
24 the fiscal year ending June 30, 2013, the sum of Five Million

1 Six Hundred Seventy-seven Thousand Seven Hundred Eighty-one  
2 Dollars (\$5,677,781.00) or so much thereof as may be necessary  
3 for the financial support of public schools.

4 SECTION 8. There is hereby appropriated to the State Board  
5 of Education from any monies not otherwise appropriated from the  
6 General Revenue Fund of the State Treasury for the fiscal year  
7 ending June 30, 2015, the sum of Five Hundred Forty-six Million  
8 Eight Hundred Sixty-eight Thousand Six Hundred Seventeen Dollars  
9 (\$546,868,617.00) or so much thereof as may be necessary for the  
10 support of public schools activities.

11 SECTION 9. There is hereby appropriated to the State Board  
12 of Education from any monies not otherwise appropriated from the  
13 General Revenue Fund of the State Treasury for the fiscal year  
14 ending June 30, 2013, the sum of Thirty-three Million Dollars  
15 (\$33,000,000.00) or so much thereof as may be necessary for the  
16 purchase of textbooks and instructional materials.

17 SECTION 10. There is hereby appropriated to the State Board  
18 of Education from any monies not otherwise appropriated from the  
19 General Revenue Fund of the State Treasury for the fiscal year  
20 ending June 30, 2015, the sum of Twenty-two Million Four Hundred  
21 Twenty-six Thousand Six Hundred Forty-two Dollars  
22 (\$22,426,642.00) or so much thereof as may be necessary for  
23 administrative and support functions of the State Department of  
24 Education.

1       SECTION 11. There is hereby appropriated to the State Board  
2 of Education from any monies not otherwise appropriated from the  
3 Oklahoma Education Lottery Trust Fund of the State Treasury for  
4 the fiscal year ending June 30, 2015, the sum of Two Million  
5 Eight Hundred Sixty-three Thousand One Hundred Fifty-eight  
6 Dollars (\$2,863,158.00) or so much thereof as may be necessary  
7 for transfer to the School Consolidation Assistance Fund.

8       SECTION 12. There is hereby appropriated to the State Board  
9 of Education from any monies not otherwise appropriated from the  
10 Oklahoma Education Lottery Trust Fund of the State Treasury for  
11 the fiscal year ending June 30, 2013, the sum of Six Hundred  
12 Thirty Thousand Eight Hundred Sixty-five Dollars (\$630,865.00)  
13 or so much thereof as may be necessary for transfer to the  
14 School Consolidation Assistance Fund.

15       SECTION 13. There is hereby appropriated to the State Board  
16 of Education from any monies not otherwise appropriated from the  
17 Oklahoma Education Lottery Trust Fund of the State Treasury for  
18 the fiscal year ending June 30, 2015, the sum of Two Million  
19 Eight Hundred Sixty-three Thousand One Hundred Fifty-eight  
20 Dollars (\$2,863,158.00) or so much thereof as may be necessary  
21 for transfer to the Teachers' Retirement System Dedicated  
22 Revenue Revolving Fund.

23       SECTION 14. There is hereby appropriated to the State Board  
24 of Education from any monies not otherwise appropriated from the

1 Oklahoma Education Lottery Trust Fund of the State Treasury for  
2 the fiscal year ending June 30, 2013, the sum of Six Hundred  
3 Thirty Thousand Eight Hundred Sixty-five Dollars (\$630,865.00)  
4 or so much thereof as may be necessary for transfer to the  
5 Teachers' Retirement System Dedicated Revenue Revolving Fund.

6 SECTION 15. There is hereby appropriated to the Oklahoma  
7 Arts Council from any monies not otherwise appropriated from the  
8 General Revenue Fund of the State Treasury for the fiscal year  
9 ending June 30, 2015, the sum of Three Million Seven Hundred  
10 Eighty-nine Thousand Five Hundred Thirty-two Dollars  
11 (\$3,789,532.00) or so much thereof as may be necessary to  
12 perform the duties imposed upon the Oklahoma Arts Council by  
13 law.

14 SECTION 16. There is hereby appropriated to the  
15 Commissioners of the Land Office from any monies not otherwise  
16 appropriated from the Commissioners of the Land Office Fund of  
17 the State Treasury for the fiscal year ending June 30, 2015, the  
18 sum of Eight Million Five Hundred Thirty-eight Thousand Six  
19 Hundred Dollars (\$8,538,600.00) or so much thereof as may be  
20 necessary to perform the duties imposed upon the Commissioners  
21 of the Land Office by law.

22 SECTION 17. There is hereby appropriated to the Board of  
23 Trustees of the Oklahoma School of Science and Mathematics from  
24 any monies not otherwise appropriated from the General Revenue

1 Fund of the State Treasury for the fiscal year ending June 30,  
2 2015, the sum of Six Million Three Hundred Thirty-two Thousand  
3 Two Hundred Seventy-four Dollars (\$6,332,274.00) or so much  
4 thereof as may be necessary to perform the duties imposed upon  
5 the Board of Trustees of the Oklahoma School of Science and  
6 Mathematics by law.

7 SECTION 18. There is hereby appropriated to the Office of  
8 Educational Quality and Accountability from any monies not  
9 otherwise appropriated from the General Revenue Fund of the  
10 State Treasury for the fiscal year ending June 30, 2015, the sum  
11 of One Million Nine Hundred Thirty-one Thousand Two Hundred  
12 Seventy-one Dollars (\$1,931,271.00) or so much thereof as may be  
13 necessary to perform the duties imposed upon the Office of  
14 Educational Quality and Accountability by law.

15 CAREER AND TECHNOLOGY EDUCATION

16 SECTION 19. There is hereby appropriated to the State Board  
17 of Career and Technology Education from any monies not otherwise  
18 appropriated from the General Revenue Fund of the State Treasury  
19 for the fiscal year ending June 30, 2015, the sum of One Hundred  
20 Thirty-five Million Forty-nine Thousand One Hundred Ninety-four  
21 Dollars (\$135,049,194.00) or so much thereof as may be necessary  
22 to perform the duties imposed upon the State Board of Career and  
23 Technology Education by law.

1       SECTION 20. There is hereby appropriated to the State Board  
2 of Career and Technology Education from any monies not otherwise  
3 appropriated from the Oklahoma Education Lottery Trust Fund of  
4 the State Treasury for the fiscal year ending June 30, 2015, the  
5 sum of Three Million One Hundred Forty-nine Thousand Four  
6 Hundred Seventy-three Dollars (\$3,149,473.00) pursuant to  
7 paragraph 2 of subsection C of Section 713 of Title 3A of the  
8 Oklahoma Statutes for allocation by the State Board of Career  
9 and Technology Education for the education and general operating  
10 budgets of the institutions and for other programs,  
11 construction, renovations or repairs administered by the State  
12 Board of Career and Technology Education.

13       SECTION 21. There is hereby appropriated to the State Board  
14 of Career and Technology Education from any monies not otherwise  
15 appropriated from the Oklahoma Education Lottery Trust Fund of  
16 the State Treasury for the fiscal year ending June 30, 2013, the  
17 sum of Six Hundred Ninety-three Thousand Nine Hundred Fifty-one  
18 Dollars (\$693,951.00) pursuant to paragraph 2 of subsection C of  
19 Section 713 of Title 3A of the Oklahoma Statutes for allocation  
20 by the State Board of Career and Technology Education for the  
21 education and general operating budgets of the institutions and  
22 for other programs, construction, renovations or repairs  
23 administered by the State Board of Career and Technology  
24 Education.

1       SECTION 22. There is hereby appropriated to the Oklahoma  
2 Educational Television Authority from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury  
4 for the fiscal year ending June 30, 2015, the sum of Three  
5 Million Six Hundred Twelve Thousand One Hundred Dollars  
6 (\$3,612,100.00) or so much thereof as may be necessary to  
7 perform the duties imposed upon the Oklahoma Educational  
8 Television Authority by law.

9       SECTION 23. There is hereby appropriated to the Oklahoma  
10 Department of Libraries from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury  
12 for the fiscal year ending June 30, 2015, the sum of Five  
13 Million Five Hundred Seventy-four Thousand Two Hundred Eight  
14 Dollars (\$5,574,208.00) or so much thereof as may be necessary  
15 to perform the duties imposed upon the Oklahoma Department of  
16 Libraries by law.

17                                   HIGHER EDUCATION

18       SECTION 24. There is hereby appropriated to the Oklahoma  
19 State Regents for Higher Education from any monies not otherwise  
20 appropriated from the General Revenue Fund of the State Treasury  
21 for the fiscal year ending June 30, 2015, the sum of Eight  
22 Hundred Thirty-five Million Sixty-four Thousand Nine Hundred Ten  
23 Dollars (\$835,064,910.00) or so much thereof as may be necessary  
24 for allocation by the Oklahoma State Regents for Higher

1 Education pursuant to the provisions of Article XIII-A of the  
2 Oklahoma Constitution for the education and general operating  
3 budgets of the institutions and for other programs,  
4 construction, renovations or repairs administered by the  
5 Oklahoma State Regents for Higher Education. Of those funds  
6 appropriated, the sum of Three Million Eight Hundred Thirty  
7 Thousand Thirty-eight Dollars (\$3,830,038.00) shall be  
8 transferred to the Oklahoma Tuition Equalization Grant Trust  
9 Fund to implement the provisions of the Oklahoma Tuition  
10 Equalization Grant Act.

11 SECTION 25. The Oklahoma State Regents for Higher Education  
12 are hereby authorized to expend, from the Special Cash Fund of  
13 the State Treasury the sum of Ten Million Dollars  
14 (\$10,000,000.00) or so much thereof as may be necessary for  
15 allocation by the Oklahoma State Regents for Higher Education  
16 pursuant to the provisions of Article XIII-A of the Oklahoma  
17 Constitution for the education and general operating budgets of  
18 the institutions and for other programs, construction,  
19 renovations or repairs administered by the Oklahoma State  
20 Regents for Higher Education.

21 SECTION 26. The Oklahoma State Regents for Higher Education  
22 are hereby authorized to expend during the fiscal year ending  
23 June 30, 2015, the sum of Forty-seven Million Three Hundred  
24 Seventy-two Thousand Two Hundred Ninety-nine Dollars

1 (\$47,372,299.00) from the Higher Education Capital Revolving  
2 Fund of the State Treasury for allocation by the Oklahoma State  
3 Regents for Higher Education pursuant to the provisions of  
4 Article XIII-A of the Oklahoma Constitution for the education  
5 and general operating budgets of the institutions and for other  
6 programs, construction, renovations or repairs administered by  
7 the Oklahoma State Regents for Higher Education.

8 SECTION 27. The Oklahoma State Regents for Higher Education  
9 are hereby authorized to expend during the fiscal year ending  
10 June 30, 2015, the sum of Forty-seven Million Three Hundred  
11 Seventy-two Thousand Two Hundred Ninety-nine Dollars  
12 (\$47,372,299.00) from the Oklahoma Student Aid Revolving Fund of  
13 the State Treasury for allocation by the Oklahoma State Regents  
14 for Higher Education pursuant to the provisions of Article XIII-  
15 A of the Oklahoma Constitution for the education and general  
16 operating budgets of the institutions and for other programs,  
17 construction, renovations or repairs administered by the  
18 Oklahoma State Regents for Higher Education.

19 SECTION 28. There is hereby appropriated to the Oklahoma  
20 State Regents for Higher Education from any monies not otherwise  
21 appropriated from the Special Cash Fund of the State Treasury  
22 the sum of Fifteen Million Dollars (\$15,000,000.00) for  
23 allocation by the Oklahoma State Regents for Higher Education  
24 pursuant to the provisions of Article XIII-A of the Oklahoma

1 Constitution for the education and general operating budgets of  
2 the institutions and for other programs, construction,  
3 renovations or repairs administered by the Oklahoma State  
4 Regents for Higher Education.

5 SECTION 29. There is hereby appropriated to the Oklahoma  
6 State Regents for Higher Education from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury  
8 for the fiscal year ending June 30, 2015, the sum of One Million  
9 Two Hundred Thirty-four Thousand One Hundred Seventy-four  
10 Dollars (\$1,234,174.00) or so much thereof as may be necessary  
11 for expenditures for concurrent enrollment pursuant to Section  
12 628.13 of Title 70 of the Oklahoma Statutes.

13 SECTION 30. There is hereby appropriated to the Oklahoma  
14 State Regents for Higher Education from any monies not otherwise  
15 appropriated from the Oklahoma Education Lottery Trust Fund of  
16 the State Treasury for the fiscal year ending June 30, 2015, the  
17 sum of Twenty-two Million Six Hundred Eighteen Thousand Nine  
18 Hundred Forty-four Dollars (\$22,618,944.00) pursuant to  
19 paragraph 2 of subsection C of Section 713 of Title 3A of the  
20 Oklahoma Statutes for allocation by the Oklahoma State Regents  
21 for Higher Education pursuant to the provisions of Article XIII-  
22 A of the Oklahoma Constitution for construction, renovations or  
23 repairs administered by the Oklahoma State Regents for Higher  
24 Education or for any other purpose authorized by paragraph 2 of

1 subsection C of Section 713 of Title 3A of the Oklahoma  
2 Statutes.

3 SECTION 31. There is hereby appropriated to the Oklahoma  
4 State Regents for Higher Education from any monies not otherwise  
5 appropriated from the Oklahoma Education Lottery Trust Fund of  
6 the State Treasury for the fiscal year ending June 30, 2013, the  
7 sum of Four Million Nine Hundred Eighty-three Thousand Eight  
8 Hundred Thirty Dollars (\$4,983,830.00) pursuant to paragraph 2  
9 of subsection C of Section 713 of Title 3A of the Oklahoma  
10 Statutes for allocation by the Oklahoma State Regents for Higher  
11 Education pursuant to the provisions of Article XIII-A of the  
12 Oklahoma Constitution for construction, renovations or repairs  
13 administered by the Oklahoma State Regents for Higher Education  
14 or for any other purpose authorized by paragraph 2 of subsection  
15 C of Section 713 of Title 3A of the Oklahoma Statutes.

16 SECTION 32. There is hereby appropriated to the Oklahoma  
17 State Regents for Higher Education from any monies not otherwise  
18 appropriated from the General Revenue Fund of the State Treasury  
19 for the fiscal year ending June 30, 2015, the sum of Four  
20 Million Nine Hundred Two Thousand Five Hundred Fifty Dollars  
21 (\$4,902,550.00) or so much thereof as may be necessary for the  
22 general operating budget of the Administrative Offices of the  
23 Oklahoma State Regents for Higher Education.

1       SECTION 33. There is hereby appropriated to the Physician  
2 Manpower Training Commission from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury  
4 for the fiscal year ending June 30, 2015, the sum of Three  
5 Million Seven Hundred Thirty-eight Thousand Three Hundred  
6 Ninety-five Dollars (\$3,738,395.00) or so much thereof as may be  
7 necessary to perform the duties imposed upon the Physician  
8 Manpower Training Commission by law.

9       SECTION 34. There is hereby appropriated to the Physician  
10 Manpower Training Commission from any monies not otherwise  
11 appropriated from the Special Cash Fund of the State Treasury  
12 the sum of Four Hundred Thousand Dollars (\$400,000.00) or so  
13 much thereof as may be necessary to perform the duties imposed  
14 upon the Physician Manpower Training Commission by law.

15       SECTION 35. There is hereby appropriated to the Oklahoma  
16 Center for the Advancement of Science and Technology from any  
17 monies not otherwise appropriated from the General Revenue Fund  
18 of the State Treasury for the fiscal year ending June 30, 2015,  
19 the sum of Sixteen Million Eight Hundred Thirty-one Thousand  
20 Eight Hundred Nineteen Dollars (\$16,831,819.00) or so much  
21 thereof as may be necessary to perform the duties imposed upon  
22 the Oklahoma Center for the Advancement of Science and  
23 Technology by law. Of those funds appropriated, the sum of  
24 Twelve Million Four Hundred Thirty-four Thousand One Hundred Six

1 Dollars (\$12,434,106.00) shall be deposited in the Research  
2 Support Revolving Fund, created pursuant to Section 5060.11 of  
3 Title 74 of the Oklahoma Statutes. Of those funds appropriated,  
4 the sum of Three Million Seven Hundred Forty-eight Thousand Two  
5 Hundred Five Dollars (\$3,748,205.00) shall be deposited in the  
6 Seed-capital Revolving Fund, created pursuant to Section 5060.21  
7 of Title 74 of the Oklahoma Statutes.

8 GENERAL GOVERNMENT AND TRANSPORTATION

9 SECTION 36. There is hereby appropriated to the Office of  
10 the State Auditor and Inspector from any monies not otherwise  
11 appropriated from the General Revenue Fund of the State Treasury  
12 for the fiscal year ending June 30, 2015, the sum of Four  
13 Million One Hundred Fifty-eight Thousand Nine Hundred Seventy-  
14 six Dollars (\$4,158,976.00) or so much thereof as may be  
15 necessary to perform the duties imposed upon the Office of the  
16 State Auditor and Inspector by law.

17 SECTION 37. There is hereby appropriated to the Office of  
18 the State Auditor and Inspector from any monies not otherwise  
19 appropriated from the General Revenue Fund of the State Treasury  
20 for the fiscal year ending June 30, 2015, the sum of Two Hundred  
21 Eighty-nine Thousand One Hundred Twenty-six Dollars  
22 (\$289,126.00) or so much thereof as may be necessary to perform  
23 the duties imposed upon the Commission on County Government  
24 Personnel Education and Training. The appropriation made in

1 | this section shall be expended exclusively for the purpose so  
2 | stated and shall not be transferable.

3 |       SECTION 38. There is hereby appropriated to the Office of  
4 | the State Bond Advisor from any monies not otherwise  
5 | appropriated from the General Revenue Fund of the State Treasury  
6 | for the fiscal year ending June 30, 2015, the sum of One Hundred  
7 | Thirty-five Thousand Two Hundred Forty Dollars (\$135,240.00) or  
8 | so much thereof as may be necessary to perform the duties

24 of Three Hundred Thousand Dollars (\$300,000.00) or so much

1 thereof as may be necessary for the Food and Agricultural  
2 Products Center of the Oklahoma Agricultural Extension Division.

3 SECTION 139. There is hereby appropriated to the Oklahoma  
4 Conservation Commission from any monies not otherwise  
5 appropriated from the General Revenue Fund of the State Treasury  
6 for the fiscal year ending June 30, 2013, the sum of Three  
7 Million Dollars (\$3,000,000.00) or so much thereof as may be  
8 necessary for watershed flood control programs.

9 SECTION 140. There is hereby appropriated to the Scenic  
10 Rivers Commission from any monies not otherwise appropriated  
11 from the General Revenue Fund of the State Treasury for the
