BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 10A O.S. 2011, Section 1-6-102, as last amended by Section 2, Chapter 374, O.S.L. 2013 (10A O.S. Supp. 2013, Section 1-6-102), is amended to read as follows:

1 Section 1-6-102. A. Except as provided by this section and
2 except as otherwise specifically provided by state and federal laws,
3 the following records are confidential and shall not be open to the
4 general public or inspected or their contents disclosed:

5 1. Juvenile court records;

6 2. Agency records;

7 3. District attorney's records;

8 4. Court Appointed Special Advocate records pertaining to a
9 child welfare case;

10 5. Law enforcement records;

11 ~~5.~~ 6. Nondirectory education records; and

12 ~~6.~~ 7. Social records.

13 B. The limitation of subsection A of this section shall not
14 apply to statistical information and other abstract information
15 obtained pursuant to the provisions of the Oklahoma Children's Code.

16 C. Except as authorized by Section 620.6 of Title 10 of the
17 Oklahoma Statutes and this chapter and except as otherwise
18 specifically provided by state and federal laws pertaining to
19 education records, medical records, drug or alcohol treatment
20 records, law enforcement, or social service records, the records
21 listed in subsection A of this section shall be confidential and
22 shall be inspected, released, disclosed, corrected or expunged only
23 pursuant to an order of the court. A subpoena or subpoena duces
24

1 tecum purporting to compel testimony or disclosure of such
2 information or record shall be invalid.

3 D. 1. In a proceeding where the child custody or visitation is
4 at issue, the safety analysis records of the Department shall be
5 produced to the court when a parent, legal guardian, or child who is
6 the subject of such record obtains a court order directing the
7 production of the records.

8 2. The person or party seeking the records shall proceed by
9 filing a motion for production of safety analysis records which
10 contains the following averments:

- 11 a. the movant is a parent, legal guardian, or child who
12 is the subject of the safety analysis records,
- 13 b. child custody or visitation is at issue,
- 14 c. that upon receipt from the court, the safety analysis
15 records shall be kept confidential and disclosed only
16 to the movant, the attorneys of the movant, those
17 persons employed by or acting on behalf of the movant
18 and the attorneys of the movant whose aid is necessary
19 to the prosecution or defense of the child custody or
20 visitation issue, and
- 21 d. that a copy of the motion is being provided to the
22 parties, the attorney of the child, if any, and the
23 guardian ad litem, if any.

1 3. Upon filing the motion for production of safety analysis
2 records, the court may, in its discretion, enter an ex parte order
3 for production of safety analysis records that shall be
4 substantially in the following form:

5 CONFIDENTIAL RECORDS DISCLOSURE AND PROTECTIVE ORDER

6 NOW on this ____ day of _____, 20__, the court finds that child
7 custody or visitation is at issue in the above styled and numbered
8 proceeding and the disclosure of the safety analysis records of the
9 Oklahoma Department of Human Services pursuant to Section 1-6-102 of
10 this title is necessary and relevant to the court's determination of
11 the child's best interests. The court therefore orders as follows:

12 a. The Oklahoma Department of Human Services

13 ("Department" or "DHS") shall produce a copy of its

14 safety analysis records to this court on or before ____

15 day of _____, 20__.

16 b. The Department shall be permitted to redact or omit

17 information in its safety analysis records which may

18 identify the reporter of alleged child abuse or

19 neglect.

20 c. All information contained in the safety analysis

21 records of the Department is confidential under

22 Oklahoma law and shall be disclosed only to the

23 parties, the attorneys of the parties, and those

24 persons employed by or acting on behalf of the parties

1 and the attorneys of the parties whose aid is
2 necessary to the prosecution or defense of the child
3 custody or visitation issue.

4 d. No confidential information whether contained in
5 pleadings, briefs, discovery, or other documents shall
6 be filed except under seal with the legend "THIS
7 DOCUMENT CONTAINS CONFIDENTIAL INFORMATION AND IS
8 SUBJECT TO A PROTECTIVE ORDER OF THE COURT".

9 e. No person or entity shall utilize any information
10 contained in the safety analysis records for any
11 purpose other than the prosecution or defense of the
12 child custody or visitation issues in this case.

13 f. The release by counsel or any other person for any
14 reason of identifiers such as social security or tax
15 ID numbers that may be contained in the Department
16 records and which belong to any person or entity is
17 strictly prohibited.

18 g. Any violation of this order shall be subject to
19 prosecution for contempt of court.

20 IT IS SO ORDERED this ____ day of _____, 20__.

21 4. This subsection shall not apply to:

22 a. deprived child proceedings brought pursuant to the
23 Oklahoma Children's Code,
24

- b. discovery of safety analysis records by a person or entity who is not the subject of those records, or
- c. discovery of safety analysis records in criminal, other civil, or administrative proceedings.

5. The party who has obtained a court order for the safety analysis records of the Department shall provide the Department with the names and other identifying information concerning the subjects of the safety analysis records.

6. Upon receipt of a court order to produce its safety analysis records, the Department shall be given a minimum of five (5) judicial days to deliver the records to the court.

7. The safety analysis records provided by the Department to the court pursuant to this subsection shall not be subject to judicial review and shall be released by the court only to the litigants in the case under a protective order.

8. A court order entered pursuant to this subsection which purports to require the Department to produce all agency records shall be deemed to require only the production of the safety analysis records of the Department.

9. An employee of the Department shall not be compelled to testify about the safety analysis records except upon a court order directing such testimony. Any subpoena or subpoena duces tecum purporting to compel disclosure of safety analysis records or

1 testimony concerning such records without a court order shall be
2 invalid.

3 10. Except as provided by this subsection or other law,
4 confidential records may be inspected, released, disclosed,
5 corrected, or expunged only by the procedure set forth in subsection
6 E of this section.

7 E. When confidential records may be relevant in a criminal,
8 civil, or administrative proceeding, an order of the court
9 authorizing the inspection, release, disclosure, correction, or
10 expungement of confidential records shall be entered by the court
11 only after a judicial review of the records and a determination of
12 necessity pursuant to the following procedure:

13 1. A petition or motion shall be filed with the court
14 describing with specificity the confidential records being sought
15 and setting forth in detail the compelling reason why the
16 inspection, release, disclosure, correction, or expungement of
17 confidential records should be ordered by the court. A petition or
18 motion that does not contain the required specificity or detail may
19 be subject to dismissal by the court;

20 2. Upon the filing of the petition or motion, the court shall
21 set a date for a hearing and shall require notice of not less than
22 twenty (20) days to the agency or person holding the records and the
23 person who is the subject of the record if such person is eighteen
24 (18) years of age or older or to the parents of a child less than

1 | eighteen (18) years of age who is the subject of the record, to the
2 | attorneys, if any, of such person, child or parents and any other
3 | interested party as ordered by the court. The court may also enter
4 | an ex parte order compelling the person or agency holding the
5 | records to either produce the records to the court on or before the
6 | date set for hearing or file an objection or appear for the hearing.
7 | The court may shorten the time allowed for notice due to exigent
8 | circumstances;

9 | 3. At the hearing, should the court find that a compelling
10 | reason does not exist for the confidential records to be judicially
11 | reviewed, the matter shall be dismissed; otherwise, the court shall
12 | order that the records be produced for a judicial review. The
13 | hearing may be closed at the discretion of the court; and

14 | 4. The judicial review of the records shall include a
15 | determination, with due regard for the confidentiality of the
16 | records and the privacy of persons identified in the records, as to
17 | whether an order should be entered authorizing the inspection,
18 | release, disclosure, correction, or expungement of the records based
19 | upon the need for the protection of a legitimate public or private
20 | interest.

21 | F. The court may, for good cause shown, prohibit the release of
22 | such confidential records or testimony or authorize a release of the
23 | confidential information or testimony upon such conditions as the
24 |

1 court deems necessary and appropriate, subject to the provisions of
2 this section.

3 G. Any public or private agency, entity, or professional person
4 required to produce confidential records pursuant to this section
5 may require payment of fees from the party seeking the records prior
6 to any records being produced, including a research fee not
7 exceeding Twenty Dollars (\$20.00) per hour and a copy fee not to
8 exceed fifty cents (\$0.50) per page and Five Dollars (\$5.00) per
9 copy of each video tape or disk; provided, the court may waive such
10 costs in a criminal action based upon indigence of a defendant. The
11 Department shall not be permitted to assess fees for records
12 produced pursuant to subsection D of this section.

13 H. Nothing in Section 620.6 of Title 10 of the Oklahoma
14 Statutes and this chapter shall be construed as:

15 1. Authorizing the inspection of records or the disclosure of
16 information contained in records relating to the provision of
17 benefits or services funded, in whole or in part, with federal
18 funds, except in accord with federal statutes and regulations
19 governing the receipt or use of such funds;

20 2. Authorizing the disclosure of papers, records, books or
21 other information relating to the adoption of a child required to be
22 kept confidential. The disclosure of such information shall be
23 governed by the provisions of the Oklahoma Adoption Code;

1 3. Abrogating any privilege, including the attorney-client
2 privilege, or affecting any limitation on such privilege found in
3 any other statutes;

4 4. Limiting or otherwise affecting access of parties to a
5 deprived proceeding to records filed with or submitted to the court;

6 5. Limiting or otherwise affecting access of agencies to
7 information subject to disclosure, review, or inspection by contract
8 or as a condition for the receipt of public funds or participation
9 in any program administered by the agency;

10 6. Prohibiting the Department of Human Services from
11 summarizing the outcome of an investigation to the person who
12 reported a known or suspected instance of child abuse or neglect or
13 to any person providing services to a child who is or is alleged to
14 be a victim of child abuse;

15 7. Authorizing the disclosure of information which identifies
16 any person who has reported an allegation of known or suspected
17 child abuse or neglect unless such disclosure is specifically
18 ordered by the court;

19 8. Authorizing the disclosure of a recording or a transcription
20 of a hotline referral which identifies any person who has reported
21 an allegation of known or suspected child abuse or neglect, unless
22 the disclosure is specifically ordered by the court;

23 9. Prohibiting the Department of Human Services from providing
24 a summary of allegations and findings of an investigation involving

1 a child care facility that does not disclose identities but that
2 permits parents to evaluate the facility;

3 10. Prohibiting the disclosure of confidential information to
4 any educational institution, facility, or educator to the extent
5 necessary to enable the educator to better provide educational
6 services and activities for a child and provide for the safety of
7 students;

8 11. Prohibiting the Department from obtaining, without a court
9 order, nondirectory education records pertaining to a child in the
10 legal custody of the Department; or

11 12. Prohibiting the Department from providing records to a
12 federally recognized Indian tribe for any individual who has applied
13 for foster care placement, adoptive placement, or guardianship
14 placement through the tribe; provided, that the tribe shall be
15 required to maintain the confidentiality of the records.

16 SECTION 2. REPEALER 10A O.S. 2011, Section 1-6-102, as
17 last amended by Section 1, Chapter 387, O.S.L. 2013 (10A O.S. Supp.

22 Section 1290.14.

23 SAFETY AND TRAINING COURSE
24

1 A. Each applicant for a license to carry a concealed or
2 unconcealed handgun pursuant to the Oklahoma Self-Defense Act must
3 successfully complete a firearms safety and training course in this
4 state conducted by a registered and approved firearms instructor as
5 provided by the provisions of this section. The applicant must
6 further demonstrate competence and qualification with an authorized
7 pistol of the type or types that the applicant desires to carry as a
8 concealed or unconcealed handgun pursuant to the provisions of the
9 Oklahoma Self-Defense Act, except certain persons may be exempt from
10 such training requirement as provided by the provisions of Section
11 1290.15 of this title.

12 B. The Council on Law Enforcement Education and Training
13 (CLEET) shall establish criteria for approving firearms instructors
14 for purposes of training and qualifying individuals for a handgun
15 license pursuant to the provisions of the Oklahoma Self-Defense Act.
16 Prior to submitting an application for CLEET approval as a firearms
17 instructor, applicants shall attend a firearms instructor school,
18 meeting the following minimum requirements:

19 1. Firearms instructor training conducted by one of the
20 following entities:

- 21 a. Council on Law Enforcement Education and Training,
- 22 b. National Rifle Association,
- 23 c. Oklahoma Rifle Association,
- 24 d. federal law enforcement agencies, or

1 e. other professionally recognized organizations;

2 2. The course shall be at least sixteen (16) hours in length;

3 3. Upon completion of the course, the applicant shall be
4 qualified to provide instruction on revolvers, semiautomatic
5 pistols, or both; and

6 4. Receive a course completion certificate.

7 All firearms instructors shall be required to meet the
8 eligibility requirements for a handgun license as provided in
9 Sections 1290.9, 1290.10, and 1290.11 of this title, and the
10 application shall be processed as provided for applicants in Section
11 1290.12 of this title, including the state and national criminal
12 history records search and fingerprint search. A firearms
13 instructor shall be required to pay a fee of One Hundred Dollars
14 (\$100.00) to the Council on Law Enforcement Education and Training
15 (CLEET) each time the person makes application for CLEET approval as
16 a firearms instructor pursuant to the provisions of the Oklahoma
17 Self-Defense Act. The fee shall be retained by CLEET and shall be
18 deposited into the Firearms Instructors Revolving Fund. CLEET shall
19 promulgate the rules, forms and procedures necessary to implement
20 the approval of firearms instructors as authorized by the provisions
21 of this subsection. CLEET shall periodically review each approved
22 instructor during a training and qualification course to assure
23 compliance with the rules and course contents. Any violation of the
24 rules may result in the revocation or suspension of CLEET and

1 Oklahoma State Bureau of Investigation approval. Unless the
2 approval has been revoked or suspended, a firearms instructor's
3 CLEET approval shall be for a term of five (5) years. Beginning on
4 July 1, 2003, any firearms instructor who has been issued a four-
5 year CLEET approval shall not be eligible for the five-year approval
6 until the expiration of the approval previously issued. CLEET shall
7 be responsible for notifying all approved firearms instructors of
8 statutory and policy changes related to the Oklahoma Self-Defense
9 Act. A firearms instructor shall not be required to submit his or
10 her fingerprints for a fingerprint search when renewing a firearms
11 instructor's CLEET approval.

12 C. 1. All firearms instructors approved by CLEET to train and
13 qualify individuals for a handgun license shall be required to apply
14 for registration with the Oklahoma State Bureau of Investigation
15 after receiving CLEET approval. All firearms instructors teaching
16 the approved course for a handgun license must display their
17 registration certificate during each training and qualification
18 course. Each approved firearms instructor shall complete a
19 registration form provided by the Bureau and shall have the option
20 to pay a registration fee of either One Hundred Dollars (\$100.00)
21 for a five-year registration certificate or Two Hundred Dollars
22 (\$200.00) for a ten-year registration certificate to the Bureau at
23 the time of each application for registration, except as provided in
24 paragraph 2 of this subsection. Registration certificates issued by

1 the Bureau shall be valid for a period of five (5) years or ten (10)
2 years from the date of issuance. The Bureau shall issue a five-year
3 or ten-year handgun license to an approved firearms instructor at
4 the time of issuance of a registration certificate and no additional
5 fee shall be required or charged. The Bureau shall maintain a
6 current listing of all registered firearms instructors in this
7 state. Nothing in this paragraph shall be construed to eliminate
8 the requirement for registration and training with CLEET as provided
9 in subsection B of this section. Failure to register or be trained
10 as required shall result in a revocation or suspension of the
11 instructor certificate by the Bureau.

12 2. On or after July 1, 2003, the registered instructors listed
13 in subparagraphs a and b of this paragraph shall not be required to
14 renew the firearms instructor registration certificate with the
15 Oklahoma State Bureau of Investigation at the expiration of the
16 registration term, provided the instructor is not subject to any
17 suspension or revocation of the firearms instructor certificate.
18 The firearms instructor registration with the Oklahoma State Bureau
19 of Investigation shall automatically renew together with the handgun
20 license authorized in paragraph 1 of this subsection for an
21 additional five-year term and no additional cost or fee may be
22 charged for the following individuals:

23 a. an active duty law enforcement officer of this state
24 or any of its political subdivisions or of the federal

1 government who has a valid CLEET approval as a
2 firearms instructor pursuant to the Oklahoma Self-
3 Defense Act, and

4 b. a retired law enforcement officer authorized to carry
5 a firearm pursuant to Section 1289.8 of this title who
6 has a valid CLEET approval as a firearms instructor
7 pursuant to the Oklahoma Self-Defense Act.

8 D. The Oklahoma State Bureau of Investigation shall approve
9 registration for a firearms instructor applicant who is in full
10 compliance with CLEET rules regarding firearms instructors and the
11 provisions of subsection B of this section, if completion of the
12 federal fingerprint search is the only reason for delay of
13 registration of that firearms instructor applicant. Upon receipt of
14 the federal fingerprint search information, if the Bureau receives
15 information which precludes the person from having a handgun
16 license, the Bureau shall revoke both the registration and the
17 handgun license previously issued to the firearms instructor.

18 E. The required firearms safety and training course and the
19 actual demonstration of competency and qualification required of the
20 applicant shall be designed and conducted in such a manner that the
21 course can be reasonably completed by the applicant within an eight-
22 hour period. CLEET shall establish the course content and
23 promulgate rules, procedures and forms necessary to implement the
24 provisions of this subsection. For the training and qualification

1 course, an applicant may be charged a fee which shall be determined
2 by the instructor or entity that is conducting the course. The
3 ~~instructor to student ratio shall not exceed ten students to any one~~
4 ~~instructor~~ maximum class size shall be determined by the instructor
5 conducting the course; provided, however, practice shooting sessions
6 shall not have more than ten participating students at one time.

7 CLEET may establish criteria for assistant instructors, ~~maximum~~
8 ~~class size~~ and any other requirements deemed necessary to conduct a
9 safe and effective training and qualification course. The course
10 content shall include a safety inspection of the firearm to be used
11 by the applicant in the training course; instruction on pistol
12 handling, safety and storage; dynamics of ammunition and firing;
13 methods or positions for firing a pistol; information about the
14 criminal provisions of the Oklahoma law relating to firearms; the
15 requirements of the Oklahoma Self-Defense Act as it relates to the
16 applicant; self-defense and the use of appropriate force; a practice
17 shooting session; and a familiarization course. The firearms
18 instructor shall refuse to train or qualify any person when the
19 pistol to be used or carried by the person is either deemed unsafe
20 or unfit for firing or is a weapon not authorized by the Oklahoma
21 Self-Defense Act. The course shall provide an opportunity for the
22 applicant to qualify himself or herself on either a derringer, a
23 revolver, a semiautomatic pistol or any combination of a derringer,
24 a revolver and a semiautomatic pistol, provided no pistol shall be

1 capable of firing larger than .45 caliber ammunition. Any applicant
2 who successfully trains and qualifies himself or herself with a
3 semiautomatic pistol may be approved by the firearms instructor on
4 the training certificate for a semiautomatic pistol, a revolver and
5 a derringer upon request of the applicant. Any person who qualifies
6 on a derringer or revolver shall not be eligible for a semiautomatic
7 rating until the person has demonstrated competence and
8 qualifications on a semiautomatic pistol. Upon successful
9 completion of the training and qualification course, a certificate
10 shall be issued to each applicant who successfully completes the
11 course. The certificate of training shall comply with the form
12 established by CLEET and shall be submitted with an application for
13 a handgun license pursuant to the provisions of paragraph 2 of
14 subsection A of Section 1290.12 of this title.

15 F. There is hereby created a revolving fund for the Council on
16 Law Enforcement Education and Training (CLEET), to be designated the
17 "Firearms Instructors Revolving Fund". The fund shall be a
18 continuing fund, not subject to fiscal year limitations, and shall
19 consist of all funds received for approval of firearms instructors
20 for purposes of the Oklahoma Self-Defense Act. All funds received
21 shall be deposited to the fund. All monies accruing to the credit
22 of said fund are hereby appropriated and may be budgeted and
23 expended by the Council on Law Enforcement Education and Training,
24 for implementation of the training and qualification course

1 contents, approval of firearms instructors and any other CLEET
2 requirement pursuant to the provisions of the Oklahoma Self-Defense
3 Act or as may otherwise be deemed appropriate by CLEET.
4 Expenditures from said fund shall be made upon warrants issued by
5 the State Treasurer against claims filed as prescribed by law with
6 the Director of the Office of Management and Enterprise Services for
7 approval and payment.

8 SECTION 4. REPEALER 21 O.S. 2011, Section 1290.14, as
9 last amended by Section 1, Chapter 139, O.S.L. 2013 (21 O.S. Supp.
10 2013, Section 1290.14), is hereby repealed.

11 SECTION 5. AMENDATORY 26 O.S. 2011, Section 7-114, as
12 amended by Section 2, Chapter 34, O.S.L. 2013 (26 O.S. Supp. 2013,
13 Section 7-114), is amended to read as follows:

14 Section 7-114. A. Each person appearing to vote shall announce
15 that person's name to the judge of the precinct and shall provide
16 proof of identity, whereupon the judge shall determine whether the
17 person's name is in the precinct registry. As used in this section,
18 "proof of identity" shall mean a document that satisfies all of the
19 following:

20 1. The document shows the name of the person to whom the
21 document was issued, and the name substantially conforms to the name
22 in the precinct registry;

23 2. The document shows a photograph of the person to whom the
24 document was issued;

1 3. The document includes an expiration date, which is after the
2 date of the election in which the person is appearing to vote. The
3 provisions of this paragraph shall not apply to:

4 a. an identification card that is valid indefinitely, or

5 b. an identification card issued by a branch of the armed
6 services of the United States to a person who is a
7 member of such branch or is retired therefrom; and

8 4. The document was issued by the United States, the State of
9 Oklahoma or the government of a federally recognized Indian tribe or
10 nation.

11 Provided, if the person presents a voter identification card
12 issued by the appropriate county election board, such card may serve
13 as proof of identity without meeting the requirements of paragraphs
14 2 and 3 of this subsection.

15 B. 1. If a person declines to or is unable to produce proof of
16 identity, the person may sign a statement under oath, in a form
17 approved by the Secretary of the State Election Board, swearing or
18 affirming that the person is the person identified on the precinct
19 registry, and shall be allowed to cast a provisional ballot in a
20 manner consistent with the provisions of Section 7-116.1 of this
21 title.

22 2. A provisional ballot cast by a voter who declines or is
23 unable to produce proof of identity shall only be considered
24 verified and approved for counting if:

- a. the voter's name on the affidavit substantially conforms to the voter's name in the voter registration database, except as provided in paragraph 3 of this subsection,
- b. the voter's residence address on the affidavit substantially conforms to the voter's residence address in the voter registration database, except as provided in paragraph 4 of this subsection,
- c. the voter's date of birth matches the information in the voter registration database,
- d. the voter's Oklahoma driver license number or the last four digits of the voter's Social Security number on the affidavit matches the information in the voter registration database. The provisions of this subparagraph shall not apply if the voter was not required to provide a driver license number or the last four digits of the voter's Social Security number at the time of registration, and
- e. the provisional ballot meets the eligibility requirements set forth in Section 7-116.1 of this title.

3. A voter casting a provisional ballot as provided in this section who has legally changed his or her name, but has not updated the name on the voter registry, may note this fact on the affidavit

1 and submit a form prescribed by the Secretary of the State Election
2 Board to update his or her name. In such a case, and where the
3 requirements of Section 4-117 of this title are satisfied, the
4 provisional ballot shall be deemed to meet the requirements of
5 subparagraph a of paragraph 2 of this subsection.

6 4. A voter casting a provisional ballot as provided in this
7 section who has changed his or her address of residence, but has not
8 updated the address on the voter registry, may note this fact on the
9 affidavit and submit a form to update the address prescribed by the
10 Secretary of the State Election Board. In such a case, and where
11 the requirements of Section 4-117 of this title are satisfied, the
12 provisional ballot shall be deemed to meet the requirements of
13 subparagraph a of paragraph 2 of this subsection.

14 5. False swearing or affirming under oath shall be punishable
15 as a felony as provided in Section 16-103 of this title, and the
16 penalty shall be distinctly set forth on the face of the statement.

17 SECTION 6. REPEALER 26 O.S. 2011, Section 7-114, as
18 amended by Section 1, Chapter 38, O.S.L. 2013 (26 O.S. Supp. 2013,
19 Section 7-114), is hereby repealed.

20 SECTION 7. AMENDATORY 40 O.S. 2011, Section 2-203, as
21 amended by Section 1, Chapter 148, O.S.L. 2013 (40 O.S. Supp. 2013,
22 Section 2-203), is amended to read as follows:

23 Section 2-203. CLAIM.
24

1 A. An unemployed individual must file an initial claim for
2 unemployment benefits by calling an Oklahoma Employment Security
3 Commission claims representative in a Commission Call Center, by
4 completing the required forms through the Internet Claims service
5 provided by the Commission, or by completing all forms necessary to
6 process an initial claim in a local office of the Commission or any
7 alternate site designated by the Commission to take unemployment
8 benefit claims. The Commission may obtain additional information
9 regarding an individual's claim through any form of
10 telecommunication, writing, or interview. An unemployed individual
11 must file a claim in writing or by telecommunication for benefits
12 with respect to each week in accordance with such rule as the
13 Commission may prescribe.

14 B. During the process of filing an initial claim for
15 unemployment benefits, the claimant shall be made aware of the
16 definition of misconduct set out in Section 2-406 of this title, and
17 the claimant shall affirmatively certify that the answers given to
18 all questions in the initial claim process are true and correct to
19 the best of the claimant's knowledge and that no information has
20 been intentionally withheld or misrepresented in an attempt by the
21 claimant to receive benefits to which he or she is not entitled.

22 C. With respect to each week, he or she must provide the
23 Commission with a true and correct statement of all material facts
24 relating to: his or her unemployment; ability to work; availability

1 for work; activities or conditions which could restrict the
2 individual from seeking or accepting full-time employment
3 immediately; applications for or receipt of workers' compensation
4 benefits; employment and earnings; and the reporting of other income
5 from retirement, pension, disability, self-employment, education or
6 training allowances.

7 D. No claim will be allowed or paid unless the claimant resides
8 within a state or foreign country with which the State of Oklahoma
9 has entered into a reciprocal or cooperative arrangement pursuant to
10 Part 7 of Article IV of the Employment Security Act of 1980.

11 E. The Commission may require the individual to produce
12 documents or information relevant to the claim for benefits. If the
13 individual ~~has the ability to produce the documents or information~~
14 ~~and~~ fails to produce it, the individual's claim for unemployment
15 benefits may be disqualified indefinitely by the Commission until
16 the information is produced. The Commission may require the
17 individual to personally appear at a location for a purpose relevant
18 to the individual's unemployment claim or job search. If the
19 individual fails to appear, the individual's claim for unemployment
20 benefits may be disqualified indefinitely by the Commission until
21 the individual makes a personal appearance as directed. An
22 individual that has been disqualified indefinitely by the provisions
23 of this subsection may receive payment for any week between the
24 initial failure and the compliance with this subsection if the

1 claimant is otherwise eligible and has made a timely filing for each
2 intervening week.

3 SECTION 8. REPEALER 40 O.S. 2011, Section 2-203, as

6 SECTION 9. AMENDATORY 47 O.S. 2011, Section 11-1116, as
7 amended by Section 1, Chapter 238, O.S.L. 2013 (47 O.S. Supp. 2013,
8 Section 11-1116), is amended to read as follows:

9 Section 11-1116. A. The self-propelled or motor-driven and
10 operated vehicles described in this section shall be prohibited from
11 operating or shall be limited in operation on the streets and
12 highways of this state.

13 B. Self-propelled or motor-driven cycles, known and commonly
14 referred to as "minibikes" and other similar trade names, shall be
15 prohibited from operating on the streets and highways of this state,
16 except:

17 1. When used in a parade; or

18 2. When registered, as required by subsection E of Section 1151
19 of this title, and operated in this state by food vendor services
20 upon streets having a speed limit of thirty (30) miles per hour or
21 less.

22 All minibikes offered for sale in this state shall bear the
23 following notice to the customer: "This machine is not manufactured
24 or sold for operation on the public streets or highways. Since it

1 is not provided with equipment required by law for street or highway
2 use, all persons are cautioned that any operation of this vehicle
3 upon a public street or highway will be in violation of the motor
4 vehicle laws of this state and will subject the violator to arrest."

5 C. Golf carts and utility vehicles, as defined by Section 1102
6 of this title, shall not be operated on the streets and highways of
7 this state except:

8 1. Golf carts or utility vehicles owned by the Oklahoma Tourism
9 and Recreation Department, and operated by employees or agents of
10 the Department or employees of independent management companies
11 working on behalf of the Department, may be operated on the streets
12 and highways of this state during daylight hours or under rules
13 developed by the Oklahoma Tourism and Recreation Commission, when
14 the streets and highways are located within the boundaries of a
15 state park. The Department shall have warning signs placed at the
16 entrance and other locations at those state parks allowing golf
17 carts or utility vehicles to be operated on the streets and highways
18 of this state located within the boundaries of those state parks.
19 The warning signs shall state that golf carts and utility vehicles
20 may be operating on streets and highways and that motor vehicle
21 operators shall take special precautions to be alert for the
22 presence of golf carts or utility vehicles on the streets and
23 highways;

1 2. The municipal governing body has adopted an ordinance
2 governing the operation of golf carts and/or utility vehicles on
3 city streets; provided, such ordinances shall include necessary
4 vehicle lighting and safety requirements;

5 3. Golf carts or utility vehicles may operate on state highways
6 only if making a perpendicular crossing of a state highway located
7 within the boundaries of a municipality which has adopted an
8 ordinance governing the operation of golf carts and/or utility
9 vehicles; or

10 4. The board of county commissioners of a county has approved
11 the operation of golf cart and/or utility vehicle traffic on
12 roadways within the county, and:

13 a. the roadway has a posted speed limit of twenty-five
14 (25) miles per hour or less,

15 b. the roadway is located in an unincorporated area, and

16 c. appropriate signage, cautioning motorists of the
17 possibility of golf cart or utility vehicle traffic,
18 is erected by the board of county commissioners.

19 D. All-terrain vehicles shall not be operated on the streets
20 and highways of this state, except:

21 1. On unpaved roads which are located within the boundaries of
22 any property of the Forest Service of the United States Department
23 of Agriculture;

24 2. On public streets and highways if:

- 1 a. the vehicle needs to make a direct crossing of the
2 street or highway while the vehicle is traveling upon
3 a regularly traveled trail and needs to continue
4 travel from one area of the trail to another and, if
5 the vehicle comes to a complete stop, yields the
6 right-of-way to all oncoming traffic that constitutes
7 an immediate hazard, and crosses the street or highway
8 at an angle of approximately ninety (90) degrees to
9 the direction of the street or highway. This
10 exception shall not apply to divided highways or
11 streets or highways with a posted speed limit of more
12 than thirty-five (35) miles per hour in the area of
13 the crossing,
- 14 b. the vehicle needs to travel on a public street or
15 highway in order to cross a railroad track. In that
16 event, the all-terrain vehicle may travel for not more
17 than three hundred (300) feet on a public street or
18 highway to cross a railroad track,
- 19 c. the operator of the all-terrain vehicle making the
20 crossing at a street or highway has a valid driver
21 license, and
- 22 d. the operator of the vehicle makes a crossing on a
23 street or highway during daylight hours only; and
24

1 3. On streets and highways within a municipality if the
2 municipal governing body has adopted an ordinance governing the
3 operation of golf carts, utility vehicles or all-terrain vehicles on
4 streets and highways within the municipality; or

5 4. On roadways within unincorporated areas of a county if the
6 board of county commissioners of the county has approved the
7 operation of all-terrain vehicles on roadways within unincorporated
8 areas of the county and the all-terrain vehicle is only used as an
9 instrument of husbandry.

10 SECTION 10. REPEALER 47 O.S. 2011, Section 11-1116, as

13 SECTION 11. AMENDATORY 47 O.S. 2011, Section 583, as
14 amended by Section 2, Chapter 145, O.S.L. 2013 (47 O.S. Supp. 2013,
15 Section 583), is amended to read as follows:

16 Section 583. A. 1. It shall be unlawful and constitute a
17 misdemeanor for any person to engage in business as, or serve in the
18 capacity of, or act as a used motor vehicle dealer, used motor
19 vehicle salesperson, wholesale used motor vehicle dealer,
20 manufactured home dealer, restricted manufactured home park dealer,
21 manufactured home salesperson, manufactured home installer, or
22 manufactured home manufacturer selling directly to a licensed
23 manufactured home dealer in this state without first obtaining a
24

1 license or following other requirements therefor as provided in this
2 section.

3 2. a. Any person engaging, acting, or serving in the
4 capacity of a used motor vehicle dealer and/or a used
5 motor vehicle salesperson, a manufactured home dealer,
6 restricted manufactured home park dealer, manufactured
7 home salesperson, a manufactured home installer, or a
8 manufactured home manufacturer, or having more than
9 one place where any such business, or combination of
10 businesses, is carried on or conducted shall be
11 required to obtain and hold a current license for each
12 such business, in which engaged.

13 b. A used motor vehicle dealer's license shall authorize
14 one person to sell without a salesperson's license in
15 the event such person shall be the owner of a
16 proprietorship, or the person designated as principal
17 in the dealer's franchise or the managing officer or
18 one partner if no principal person is named in the
19 franchise.

20 c. If after a hearing in accordance with the provisions
21 of Section 585 of this title, the Oklahoma Used Motor
22 Vehicle and Parts Commission shall find any person
23 installing a mobile or manufactured home to be in
24 violation of any of the provisions of this act, such

1 person may be subject to an administrative fine of not
2 more than Five Hundred Dollars (\$500.00) for each
3 violation. Each day a person is in violation of this
4 act may constitute a separate violation. The maximum
5 fine shall not exceed One Thousand Dollars
6 (\$1,000.00). All administrative fines collected
7 pursuant to the provisions of this subparagraph shall
8 be deposited in the fund established in Section 582 of
9 this title. Administrative fines imposed pursuant to
10 this subparagraph may be enforceable in the district
11 courts of this state.

12 d. A salesperson's license may not be issued under a
13 wholesale used motor vehicle dealer's license.

14 3. Any person except persons penalized by administrative fine
15 violating the provisions of this section shall, upon conviction, be
16 fined not to exceed Five Hundred Dollars (\$500.00). A second or
17 subsequent conviction shall be punished by a fine not to exceed One
18 Thousand Dollars (\$1,000.00); provided that each day such unlicensed
19 person violates this section shall constitute a separate offense,
20 and any vehicle involved in a violation of this subsection shall be
21 considered a separate offense.

22 B. 1. Applications for licenses required to be obtained under
23 provisions of this act, Section 581 et seq. of this title, which
24 creates the Oklahoma Used Motor Vehicle and Parts Commission shall

1 be verified by the oath or affirmation of the applicant and shall be
2 on forms prescribed by the Commission and furnished to the
3 applicants, and shall contain such information as the Commission
4 deems necessary to enable it to fully determine the qualifications
5 and eligibility of the several applicants to receive the license or
6 licenses applied for. The Commission shall require in the
7 application, or otherwise, information relating to:

- 8 a. the applicant's financial standing,
- 9 b. the applicant's business integrity,
- 10 c. whether the applicant has an established place of
11 business and is engaged in the pursuit, avocation, or
12 business for which a license, or licenses, is applied
13 for,
- 14 d. whether the applicant is able to properly conduct the
15 business for which a license, or licenses, is applied
16 for, and
- 17 e. such other pertinent information consistent with the
18 safeguarding of the public interest and the public
19 welfare.

20 2. All applications for license or licenses shall be
21 accompanied by the appropriate fee or fees in accordance with the
22 schedule hereinafter provided. In the event any application is
23 denied and the license applied for is not issued, the entire license
24 fee shall be returned to the applicant.

1 3. All bonds and licenses issued under the provisions of this
2 act shall expire on December 31, following the date of issue and
3 shall be nontransferable. All applications for renewal of licenses
4 should be submitted by November 1 of each year, and licenses shall
5 be issued by January 10. If applications have not been made for
6 renewal of licenses, such licenses shall expire on December 31 and
7 it shall be illegal for any person to represent himself or herself
8 and act as a dealer thereafter. Tag agents shall be notified not to
9 accept dealers' titles until such time as licenses have been issued.

10 4. A used motor vehicle salesperson's license shall permit the
11 licensee to engage in the activities of a used motor vehicle
12 salesperson. Salespersons shall not be allowed to sell vehicles
13 unless applications, ~~bonds~~, and fees are on file with the Commission
14 and the motor vehicle salesperson's or temporary salesperson's
15 license issued. A temporary salesperson's license, salesperson's
16 renewal or reissue of salesperson's license shall be deemed to have
17 been issued when the appropriate application, ~~bond~~, and fee have
18 been properly addressed and mailed to the Commission.

19 Dealers' payrolls and other evidence will be checked to
20 ascertain that all salespersons for such dealers are licensed.

21 C. The schedule of license fees to be charged and received by
22 the Commission for the licenses issued hereunder shall be as
23 follows:
24

1 1. For each used motor vehicle dealer's license and each
2 wholesale used motor vehicle dealer's license, Three Hundred Dollars
3 (\$300.00). If a used motor vehicle dealer or a wholesale used motor
4 vehicle dealer has once been licensed by the Commission in the
5 classification for which he or she applies for a renewal of the
6 license, the fee for each subsequent renewal shall be One Hundred
7 Fifty Dollars (\$150.00); provided, if an applicant holds a license
8 to conduct business as an automotive dismantler and parts recycler
9 issued pursuant to Section 591.1 et seq. of this title, the initial
10 fee shall be One Hundred Dollars (\$100.00) and the renewal fee shall
11 be One Hundred Dollars (\$100.00). If an applicant is applying
12 simultaneously for a license under this paragraph and a license
13 under paragraph 1 of Section 591.5 of this title, the initial
14 application fee shall be Two Hundred Dollars (\$200.00). For the
15 reinstatement of a used motor vehicle dealer's license after
16 revocation for cancellation or expiration of insurance pursuant to
17 subsection F of this section, the fee shall be One Hundred Dollars
18 (\$100.00);

19 2. For a used motor vehicle dealer's license, for each place of
20 business in addition to the principal place of business, One Hundred
21 Dollars (\$100.00);

22 3. For each used motor vehicle salesperson's license and
23 renewal, Twenty-five Dollars (\$25.00), and for a transfer, Twenty-
24 five Dollars (\$25.00);

1 4. For each holder who possesses a valid new motor vehicle
2 dealer's license from the Oklahoma Motor Vehicle Commission, One
3 Hundred Dollars (\$100.00) shall be the initial fee for a used motor
4 vehicle license and the fee for each subsequent renewal shall be One
5 Hundred Dollars (\$100.00);

6 5. a. For each manufactured home dealer's license or a
7 restricted manufactured home park dealer's license,
8 Three Hundred Dollars (\$300.00), and for each place of
9 business in addition to the principal place of
10 business, Two Hundred Dollars (\$200.00), and

11 b. For each renewal of a manufactured home dealer's
12 license or a restricted manufactured home park
13 dealer's license, and renewal for each place of
14 business in addition to the principal place of
15 business, One Hundred Fifty Dollars (\$150.00);

16 6. a. For each manufactured home installer's license, Two
17 Hundred Dollars (\$200.00), and

18 b. For each renewal of a manufactured home installer's
19 license, Two Hundred Dollars (\$200.00);

20 7. a. For each manufactured home manufacturer selling
21 directly to a licensed manufactured home dealer in
22 this state, Seven Hundred Fifty Dollars (\$750.00), and

23 b. For each renewal of a manufactured home manufacturer's
24 license, Seven Hundred Fifty Dollars (\$750.00); and

1 8. For each manufactured home salesperson's license or renewal
2 thereof, Twenty-five Dollars (\$25.00), and for each transfer,
3 Twenty-five Dollars (\$25.00).

4 D. 1. The license issued to each used motor vehicle dealer,
5 each wholesale used motor vehicle dealer, each restricted
6 manufactured home park dealer and each manufactured home dealer
7 shall specify the location of the place of business. If the
8 business location is changed, the Oklahoma Used Motor Vehicle and
9 Parts Commission shall be notified immediately of the change and the
10 Commission may endorse the change of location on the license. The
11 fee for a change of location shall be One Hundred Dollars (\$100.00),
12 and the fee for a change of name, Twenty-five Dollars (\$25.00). The
13 license of each licensee shall be posted in a conspicuous place in
14 the place or places of business of the licensee.

15 2. The license issued to each manufactured home installer, and
16 each manufactured home manufacturer shall specify the location of
17 the place of business. If the business location is changed, the
18 Oklahoma Used Motor Vehicle and Parts Commission shall be notified
19 immediately of the change and the Commission may endorse the change
20 of location on the license without charge. The license of each
21 licensee shall be posted in a conspicuous place in the place or
22 places of business of the licensee.

23 3. Every used motor vehicle salesperson shall have the license
24 upon his or her person when engaged in business, and shall display

1 same upon request. The name of the employer of the salesperson
2 shall be stated on the license and if there is a change of employer,
3 the license holder shall immediately mail the license to the
4 Commission for its endorsement of the change thereon. There shall
5 be no charge for endorsement of change of employer on the license or
6 penalty for not having a license upon his or her person.

7 4. Every manufactured home installer shall have the license
8 available for inspection at the primary place of business of the
9 licensee. This license shall be valid for the licensee and all of
10 the employees of the licensee. Any person who is not an employee of
11 the licensee must obtain a separate manufactured home installer
12 license regardless of whether such person is acting in the capacity
13 of a contractor or subcontractor.

14 E. 1. a. Each applicant for a used motor vehicle dealer's
15 license shall procure and file with the Commission a
16 good and sufficient bond in the amount of ~~Fifteen~~
17 ~~Thousand Dollars (\$15,000.00)~~ Twenty-five Thousand
18 Dollars (\$25,000.00). Each new applicant for a used
19 motor vehicle dealer's license for the purpose of
20 conducting a used motor vehicle auction shall procure
21 and file with the Commission a good and sufficient
22 bond in the amount of Fifty Thousand Dollars
23 (\$50,000.00). An applicant who intends to conduct a
24 used motor vehicle auction who provides proof that the

1 applicant has check and title insurance in an amount
2 not less than Fifty Thousand Dollars (\$50,000.00)
3 shall only be required to have a bond in the amount of
4 Twenty-five Thousand Dollars (\$25,000.00).

5 b. Each new applicant for a used motor vehicle dealer
6 license for the purpose of conducting a used motor
7 vehicle business which will consist primarily of non-
8 auction consignment sales which are projected to equal
9 Five Hundred Thousand Dollars (\$500,000.00) or more in
10 gross annual sales shall procure and file with the
11 Commission a good and sufficient bond in the amount of
12 Fifty Thousand Dollars (\$50,000.00). The Commission
13 shall prescribe by rule the method of operation of the
14 non-auction consignment dealer in order to properly
15 protect the interests of all parties to the
16 transaction and to provide sanctions against dealers
17 who fail to comply with the rules.

18 c. Each applicant for a wholesale used motor vehicle
19 dealer's license shall procure and file with the
20 Commission a good and sufficient bond in the amount of
21 Twenty-five Thousand Dollars (\$25,000.00).

22 d. Any used motor vehicle dealer who, for the purpose of
23 being a rebuilder, applies for a rebuilder
24 certificate, as provided in Section 591.5 of this

1 title, whether as a new application or renewal, shall
2 procure and file with the Commission a good and
3 sufficient bond in the amount of Fifteen Thousand
4 Dollars (\$15,000.00), in addition to any other bonds
5 required.

6 e. Each applicant for a manufactured home dealer's
7 license or a restricted manufactured home park
8 dealer's license shall procure and file with the
9 Commission a good and sufficient bond in the amount of
10 Thirty Thousand Dollars (\$30,000.00).

11 f. Each manufactured home manufacturing facility selling
12 directly to a licensed manufactured home dealer in
13 this state shall procure and file with the Commission
14 a good and sufficient bond in the amount of Thirty
15 Thousand Dollars (\$30,000.00). In addition to all
16 other conditions and requirements set forth herein,
17 the bond shall require the availability of prompt and
18 full warranty service by the manufacturer to comply
19 with all warranties expressed or implied in connection
20 with each manufactured home which is manufactured for
21 resale in this state. A manufacturer may not sell,
22 exchange, or lease-purchase a manufactured home to a
23 person in this state who is not a licensed
24 manufactured home dealer.

1 g. The bond shall be approved as to form by the Attorney
2 General and conditioned that the applicant shall not
3 practice fraud, make any fraudulent representation, or
4 violate any of the provisions of this act in the
5 conduct of the business for which the applicant is
6 licensed. One of the purposes of the bond is to
7 provide reimbursement for any loss or damage suffered
8 by any person by reason of issuance of a certificate
9 of title by a used motor vehicle dealer, a wholesale

22 4. The bonds as required by this section shall be maintained
23 throughout the period of licensure. Should the bond be canceled for
24

1 any reason, the license shall be revoked as of the date of
2 cancellation unless a new bond is furnished prior to such date.

3 F. Any used motor vehicle dealer or wholesale used motor
4 vehicle dealer is required to furnish and keep in force a minimum of
5 Twenty-five Thousand Dollars (\$25,000.00) of single liability
6 insurance coverage on all vehicles offered for sale or used in any
7 other capacity in demonstrating or utilizing the streets and
8 roadways in accordance with the financial responsibility laws of
9 this state.

10 G. Any manufactured home dealer or restricted manufactured home
11 park dealer is required to furnish and keep in force a minimum of
12 One Hundred Thousand Dollars (\$100,000.00) of garage liability or
13 general liability with products and completed operations insurance
14 coverage.

15 H. Any manufactured home installer is required to furnish and
16 keep in force a minimum of Twenty-five Thousand Dollars (\$25,000.00)
17 of general liability with products and completed operations
18 insurance coverage.

1 SECTION 14. AMENDATORY 47 O.S. 2011, Section 1135.3, as
2 last amended by Section 3, Chapter 365, O.S.L. 2013 (47 O.S. Supp.
3 2013, Section 1135.3), is amended to read as follows:

4 Section 1135.3. A. The Oklahoma Tax Commission is hereby
5 authorized to design and issue appropriate official special license
6 plates to persons wishing to demonstrate support, interest, or
7 membership to or for an organization, occupation, cause or other
8 subject as provided by this section.

9 Special license plates shall not be transferred to any other
10 person but shall be removed from the vehicle upon transfer of
11 ownership and retained. The special license plate may then be used
12 on another vehicle but only after such other vehicle has been
13 registered for the current year.

14 Special license plates shall be renewed each year by the Tax
15 Commission or a motor license agent. The Tax Commission shall
16 annually notify by mail all persons issued special license plates.
17 The notice shall contain all necessary information and shall contain
18 instructions for the renewal procedure upon presentation to a motor
19 license agent or the Tax Commission. The license plates shall be
20 issued on a staggered system.

21 The Tax Commission is hereby directed to develop and implement a
22 system whereby motor license agents are permitted to accept
23 applications for special license plates authorized under this
24 section. The motor license agent shall confirm the applicant's

1 eligibility, if applicable, collect and deposit any amount
2 specifically authorized by law, accept and process the necessary
3 information directly into such system and generate a receipt
4 accordingly. For performance of these duties, motor license agents
5 shall retain the fee provided in Section 1141.1 of this title for
6 registration of a motor vehicle. The motor license agent fees for
7 acceptance of applications and renewals shall be paid out of the
8 Oklahoma Tax Commission Reimbursement Fund.

9 If fewer than one hundred of any type of special license plates
10 authorized prior to January 1, 2004, are issued prior to January 1,
11 2006, the Tax Commission shall discontinue issuance and renewal of
12 that type of special license plate. Any such authorized special
13 license plate registrant shall be allowed to display the license
14 plate upon the designated vehicle until the registration expiration
15 date. After such time the expired special license plate shall be
16 removed from the vehicle.

17 Except as otherwise provided in this section, for special
18 license plates authorized on or after July 1, 2004, no special
19 license plates shall be developed or issued by the Tax Commission
20 until the Commission receives one hundred (100) prepaid applications
21 therefor. The prepaid applications must be received by the Tax
22 Commission within one hundred eighty (180) days of the effective
23 date of the authorization or the authority to issue shall be null
24 and void. In the event one hundred (100) prepaid applications are

1 not received by the Tax Commission within such prescribed time
2 period any payment so received shall be refunded accordingly.

4 Plates - such plates shall be designed to demonstrate support for

7 Temple in Oklahoma. The license plate shall be designed in
8 consultation with the Shriner's Temples in Oklahoma and shall
9 contain the Shriner's emblem;

10 6. Balloonists License Plate - such plates shall be designed
11 and issued to any person wishing to demonstrate support for hot air
12 ballooning in this state;

13 7. Order of the Eastern Star License Plates - such plates shall
14 be designed and issued to any resident of this state who is a member
15 of an Order of the Eastern Star. Such persons may apply for an
16 Order of the Eastern Star license plate for each vehicle with a
17 rated carrying capacity of one (1) ton or less upon proof of an
18 Order of the Eastern Star membership or upon the presentment of an
19 application for an Order of the Eastern Star license plate
20 authorized and approved by the organization. The license plate
21 shall be designed in consultation with the Order of the Eastern Star
22 and shall contain the Order of the Eastern Star emblem;

23 8. Knights of Columbus License Plates - such plates shall be
24 designed and issued to any resident of this state who is a member of

1 the Knights of Columbus. Such persons may apply for a Knights of
2 Columbus license plate for each vehicle with a rated carrying
3 capacity of one (1) ton or less upon proof of a Knights of Columbus
4 membership or upon the presentment of an application for a Knights
5 of Columbus license plate authorized and approved by the
6 organization. The license plate shall be designed in consultation
7 with the Knights of Columbus and shall contain the Knights of
8 Columbus emblem;

9 9. Jaycees License Plates - such plates shall be designed and
10 issued to members of the Jaycees. Persons applying for such license
11 plate must show proof of membership in the Jaycees. The license
12 plates shall be designed in consultation with the Jaycees;

13 10. Ducks Unlimited License Plates - such plates shall be
14 designed and issued to members of Ducks Unlimited. Persons applying
15 for and renewing such license plates must show proof of tag
16 membership in Ducks Unlimited. The license plates shall be designed

19 designed and issued to members of Kiwanis International. Persons
20 applying for such license plate must show proof of membership in

4 shall be designed to include the original Oklahoma state flag and
5 issued to any person wishing to demonstrate support for the original
6 Oklahoma state flag. The plates shall be designed in consultation
7 with the Friends of the Oklahoma History Center; and

8 68. Tulsa 66ers License Plate - such plates shall be designed
9 and issued to any person wishing to demonstrate support for the
10 Tulsa 66ers. The plates shall be designed in consultation with the
11 Tulsa 66ers Organization.

12 C. The fee for such plates shall be Fifteen Dollars (\$15.00)
13 and shall be in addition to all other registration fees provided by
14 the Oklahoma Vehicle License and Registration Act. Unless otherwise
15 provided in this section, the fee shall be apportioned as follows:
16 Eight Dollars (\$8.00) of the special license plate fee shall be
17 deposited in the Oklahoma Tax Commission Reimbursement Fund to be
18 used for the administration of the Oklahoma Vehicle License and
19 Registration Act and the remaining Seven Dollars (\$7.00) of the
20 special license plate fee shall be apportioned as provided in
21 Section 1104 of this title.

22 SECTION 15. REPEALER 47 O.S. 2011, Section 1135.3, as
23 last amended by Section 2, Chapter 229, O.S.L. 2013 (47 O.S. Supp.
24 2013, Section 1135.3), is hereby repealed.

1 SECTION 16. AMENDATORY 59 O.S. 2011, Section 199.2, as
2 amended by Section 86, Chapter 229, O.S.L. 2013 (59 O.S. Supp. 2013,
3 Section 199.2), is amended to read as follows:

4 Section 199.2. A. 1. There is hereby re-created, to continue
5 until July 1, ~~2013~~ 2017, in accordance with the provisions of the
6 Oklahoma Sunset Law, a State Board of Cosmetology and Barbering
7 which shall be composed of eleven (11) members to be appointed by
8 the Governor and to serve at the pleasure of the Governor.

9 2. One member shall be appointed from each congressional
10 district and the additional members shall be appointed at large.
11 However, when congressional districts are redrawn each member
12 appointed prior to July 1 of the year in which such modification
13 becomes effective shall complete the current term of office and
14 appointments made after July 1 of the year in which such
15 modification becomes effective shall be based on the redrawn
16 districts. Appointments made after July 1 of the year in which such
17 modification becomes effective shall be from any redrawn districts
18 which are not represented by a board member until such time as each
19 of the modified congressional districts are represented by a board
20 member. One member shall be a barber appointed at-large.

21 3. At the time of appointment, the members shall be citizens of
22 this state, at least twenty-five (25) years of age, and shall be
23 high school graduates. Eight members shall, at the time of
24 appointment, have had at least five (5) years' continuous practical

1 experience in the practice of cosmetology or barbering in this
2 state, one member shall be a lay person, one member shall be an
3 administrator of a licensed private cosmetology school, one member
4 shall be an administrator of a licensed barber school, and one
5 member shall be an administrator of a public school licensed to
6 teach cosmetology.

7 4. No two members shall be graduates of the same cosmetology
8 school, nor shall they be organizers of or promote the organization
9 of any cosmetic, beauty, or hairdressers' association. Each of the
10 eight cosmetology appointees shall continue to be actively engaged
11 in the profession of cosmetology while serving. No two members
12 engaged in the profession of barbering shall be organizers of or
13 promote the organization of any barbering association. Each of the
14 four barbering appointees shall continue to be actively engaged in
15 the profession of barbering while serving.

16 5. If any member retires or ceases to practice his or her
17 profession during the term of membership on the Board, such terms
18 shall automatically cease and the Governor shall appoint a like-
19 qualified person to fulfill the remainder of the term.

20 B. The terms of office for Board members shall be four (4)
21 years ending June 30.

22 C. Each member shall serve until a successor is appointed and
23 qualified.
24

1 D. Six members of the Board shall constitute a quorum for the
2 transaction of business.

3 E. The Governor may remove any member of the Board at any time
4 at the Governor's discretion. Vacancies shall be filled by
5 appointment by the Governor for the unexpired portion of the term.

6 F. The Board shall organize by electing from its membership a
7 chair and vice-chair, each to serve for a period of one (1) year.
8 The presiding officer shall not be entitled to vote upon any
9 question except in the case of a tie vote.

10 Members shall be reimbursed for their actual and necessary
11 traveling expenses as provided by the State Travel Reimbursement
12 Act.

13 G. Within thirty (30) days after the end of each fiscal year,
14 the Board shall make a full report to the Governor of all its
15 receipts and expenditures, and also a full statement of its work
16 during the year, together with such recommendations as the Board
17 deems expedient.

18 H. The Board may expend funds for suitable office space for the
19 transaction of its business. The Board shall adopt a common seal
20 for the use of the executive director in authenticating Board
21 documents.

22 I. The Board shall meet at its office for the transaction of
23 such business as may come before it on the second Monday in January,
24

1 March, May, July, September, and November and at such other times as
2 it may deem advisable.

3 SECTION 17. REPEALER 59 O.S. 2011, Section 199.2, as
4 amended by Section 1, Chapter 298, O.S.L. 2013 (59 O.S. Supp. 2013,

6 SECTION 18. AMENDATORY 63 O.S. 2011, Section 2-309D, as
7 amended by Section 1, Chapter 162, O.S.L. 2013 (63 O.S. Supp. 2013,
8 Section 2-309D), is amended to read as follows:

9 Section 2-309D. A. The information collected at the central
10 repository pursuant to the Anti-Drug Diversion Act shall be
11 confidential and shall not be open to the public. Access to the
12 information shall be limited to:

13 1. Peace officers certified pursuant to Section 3311 of Title
14 70 of the Oklahoma Statutes who are employed as investigative agents
15 of the Oklahoma State Bureau of Narcotics and Dangerous Drugs
16 Control;

17 2. The United States Drug Enforcement Administration Diversion
18 Group Supervisor;

19 3. The executive director or chief investigator, as designated
20 by each board, of the following state boards:

21 a. Board of Podiatric Medical Examiners,

22 b. Board of Dentistry,

23 c. State Board of Pharmacy,

24 d. State Board of Medical Licensure and Supervision,

- e. State Board of Osteopathic Examiners,
- f. State Board of Veterinary Medical Examiners,
- g. Oklahoma Health Care Authority,
- h. Department of Mental Health and Substance Abuse Services, and
- i. State Board of Health;

provided, however, that the executive director or chief investigator of each of these boards shall be limited to access to information relevant to licensees of the employing board of such executive director or chief investigator;

4. A multicounty grand jury properly convened pursuant to the Multicounty Grand Jury Act; and

5. The Department of Mental Health and Substance Abuse Services and the State Department of Health for statistical, research, substance abuse prevention or educational purposes provided that the consumer's confidentiality is not compromised.

B. This section shall not prevent ~~the disclosure~~ access, at the discretion of the Director of the Oklahoma Bureau of Narcotics and Dangerous Drugs Control, ~~of~~ to investigative information ~~to~~ by peace officers and investigative agents of federal, state, county or municipal law enforcement agencies, district attorneys and the Attorney General in furtherance of criminal investigations or prosecutions within their respective jurisdictions, and to

1 registrants in furtherance of efforts to guard against the diversion
2 of controlled dangerous substances.

3 C. This section shall not prevent the disclosure, at the
4 discretion of the Director of the Oklahoma State Bureau of Narcotics
5 and Dangerous Drugs Control, of statistical information gathered
6 from the central repository to the general public which shall be
7 limited to types and quantities of controlled substances dispensed
8 and the county where dispensed.

9 D. Any unauthorized disclosure of any information collected at
10 the central repository provided by the Anti-Drug Diversion Act shall
11 be a misdemeanor. Violation of the provisions of this section shall
12 be deemed willful neglect of duty and shall be grounds for removal
13 from office.

14 E. Notwithstanding the provisions of subsection B of this
15 section, registrants shall have no requirement or obligation to
16 access or check the information in the central repository prior to
17 dispensing or administering medications or as part of their
18 professional practices. Registrants shall not be liable to any
19 person for any claim of damages as a result of accessing or failing
20 to access the information in the central repository and no lawsuit
21 may be predicated thereon. Nothing herein shall be construed to
22 relieve a registrant from any duty to monitor and report the sales
23 of certain products pursuant to subsection E of Section 2-309C of
24 this title.

1 F. Information regarding nonfatal overdoses, other than
2 statistical information as required by Section 2-106 of this title,
3 shall be completely confidential. Access to this information shall
4 be strictly limited to the Director of the Oklahoma State Bureau of
5 Narcotics and Dangerous Drugs Control or designee, the Chief Medical
6 Examiner, and the registrant that enters the information.
7 Registrants shall not be liable to any person for a claim of damages
8 for information reported pursuant to the provisions of Section 2-105
9 of this title.

10 SECTION 19. REPEALER 63 O.S. 2011, Section 2-309D, as
11 amended by Section 5, Chapter 181, O.S.L. 2013 (63 O.S. Supp. 2013,
12 Section 2-309D), is hereby repealed.

13 SECTION 20. AMENDATORY 68 O.S. 2011, Section 2817, as
14 amended by Section 1, Chapter 158, O.S.L. 2013 (68 O.S. Supp. 2013,
15 Section 2817), is amended to read as follows:

16 Section 2817. A. All taxable personal property, except
17 intangible personal property, personal property exempt from ad
18 valorem taxation, or household personal property, shall be listed
19 and assessed each year at its fair cash value, estimated at the
20 price it would bring at a fair voluntary sale, as of January 1.

21 The fair cash value of household personal property shall be
22 valued at ten percent (10%) of the appraised value of the
23 improvement to the residential real property within which such
24 personal property is located as of January 1 each year. The

1 assessment of household personal property as provided by this
2 section may be altered by the taxpayer listing such property at its
3 actual fair cash value. For purposes of establishing the value of
4 household personal property, pursuant to the requirement of Section
5 8 of Article X of the Oklahoma Constitution, the percentage of value
6 prescribed by this section for the household personal property shall
7 be presumed to constitute the fair cash value of the personal
8 property.

9 All unmanufactured farm products shall be assessed and valued as
10 of the preceding May 31. Every person, firm, company, association,
11 or corporation, in making the assessment, shall assess all
12 unmanufactured farm products owned by the person, firm, company,
13 association or corporation on the preceding May 31, at its fair cash
14 value on that date instead of January 1.

15 Stocks of goods, wares and merchandise shall be assessed at the
16 value of the average amount on hand during the preceding year, or
17 the average amount on hand during the part of the preceding year the
18 stock of goods, wares or merchandise was at its January 1 location.

19 B. All taxable real property shall be assessed annually as of
20 January 1, at its fair cash value, estimated at the price it would
21 bring at a fair voluntary sale for:

22 1. The highest and best use for which the property was actually
23 used during the preceding calendar year; or
24

1 2. The highest and best use for which the property was last
2 classified for use if not actually used during the preceding
3 calendar year.

4 When improvements upon residential real property are divided by
5 a taxing jurisdiction line, those improvements shall be valued and
6 assessed in the taxing jurisdiction in which the physical majority
7 of those improvements are located.

8 The Ad Valorem Division of the Oklahoma Tax Commission shall be
9 responsible for the promulgation of rules which shall be followed by
10 each county assessor of the state, for the purposes of providing for
11 the equitable use valuation of locally assessed real property in
12 this state. Agricultural land and nonresidential improvements
13 necessary or convenient for agricultural purposes shall be assessed
14 for ad valorem taxation based upon the highest and best use for
15 which the property was actually used, or was previously classified
16 for use, during the calendar year next preceding January 1 on which
17 the assessment is made.

18 C. The use value of agricultural land shall be based on the
19 income capitalization approach using cash rent. The rental income
20 shall be calculated using the direct capitalization method based
21 upon factors including, but not limited to:

22 1. Soil types, as depicted on soil maps published by the
23 Natural Resources Conservation Service of the United States
24 Department of Agriculture;

1 2. Soil productivity indices approved by the Ad Valorem
2 Division of the Tax Commission;

3 3. The specific agricultural purpose of the soil based on use
4 categories approved by the Ad Valorem Division of the Tax
5 Commission; and

6 4. A capitalization rate to be determined annually by the Ad
7 Valorem Division of the Tax Commission based on the sum of the
8 average first mortgage interest rate charged by the Federal Land
9 Bank for the immediately preceding five (5) years, weighted with the
10 prevailing rate or rates for additional loans or equity, and the
11 effective tax rate.

12 The final use value will be calculated using the soil
13 productivity indices and the agricultural use classification as
14 defined by rules promulgated by the State Board of Equalization.
15 This subsection shall not be construed in a manner which is
16 inconsistent with the duties, powers and authority of the Board as
17 to valuation of the counties as fixed and defined by Section 21 of
18 Article X of the Oklahoma Constitution.

19 However, in calculating the use value of buffer strips as
20 defined in Section 2817.2 of this title, exclusive consideration
21 shall be based only on income from production agriculture from such
22 buffer strips, not including federal or state subsidies, when valued
23 as required by subsection C of Section 2817.2 of this title.

1 D. The use value of nonresidential improvements on agricultural
2 land shall be based on the cost approach to value estimation using
3 currently updated cost manuals published by the Marshall and Swift
4 Company or similar cost manuals approved by the Ad Valorem Division
5 of the Tax Commission. The use value estimates for the
6 nonresidential improvements shall take obsolescence and depreciation
7 into consideration in addition to necessary adjustments for local
8 variations in the cost of labor and materials. This section shall
9 not be construed in a manner which is inconsistent with the duties,
10 powers and authority of the Board as to equalization of valuation of
11 the counties as determined and defined by Section 21 of Article X of
12 the Oklahoma Constitution.

13 The use value of facilities used for poultry production shall be
14 determined according to the following procedures:

15 1. The Ad Valorem Division of the Tax Commission is hereby
16 directed to develop a standard system of valuation of both real and
17 personal property of such facilities, which shall be used by all
18 county assessors in this state, under which valuation based on the
19 following shall be presumed to be the fair cash value of the
20 property:

- 21 a. for real property, a ten-year depreciation schedule,
22 at the end of which the residual value is twenty
23 percent (20%) of the value of the facility during its
24 first year of operation, and

1 b. for personal property, a five-year depreciation
2 schedule, at the end of which the residual value is
3 zero;

4 2. Such facilities shall be valued only in comparison to other
5 facilities used exclusively for poultry production. Such a facility
6 which is no longer used for poultry production shall be deemed to
7 have no productive use;

8 3. During the first year such a facility is placed on the tax
9 rolls, its fair cash value shall be presumed to be the lesser of the
10 actual purchase price or the actual documented cost of construction;
11 and

12 4. For the purpose of determining the valuation of
13 nonresidential improvements used for poultry production, the
14 provisions of this subsection shall be applicable and such
15 improvements shall not be considered to be commercial property.

16 E. The value of investment in property used exclusively by an
17 oil refinery that is used wholly as a facility, device or method for
18 the desulphurization of gasoline or diesel fuel as defined in
19 Section 2817.3 of this title shall not be included in the
20 capitalization used in the determination of fair market value of
21 such oil refinery if such property would qualify as exempt property
22 pursuant to Section 2902 of this title, whether or not an
23 application for such exemption is made by an otherwise qualifying
24

1 manufacturing concern owning the property described by Section
2 2817.3 of this title.

3 F. The use value of a lot in any platted addition or a
4 subdivision in a city, town or county zoned for residential,
5 commercial, industrial or other use shall be deemed to be the fair
6 cash value of the underlying tract of land platted, divided by the
7 number of lots contained in the platted addition or subdivision
8 until the lot shall have been conveyed to a bona fide purchaser or
9 the lot with building or buildings located thereon shall have been
10 occupied other than as a sales office by the owner thereof, or shall
11 have been leased, whichever event shall first occur. One who
12 purchases a lot for the purposes of constructing and selling a
13 building on such lot shall not be deemed to be a bona fide purchaser
14 for purposes of this section. However, if the lot is held for a
15 period longer than two (2) years before construction, then the
16 assessor may consider the lot to have been conveyed to a bona fide
17 purchaser. The cost of any land or improvements to any real
18 property required to be dedicated to public use, including, but not
19 limited to, streets, curbs, gutters, sidewalks, storm or sanitary
20 sewers, utilities, detention or retention ponds, easements, parks or
21 reserves shall not be utilized by the county assessor in the
22 valuation of any real property for assessment purposes.

23 G. The transfer of real property without a change in its use
24 classification shall not require a reassessment thereof based

1 exclusively upon the sale value of the property. However, if the
2 county assessor determines:

3 1. That by reason of the transfer of a property there is a
4 change in the actual use or classification of the property; or

5 2. That by reason of the amount of the sales consideration it
6 is obvious that the use classification prior to the transfer of the
7 property is not commensurate with and would not justify the amount
8 of the sales consideration of the property;

9 then the assessor shall, in either event, reassess the property for
10 the new use classification for which the property is being used, or,
11 the highest and best use classification for which the property may,
12 by reason of the transfer, be classified for use.

13 H. When the term "fair cash value" or the language "fair cash
14 value, estimated at the price it would bring at a fair voluntary
15 sale" is used in the Ad Valorem Tax Code, in connection with and in
16 relation to the assessment of real property, it is defined to mean
17 and shall be given the meaning ascribed and assigned to it in this
18 section and when the term or language is used in the Code in
19 connection with the assessment of personal property it shall be
20 given its ordinary or literal meaning.

21 I. Where any real property is zoned for a use by a proper
22 zoning authority, and the use of the property has not been changed,
23 the use and not zoning shall determine assessment. Any reassessment
24 required shall be effective January 1 following the change in use.

1 Taxable real property need not be listed annually with the county
2 assessor.

3 J. If any real property shall become taxable after January 1 of
4 any year, the county assessor shall assess the same and place it
5 upon the tax rolls for the next ensuing year. When any building is
6 constructed upon land after January 1 of any year, the value of the
7 building shall be added by the county assessor to the assessed
8 valuation of the land upon which the building is constructed at the
9 fair cash value thereof for the next ensuing year. However, after
10 the building has been completed it shall be deemed to have a value
11 for assessment purposes of the fair cash value of the materials used
12 in such building only, until the building and the land on which the
13 building is located shall have been conveyed to a bona fide
14 purchaser or shall have been occupied or used for any purpose other
15 than as a sales office by the owner thereof, or shall have been
16 leased, whichever event shall first occur. The county assessor
17 shall continue to assess the building based upon the fair market
18 value of the materials used therein until the building and land upon
19 which the building is located shall have been conveyed to a bona
20 fide purchaser or is occupied or used for any purpose other than as
21 a sales office by the owner thereof, or is leased, whichever event
22 shall first occur.

23 K. In case improvements on land or personal property located
24 therein or thereon are destroyed by fire, lightning, storm, winds,

1 floodwaters, overflow of streams or other cause, or the value of
2 land is impaired, damaged or destroyed by fire, lightning, storm,
3 winds, floodwaters, overflow of streams or other cause, during any
4 year, the county assessor shall determine the amount of damage and
5 shall reassess the property for that year at the fair cash value of
6 the property, as defined herein, taking into account the damage
7 occasioned by fire, lightning, storm, winds, floodwaters, overflow
8 of streams or other cause and shall present the reassessment to the
9 board of tax roll corrections for its consideration.

10 L. All taxable personal property used in the exploration of
11 oil, natural gas, or other minerals, including drilling equipment
12 and rigs, shall be assessed annually at the value set forth in the
13 first Hadco International monthly bulletin published for the tax
14 year, using the appropriate depth rating assigned to the drawworks
15 by its manufacturer and the actual condition of the rig.

16 M. The value of taxable tangible personal property used in
17 commercial disposal systems of waste materials from the production
18 of oil and gas shall not include any contract rights or leases for
19 the use of such systems nor any value associated with the wellbore
20 or non-recoverable down-hole material, including casing.

21 SECTION 21. REPEALER 68 O.S. 2011, Section 2817, as
22 amended by Section 3, Chapter 401, O.S.L. 2013 (68 O.S. Supp. 2013,
23 Section 2817), is hereby repealed.

1 SECTION 22. AMENDATORY 68 O.S. 2011, Section 3604, as
2 amended by Section 2, Chapter 378, O.S.L. 2013 (68 O.S. Supp. 2013,
3 Section 3604), is amended to read as follows:

4 Section 3604. A. Except as otherwise provided in subsection I
5 of this section, an establishment which meets the qualifications
6 specified in the Oklahoma Quality Jobs Program Act may receive
7 quarterly incentive payments for a ten-year period from the Oklahoma
8 Tax Commission pursuant to the provisions of the Oklahoma Quality
9 Jobs Program Act; provided, such an establishment defined or
10 classified in the NAICS Manual under U.S. Industry No. 711211 (2007
11 version) may receive quarterly incentive payments for a fifteen-year
12 period. The amount of such payments shall be equal to the net
13 benefit rate multiplied by the actual gross payroll of new direct
14 jobs for a calendar quarter as verified by the Oklahoma Employment
15 Security Commission.

16 B. In order to receive incentive payments, an establishment
17 shall apply to the Oklahoma Department of Commerce. The application
18 shall be on a form prescribed by the Department and shall contain
19 such information as may be required by the Department to determine
20 if the applicant is qualified. An establishment may apply for an
21 effective date for a project, which shall not be more than twenty-
22 four (24) months from the date the application is submitted to the
23 Department.

1 C. Except as otherwise provided by subsection D or E of this
2 section, in order to qualify to receive such payments, the
3 establishment applying shall be required to:

4 1. Be engaged in a basic industry;

5 2. Have an annual gross payroll for new direct jobs projected
6 by the Department to equal or exceed Two Million Five Hundred
7 Thousand Dollars (\$2,500,000.00) within three (3) years of the first
8 complete calendar quarter following the start date; and

9 3. Have a number of full-time-equivalent employees subject to
10 the tax imposed by Section 2355 of this title and working an annual
11 average of thirty (30) or more hours per week in new direct jobs
12 located in this state equal to or in excess of eighty percent (80%)
13 of the total number of new direct jobs.

14 D. In order to qualify to receive incentive payments as
15 authorized by the Oklahoma Quality Jobs Program Act, an
16 establishment engaged in an activity described under:

17 1. Industry Group Nos. 3111 through 3119 of the NAICS Manual
18 shall be required to:

19 a. have an annual gross payroll for new direct jobs
20 projected by the Department to equal or exceed One
21 Million Five Hundred Thousand Dollars (\$1,500,000.00)
22 within three (3) years of the first complete calendar
23 quarter following the start date and make, or which
24 will make within one (1) year, at least seventy-five

1 percent (75%) of its total sales, as determined by the
2 Incentive Approval Committee pursuant to the
3 provisions of subsection B of Section 3603 of this
4 title, to out-of-state customers or buyers, to in-
5 state customers or buyers if the product or service is
6 resold by the purchaser to an out-of-state customer or
7 buyer for ultimate use, or to the federal government,
8 unless the annual gross payroll equals or exceeds Two
9 Million Five Hundred Thousand Dollars (\$2,500,000.00)
10 in which case the requirements for purchase of output
11 provided by this subparagraph shall not apply, and

12 b. have a number of full-time-equivalent employees
13 working an average of thirty (30) or more hours per
14 week in new direct jobs equal to or in excess of
15 eighty percent (80%) of the total number of new direct
16 jobs; and

17 2. Division (4) of subparagraph a of paragraph 1 of subsection
18 A of Section 3603 of this title, shall be required to:

19 a. have an annual gross payroll for new direct jobs
20 projected by the Department to equal or exceed One
21 Million Five Hundred Thousand Dollars (\$1,500,000.00)
22 within three (3) years of the first complete calendar
23 quarter following the start date, and
24

1 b. have a number of full-time-equivalent employees
2 working an average of thirty (30) or more hours per
3 week in new direct jobs equal to or in excess of
4 eighty percent (80%) of the total number of new direct
5 jobs.

6 E. 1. An establishment which locates its principal business
7 activity within a site consisting of at least ten (10) acres which:

8 a. is a federal Superfund removal site,

9 b. is listed on the National Priorities List established
10 under Section 9605 of Title 42 of the United States
11 Code,

12 c. has been formally deferred to the state in lieu of
13 listing on the National Priorities List, or

14 d. has been determined by the Department of Environmental
15 Quality to be contaminated by any substance regulated
16 by a federal or state statute governing environmental
17 conditions for real property pursuant to an order of
18 the Department of Environmental Quality,

19 shall qualify for incentive payments irrespective of its actual
20 gross payroll or the number of full-time-equivalent employees
21 engaged in new direct jobs.

22 2. In order to qualify for the incentive payments pursuant to
23 this subsection, the establishment shall conduct the activity
24 resulting in at least fifty percent (50%) of its Oklahoma taxable

1 income or adjusted gross income, as determined under Section 2358 of
2 this title, whether from the sale of products or services or both
3 products and services, at the physical location which has been
4 determined not to comply with the federal or state statutes
5 described in this subsection with respect to environmental
6 conditions for real property. The establishment shall be subject to
7 all other requirements of the Oklahoma Quality Jobs Program Act
8 other than the exemptions provided by this subsection.

9 3. In order to qualify for the incentive payments pursuant to
10 this subsection, the entity shall obtain from the Department of
11 Environmental Quality a letter of concurrence that:

- 12 a. the site designated by the entity does meet one or
13 more of the requirements listed in paragraph 1 of this
14 subsection, and
- 15 b. the site is being or has been remediated to a level
16 which is consistent with the intended use of the
17 property.

18 In making its determination, the Department of Environmental
19 Quality may rely on existing data and information available to it,
20 but may also require the applying entity to provide additional data
21 and information as necessary.

22 4. If authorized by the Department of Environmental Quality
23 pursuant to paragraph 3 of this subsection, the entity may utilize a
24 remediated portion of the property for its intended purpose prior to

1 remediation of the remainder of the site, and shall qualify for
2 incentive payments based on employment associated with the portion
3 of the site.

4 F. Except as otherwise provided by subsection G of this
5 section, for applications submitted on and after June 4, 2003, in
6 order to qualify to receive incentive payments as authorized by the
7 Oklahoma Quality Jobs Program Act, in addition to other
8 qualifications specified herein, an establishment shall be required
9 to pay new direct jobs an average annualized wage which equals or
10 exceeds:

11 1. One hundred ten percent (110%) of the average county wage as
12 determined by the ~~Oklahoma State Data Center~~ Department of Commerce
13 based on the most recent U.S. Department of Commerce data for the
14 county in which the new direct jobs are located. For purposes of
15 this paragraph, health care premiums paid by the applicant for
16 individuals in new direct jobs shall be included in the annualized
17 wage; or

18 2. One hundred percent (100%) of the average county wage as
19 that percentage is determined by the ~~Oklahoma State Data Center~~
20 Department of Commerce based upon the most recent U.S. Department of
21 Commerce data for the county in which the new jobs are located. For
22 purposes of this paragraph, health care premiums paid by the
23 applicant for individuals in new direct jobs shall not be included
24 in the annualized wage.

1 Provided, no average wage requirement shall exceed Twenty-five
2 Thousand Dollars (\$25,000.00), in any county. This maximum wage
3 threshold shall be indexed and modified from time to time based on
4 the latest Consumer Price Index year-to-date percent change release
5 as of the date of the annual average county wage data release from
6 the Bureau of Economic Analysis of the U.S. Department of Commerce.

7 G. 1. As used in this subsection, "opportunity zone" means one
8 or more census tracts in which, according to the most recent federal
9 decennial census, at least thirty percent (30%) of the residents
10 have annual gross household incomes from all sources below the
11 poverty guidelines established by the U.S. Department of Health and
12 Human Services. An establishment which is otherwise qualified to
13 receive incentive payments and which locates its principal business
14 activity in an opportunity zone shall not be subject to the
15 requirements of subsection F of this section.

16 2. As used in this subsection:

17 a. "negative economic event" means:

18 (1) a man-made disaster or natural disaster as
19 defined in Section 683.3 of Title 63 of the
20 Oklahoma Statutes, resulting in the loss of a
21 significant number of jobs within a particular
22 county of this state, or

23 (2) an economic circumstance in which a significant
24 number of jobs within a particular county of this

1 state have been lost due to an establishment
2 changing its structure, consolidating with
3 another establishment, closing or moving all or
4 part of its operations out of this state, and

5 b. "significant number of jobs" means Local Area
6 Unemployment Statistics (LAUS) data, as determined by
7 the Bureau of Labor Statistics, for a county which are
8 equal to or in excess of five percent (5%) of the
9 total amount of Local Area Unemployment Statistics
10 (LAUS) data for that county for the calendar year, or
11 most recent twelve-month period in which employment is
12 measured, preceding the event.

13 An establishment which is otherwise qualified to receive
14 incentive payments and which locates in a county in which a negative
15 economic event has occurred within the eighteen-month period
16 preceding the start date shall not be subject to the requirements of
17 subsection F of this section; provided, an establishment shall not
18 be eligible to receive incentive payments based upon a negative
19 economic event with respect to jobs that are transferred from one
20 county of this state to another.

21 H. The Department shall determine if the applicant is qualified
22 to receive incentive payments.

23 I. If the applicant is determined to be qualified by the
24 Department and is not subject to the provisions of subparagraph d of

1 paragraph 7 of subsection A of Section 3603 of this title, the
2 Department shall conduct a cost/benefit analysis to determine the
3 estimated net direct state benefits and the net benefit rate
4 applicable for a ten-year period beginning with the first complete
5 calendar quarter following the start date and to estimate the amount
6 of gross payroll for a ten-year period beginning with the first
7 complete calendar quarter following the start date or for a fifteen-
8 year period for an establishment defined or classified in the NAICS
9 Manual under U.S. Industry No. 711211 (2007 version). In conducting
10 such cost/benefit analysis, the Department shall consider
11 quantitative factors, such as the anticipated level of new tax
12 revenues to the state along with the added cost to the state of
13 providing services, and such other criteria as deemed appropriate by
14 the Department. In no event shall incentive payments, cumulatively,
15 exceed the estimated net direct state benefits, except for
16 applicants subject to the provisions of subparagraph d of paragraph
17 7 of subsection A of Section 3603 of this title.

18 J. Upon approval of such an application, the Department shall
19 notify the Tax Commission and shall provide it with a copy of the
20 contract and the results of the cost/benefit analysis. The Tax
21 Commission may require the qualified establishment to submit such
22 additional information as may be necessary to administer the
23 provisions of the Oklahoma Quality Jobs Program Act. The approved
24 establishment shall file quarterly claims with the Tax Commission

1 and shall continue to file such quarterly claims during the ten-year
2 incentive period to show its continued eligibility for incentive
3 payments, as provided in Section 3606 of this title, or until it is
4 no longer qualified to receive incentive payments. The
5 establishment may be audited by the Tax Commission to verify such
6 eligibility. Once the establishment is approved, an agreement shall
7 be deemed to exist between the establishment and the State of
8 Oklahoma, requiring the continued incentive payment to be made as
9 long as the establishment retains its eligibility as defined in and
10 established pursuant to this section and Sections 3603 and 3606 of
11 this title and within the limitations contained in the Oklahoma
12 Quality Jobs Program Act, which existed at the time of such
13 approval. An establishment described in this subsection shall be
14 required to repay all incentive payments received under the Oklahoma
15 Quality Jobs Program Act if the establishment is determined by the
16 Oklahoma Tax Commission to no longer have business operations in the
17 state within three (3) years from the beginning of the calendar
18 quarter for which the first incentive payment claim is filed.

19 K. A municipality with a population of less than one hundred
20 thousand (100,000) persons in which an establishment eligible to
21 receive quarterly incentive payments pursuant to the provisions of
22 this section is located may file a claim with the Tax Commission for
23 up to twenty-five percent (25%) of the amount of such payment. The
24 amount of such claim shall not exceed amounts paid by the

1 municipality for direct costs of municipal infrastructure
2 improvements to provide water and sewer service to the
3 establishment. Such claim shall not be approved by the Tax
4 Commission unless the municipality and the establishment have
5 entered into a written agreement for such claims to be filed by the
6 municipality prior to submission of the application of the
7 establishment pursuant to the provisions of this section. If such
8 claim is approved, the amount of the payment to the establishment
9 made pursuant to the provisions of Section 3606 of this title shall
10 be reduced by the amount of the approved claim by the municipality
11 and the Tax Commission shall issue a warrant to the municipality in
12 the amount of the approved claim in the same manner as warrants are
13 issued to qualifying establishments.

14 SECTION 23. REPEALER 68 O.S. 2011, Section 3604, as
15 amended by Section 24, Chapter 227, O.S.L. 2013 (68 O.S. Supp. 2013,
16 Section 3604), is hereby repealed.

17 SECTION 24. AMENDATORY 68 O.S. 2011, Section 3914, as
18 amended by Section 4, Chapter 378, O.S.L. 2013 (68 O.S. Supp. 2013,
19 Section 3914), is amended to read as follows:

20 Section 3914. A. An establishment which meets the
21 qualifications specified in the 21st Century Quality Jobs Incentive
22 Act may receive quarterly incentive payments for a ten-year period
23 from the Oklahoma Tax Commission pursuant to the provisions of this
24 act, as verified by the Tax Commission, in an amount equal to:

1 1. The gross payroll multiplied by the initial net benefit rate
2 until such time as the establishment creates ten new direct jobs; or

3 2. The gross payroll multiplied by the fulfillment net benefit
4 rate after such time as the establishment created and maintains ten
5 new direct jobs.

6 B. In order to receive incentive payments, an establishment
7 shall apply to the Oklahoma Department of Commerce. The application
8 shall be on a form prescribed by the Department and shall contain
9 such information as may be required by the Department to determine
10 if the applicant is qualified. The establishment may apply for an
11 effective date for a project, which shall not be more than twelve
12 (12) months from the date the application is submitted to the
13 Department.

14 C. Before approving an application for incentive payments, the
15 Department must first determine that the applicant meets the
16 following requirements:

17 1. Be engaged in a basic industry as defined in the 21st
18 Century Quality Jobs Incentive Act;

19 2. Will hire at least ten full-time employees in this state
20 within twelve (12) quarters of the date of application;

21 3. Will pay the individuals it employs in new direct jobs an
22 average annualized wage which equals or exceeds three hundred
23 percent (300%) of the average county wage for the county in which
24 the applicant is located as that percentage is determined by the

1 ~~Oklahoma State Data Center~~ Department of Commerce based on the most
2 recent U.S. Department of Commerce data. For purposes of this
3 paragraph, health care premiums paid by the applicant for
4 individuals in new direct jobs shall not be included in the
5 annualized wage. Provided, no average wage requirement shall exceed
6 Ninety-four Thousand Dollars (\$94,000.00) in any county. This
7 maximum wage threshold shall be indexed and modified from time to
8 time based on the latest Consumer Price Index year-to-date percent
9 change release as of the date of the annual average county wage data
10 release from the Bureau of Economic Analysis of the U.S. Department
11 of Commerce;

12 4. Has a basic health benefit plan which, as determined by the
13 Department, meets the elements established under divisions (1)
14 through (7) of subparagraph b of paragraph 1 of subsection A of
15 Section 3603 of ~~Title 68 of the Oklahoma Statutes~~ this title and
16 which will be offered to individuals within twelve (12) months of
17 employment in a new direct job;

18 5. Has not received incentive payments under the Small Employer
19 Quality Jobs Program Act, the Saving Quality Jobs Act or the Former
20 Military Facility Development Act; and

21 6. Is not qualified for approval of an application for
22 incentive payments under the Small Employer Quality Jobs Program
23 Act, the Saving Quality Jobs Act or the Former Military Facility
24 Development Act.

1 D. The Oklahoma Department of Commerce shall determine if an
2 applicant is qualified to receive the incentive payment. Upon
3 qualifying the applicant, the Department shall notify the Tax
4 Commission and shall provide it with a copy of the contract and
5 approval which shall provide the number of persons employed by the
6 applicant upon the date of approval and the maximum total incentives
7 which may be paid to the applicant during the ten-year period. The
8 Tax Commission may require the qualified establishment to submit
9 additional information as may be necessary to administer the
10 provisions of this act. The approved establishment shall report to
11 the Tax Commission quarterly to show its continued eligibility for
12 incentive payments, as provided in Section 3905 of ~~Title 68 of the~~
13 ~~Oklahoma Statutes~~ this title. Establishments may be audited by the
14 Tax Commission to verify such eligibility. Once the establishment
15 is approved, an agreement shall be deemed to exist between the
16 establishment and the State of Oklahoma, requiring incentive
17 payments to be made for a ten-year period as long as the
18 establishment retains its eligibility and within the limitations of
19 this act as it existed at the time of such approval.

20 SECTION 25. REPEALER 68 O.S. 2011, Section 3914, as
21 amended by Section 29, Chapter 227, O.S.L. 2013 (68 O.S. Supp. 2013,
22 Section 3914), is hereby repealed.
23

SECTION 26. AMENDATORY 70 O.S. 2011, Section 1210.523,
as last amended by Section 1, Chapter 125, O.S.L. 2013 (70 O.S.
Supp. 2013, Section 1210.523), is amended to read as follows:

Section 1210.523. A. Except as provided in subsections D and E
of this section, beginning with students entering the ninth grade in
the 2008-2009 school year, every student shall demonstrate mastery
of the state academic content standards in the following subject
areas in order to graduate from a public high school with a standard
diploma:

1. Algebra I;
2. English II; and
3. Two of the following five:
 - a. Algebra II,
 - b. Biology I,
 - c. English III,
 - d. Geometry, and
 - e. United States History.

B. To demonstrate mastery, the student shall attain at least a
proficient score on the end-of-instruction criterion-referenced
tests administered pursuant to Section 1210.508 of this title.

C. Notwithstanding any other provision of law, students who do
not attain at least a proficient score on any end-of-instruction
test shall be provided remediation or intervention and the
opportunity to retake the test until at least a proficient score is

1 attained on the tests of Algebra I, English II and two of the tests
2 required in paragraph 3 of subsection A of this section or an
3 approved alternative test. Technology center schools shall be
4 authorized to provide intervention and remediation in Algebra I,
5 Algebra II, Geometry, English II, English III, United States
6 History, and Biology I to students enrolled in technology center
7 schools, with the approval of the independent school district board.

8 D. 1. Students who do not meet the requirements of subsection
9 A of this section may graduate from a public high school with a
10 standard diploma by demonstrating mastery of state academic content
11 standards by alternative methods as approved by the State Board of
12 Education.

13 2. The State Board of Education shall adopt rules providing for
14 necessary student exceptions and exemptions to the requirements of
15 this section. The Board shall collect data by school site and
16 district on the number of students provided and categories of
17 exceptions and exemptions granted. Beginning October 1, 2012, the
18 Board shall provide an annual report of this data to the Governor,
19 President Pro Tempore of the Senate and Speaker of the House of
20 Representatives.

21 3. Students who score ten percent (10%) above the cut scores
22 approved by the State Board of Education for the American College
23 Testing Program (ACT), the Scholastic Aptitude Test (SAT), ACT Plan
24 or Preliminary Scholastic Aptitude Test/National Merit Scholarship

1 Qualifying Test (PSAT/NMSQT) alternate tests shall be deemed to have
2 satisfactorily demonstrated mastery of state academic content
3 standards in the subject areas for which alternative tests have been
4 approved and shall be exempt from taking the end-of-instruction
5 criterion-referenced tests in the subject areas of Algebra II,
6 English III, Geometry or United States History as listed in
7 paragraph 3 of subsection A of this section.

8 4. Students who have a score that is equal to or above the cut
9 scores approved by the State Board of Education for the Advanced
10 Placement course exams, ACT Workkeys job skills assessment, College-
11 Level Examination Program (CLEP) or International Baccalaureate (IB)
12 alternate tests shall be deemed to have satisfactorily demonstrated
13 mastery of state academic content standards in the subject areas for
14 which alternate tests have been approved and shall be exempt from
15 taking the end-of-instruction criterion-referenced tests in the
16 subject areas of Algebra II, English III, Geometry or United States
17 History as listed in paragraph 3 of subsection A of this section.

18 5. The State Board of Education shall adopt rules providing for
19 implementation of paragraphs 3 and 4 of this subsection. The rules
20 shall provide for the designation of students as proficient or
21 advanced based on the scores obtained pursuant to paragraphs 3 and 4
22 of this subsection for the purposes of calculating the grade of a
23 school as part of the accountability system developed pursuant to
24 Section 1210.545 of this title, evaluating teachers and

1 administrators as part of the Teacher and Leader Effectiveness
2 Evaluation System developed pursuant to Section 6-101.16 of this
3 title and for any other purpose provided for by law.

4 E. 1. The State Board of Education shall adopt rules
5 establishing an appeal process for students who have been denied a
6 standard diploma by the school district in which the student is or
7 was enrolled for failing to meet the requirements of this section.
8 A student who has been denied a standard diploma by the school
9 district in which the student is enrolled shall have thirty (30)
10 days after denial of the standard diploma in which to file a
11 petition for an appeal to the State Board of Education. The State
12 Board of Education shall take action on a petition for an appeal no
13 later than forty-five (45) days after receiving the petition.

14 2. The State Board of Education shall collect data by school
15 site and school district on the number of students petitioning for
16 an appeal and the number of appeals approved by the State Board of
17 Education pursuant to this subsection. Beginning October 1, 2012,
18 the State Board of Education shall provide an annual report of this
19 data to the Governor, President Pro Tempore of the Senate and
20 Speaker of the House of Representatives.

21 F. 1. Students who have individualized education programs
22 pursuant to the Individuals with Disabilities Education Act (IDEA)
23 shall have an appropriate statement on the student's individualized
24 education program requiring administration of the assessment with or

1 without accommodations or an alternate assessment. Any
2 accommodations normally employed for the assessment shall be
3 approved by the State Board of Education and be provided for in the
4 individualized education program. All documentation for each
5 student shall be on file in the school prior to administration of
6 the assessment.

7 2. Students with disabilities whose individualized education
8 program (IEP) pursuant to the Individuals with Disabilities
9 Education Act (IDEA) indicates that the student is to be assessed
10 with alternate achievement standards through the Oklahoma Alternate
11 Assessment Program (OAAP) may be eligible to graduate from a public
12 high school with a standard diploma after failing to meet the
13 requirements of subsection A of this section upon the determination
14 of the school district that the student meets the following
15 criteria:

16 a. obtains a written recommendation from the student's
17 teacher of record in consultation with the teacher in
18 each subject in which the student failed to meet the
19 requirements of subsection A of this section. The
20 recommendation shall be supported by the principal and
21 by documentation demonstrating the acquired knowledge
22 of the student by alternate measures as required by
23 the individualized education program (IEP),
24

- b. completes remediation opportunities to the extent required by the individualized education program (IEP),
- c. retakes the exam in each subject in which the student failed to meet the requirements of subsection A of this section if the individualized education program (IEP) requires retake opportunities,
- d. maintains at least a C average or the equivalent in each subject in which the student failed to meet the requirements of subsection A of this section, and
- e. meets all other graduation requirements of the school district in which the student is enrolled.

3. The Oklahoma School for the Blind and the Oklahoma School for the Deaf shall be considered local education agencies solely for the purposes of purchasing, administering and obtaining test results under this section for the students attending their schools.

4. Students identified as English language learners shall be assessed in a valid and reliable manner with the state academic assessments with acceptable accommodations as necessary or, to the extent practicable, with alternate assessments aligned to the state assessment provided by the school district in the language and form most likely to yield accurate data of the student's knowledge of the content areas.

1 G. Students who have been denied a standard diploma by the
2 school district in which the student is or was enrolled for failing
3 to meet the requirements of this section may re-enroll in the school
4 district that denied the student a standard diploma following the
5 denial of a standard diploma. The student shall be provided
6 remediation or intervention and the opportunity to retake the test
7 until at least a proficient score is attained on the test or tests
8 necessary to obtain a standard diploma. Students who re-enroll in
9 the school district to meet the graduation requirements of this
10 section shall be exempt from the hourly instructional requirements
11 of Section 1-111 of this title and the six-period enrollment
12 requirements of Section 11-103.6 of this title.

13 H. The State Board of Education shall be authorized to contract
14 with an entity to develop and advise on the implementation of a
15 communications campaign to build public understanding of and support
16 for the testing requirements of this section.

17 SECTION 27. REPEALER 70 O.S. 2011, Section 1210.523, as
18 last amended by Section 1, Chapter 367, O.S.L. 2013 (70 O.S. Supp.
19 2013, Section 1210.523), is hereby repealed.

20 SECTION 28. REPEALER 70 O.S. 2011, Section 1210.523, as
21 last amended by Section 2, Chapter 403, O.S.L. 2013 (70 O.S. Supp.
22 2013, Section 1210.523), is hereby repealed.

23 SECTION 29. It being immediately necessary for the preservation
24 of the public peace, health and safety, an emergency is hereby

1 declared to exist, by reason whereof this act shall take effect and
2 be in full force from and after its passage and approval.
