State Treasurer, the State Department of Health,  
the Oklahoma Health Care Authority, the J.D.  
McCarty Center for Children with Developmental  
Disabilities, the Department of Mental Health and  
Substance Abuse Services, the University  
Hospitals Authority, the Oklahoma Department of  
Veterans Affairs, the Oklahoma State University  
Medical Authority, the Oklahoma Commission on  
Children and Youth, the Office of Disability

Concerns, the Department of Human Services, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Rural Economic Action Plan Fund, the Oklahoma Conservation Commission, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Office of the Attorney General, district attorneys and the District Attorneys Council, the Court of Criminal Appeals, the Supreme Court, the Oklahoma Indigent Defense System, the Pardon and Parole Board, the Workers' Compensation Commission and the Workers' Compensation Court of Existing Claims; stating amounts of the appropriations; stating purposes and restrictions; directing the State Board of Equalization to make certain reduction; authorizing and requiring certain expenditures; authorizing and requiring certain transfers; requiring certain deposit; and providing effective dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

#### COMMON EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year  
2 ending June 30, 2015, the sum of One Billion Fifty-five Million  
3 Two Hundred Ninety-four Thousand Five Hundred Forty-seven  
4 Dollars (\$1,055,294,547.00) or so much thereof as may be  
5 necessary for the financial support of public schools.

6 SECTION 2. There is hereby appropriated to the State Board  
7 of Education from any monies not otherwise appropriated from the  
8 Education Reform Revolving Fund created in Section 34.89 of  
9 Title 62 of the Oklahoma Statutes, the sum of Seven Hundred  
10 Thirty-eight Million Six Hundred Twenty-five Thousand Four  
11 Hundred Seventy-four Dollars (\$738,625,474.00) or so much  
12 thereof as may be necessary for the financial support of public  
13 schools.

14 SECTION 3. The State Board of Education is hereby  
15 authorized to expend during the fiscal year ending June 30,  
16 2015, from the Common Education Technology Revolving Fund of the  
17 State Treasury, the sum of Forty-seven Million Three Hundred  
18 Seventy-two Thousand Two Hundred Ninety-nine Dollars  
19 (\$47,372,299.00) or so much thereof as may be necessary for the  
20 financial support of public schools.

21 SECTION 4. There is hereby appropriated to the State Board  
22 of Education from any monies not otherwise appropriated from the  
23 Mineral Leasing Fund of the State Treasury for the fiscal year  
24 ending June 30, 2015, the sum of Three Million Eight Hundred

1 Thousand Dollars (\$3,800,000.00) or so much thereof as may be  
2 necessary for the financial support of public schools.

3 SECTION 5. There is hereby appropriated to the State Board  
4 of Education from any monies not otherwise appropriated from the  
5 Mineral Leasing Fund of the State Treasury for the fiscal year  
6 ending June 30, 2013, the sum of One Million Thirty-two Thousand  
7 Two Hundred Fifty-eight Dollars (\$1,032,258.00) or so much  
8 thereof as may be necessary for the financial support of public  
9 schools.

10 SECTION 6. There is hereby appropriated to the State Board  
11 of Education from any monies not otherwise appropriated from the  
12 Oklahoma Education Lottery Trust Fund of the State Treasury for  
13 the fiscal year ending June 30, 2015, the sum of Twenty-five  
14 Million Seven Hundred Sixty-eight Thousand Four Hundred Eighteen  
15 Dollars (\$25,768,418.00) or so much thereof as may be necessary  
16 for the financial support of public schools.

17 SECTION 7. There is hereby appropriated to the State Board  
18 of Education from any monies not otherwise appropriated from the  
19 Oklahoma Education Lottery Trust Fund of the State Treasury for  
20 the fiscal year ending June 30, 2013, the sum of Five Million  
21 Six Hundred Seventy-seven Thousand Seven Hundred Eighty-one  
22 Dollars (\$5,677,781.00) or so much thereof as may be necessary  
23 for the financial support of public schools.

1       SECTION 8. There is hereby appropriated to the State Board  
2 of Education from any monies not otherwise appropriated from the  
3 General Revenue Fund of the State Treasury for the fiscal year  
4 ending June 30, 2015, the sum of Five Hundred Forty-six Million  
5 Eight Hundred Sixty-eight Thousand Six Hundred Seventeen Dollars  
6 (\$546,868,617.00) or so much thereof as may be necessary for the  
7 support of public schools activities.

8       SECTION 9. There is hereby appropriated to the State Board  
9 of Education from any monies not otherwise appropriated from the  
10 General Revenue Fund of the State Treasury for the fiscal year  
11 ending June 30, 2013, the sum of Thirty-three Million Dollars  
12 (\$33,000,000.00) or so much thereof as may be necessary for the  
13 purchase of textbooks and instructional materials.

14       SECTION 10. There is hereby appropriated to the State Board  
15 of Education from any monies not otherwise appropriated from the  
16 General Revenue Fund of the State Treasury for the fiscal year  
17 ending June 30, 2015, the sum of Twenty-two Million Four Hundred  
18 Twenty-six Thousand Six Hundred Forty-two Dollars  
19 (\$22,426,642.00) or so much thereof as may be necessary for  
20 administrative and support functions of the State Department of  
21 Education.

22       SECTION 11. There is hereby appropriated to the State Board  
23 of Education from any monies not otherwise appropriated from the  
24 Oklahoma Education Lottery Trust Fund of the State Treasury for

1 the fiscal year ending June 30, 2015, the sum of Two Million  
2 Eight Hundred Sixty-three Thousand One Hundred Fifty-eight  
3 Dollars (\$2,863,158.00) or so much thereof as may be necessary  
4 for transfer to the School Consolidation Assistance Fund.

5 SECTION 12. There is hereby appropriated to the State Board  
6 of Education from any monies not otherwise appropriated from the  
7 Oklahoma Education Lottery Trust Fund of the State Treasury for  
8 the fiscal year ending June 30, 2013, the sum of Six Hundred  
9 Thirty Thousand Eight Hundred Sixty-five Dollars (\$630,865.00)  
10 or so much thereof as may be necessary for transfer to the  
11 School Consolidation Assistance Fund.

12 SECTION 13. There is hereby appropriated to the State Board  
13 of Education from any monies not otherwise appropriated from the  
14 Oklahoma Education Lottery Trust Fund of the State Treasury for  
15 the fiscal year ending June 30, 2015, the sum of Two Million  
16 Eight Hundred Sixty-three Thousand One Hundred Fifty-eight  
17 Dollars (\$2,863,158.00) or so much thereof as may be necessary  
18 for transfer to the Teachers' Retirement System Dedicated  
19 Revenue Revolving Fund.

20 SECTION 14. There is hereby appropriated to the State Board  
21 of Education from any monies not otherwise appropriated from the  
22 Oklahoma Education Lottery Trust Fund of the State Treasury for  
23 the fiscal year ending June 30, 2013, the sum of Six Hundred  
24 Thirty Thousand Eight Hundred Sixty-five Dollars (\$630,865.00)

1 or so much thereof as may be necessary for transfer to the  
2 Teachers' Retirement System Dedicated Revenue Revolving Fund.

3 SECTION 15. There is hereby appropriated to the Oklahoma  
4 Arts Council from any monies not otherwise appropriated from the  
5 General Revenue Fund of the State Treasury for the fiscal year  
6 ending June 30, 2015, the sum of Three Million Seven Hundred  
7 Eighty-nine Thousand Five Hundred Thirty-two Dollars  
8 (\$3,789,532.00) or so much thereof as may be necessary to  
9 perform the duties imposed upon the Oklahoma Arts Council by  
10 law.

11 SECTION 16. There is hereby appropriated to the  
12 Commissioners of the Land Office from any monies not otherwise  
13 appropriated from the Commissioners of the Land Office Fund of  
14 the State Treasury for the fiscal year ending June 30, 2015, the  
15 sum of Eight Million Five Hundred Thirty-eight Thousand Six  
16 Hundred Dollars (\$8,538,600.00) or so much thereof as may be  
17 necessary to perform the duties imposed upon the Commissioners  
18 of the Land Office by law.

19 SECTION 17. There is hereby appropriated to the Board of  
20 Trustees of the Oklahoma School of Science and Mathematics from  
21 any monies not otherwise appropriated from the General Revenue  
22 Fund of the State Treasury for the fiscal year ending June 30,  
23 2015, the sum of Six Million Three Hundred Thirty-two Thousand  
24 Two Hundred Seventy-four Dollars (\$6,332,274.00) or so much

1 | thereof as may be necessary to perform the duties imposed upon  
2 | the Board of Trustees of the Oklahoma School of Science and  
3 | Mathematics by law.

4 |       SECTION 18. There is hereby appropriated to the Office of  
5 | Educational Quality and Accountability from any monies not  
6 | otherwise appropriated from the General Revenue Fund of the  
7 | State Treasury for the fiscal year ending June 30, 2015, the sum  
8 | of One Million Nine Hundred Thirty-one Thousand Two Hundred  
9 | Seventy-one Dollars (\$1,931,271.00) or so much thereof as may be  
10 | necessary to perform the duties imposed upon the Office of  
11 | Educational Quality and Accountability by law.

12 |                   CAREER AND TECHNOLOGY EDUCATION

13 |       SECTION 19. There is hereby appropriated to the State Board  
14 | of Career and Technology Education from any monies not otherwise  
15 | appropriated from the General Revenue Fund of the State Treasury  
16 | for the fiscal year ending June 30, 2015, the sum of One Hundred  
17 | Thirty-five Million Forty-nine Thousand One Hundred Ninety-four  
18 | Dollars (\$135,049,194.00) or so much thereof as may be necessary  
19 | to perform the duties imposed upon the State Board of Career and  
20 | Technology Education by law.

21 |       SECTION 20. There is hereby appropriated to the State Board  
22 | of Career and Technology Education from any monies not otherwise  
23 | appropriated from the Oklahoma Education Lottery Trust Fund of  
24 | the State Treasury for the fiscal year ending June 30, 2015, the



1 sum of Three Million One Hundred Forty-nine Thousand Four  
2 Hundred Seventy-three Dollars (\$3,149,473.00) pursuant to  
3 paragraph 2 of subsection C of Section 713 of Title 3A of the  
4 Oklahoma Statutes for allocation by the State Board of Career  
5 and Technology Education for the education and general operating  
6 budgets of the institutions and for other programs,  
7 construction, renovations or repairs administered by the State  
8 Board of Career and Technology Education.

9 SECTION 21. There is hereby appropriated to the State Board  
10 of Career and Technology Education from any monies not otherwise  
11 appropriated from the Oklahoma Education Lottery Trust Fund of  
12 the State Treasury for the fiscal year ending June 30, 2013, the  
13 sum of Six Hundred Ninety-three Thousand Nine Hundred Fifty-one  
14 Dollars (\$693,951.00) pursuant to paragraph 2 of subsection C of  
15 Section 713 of Title 3A of the Oklahoma Statutes for allocation  
16 by the State Board of Career and Technology Education for the  
17 education and general operating budgets of the institutions and  
18 for other programs, construction, renovations or repairs  
19 administered by the State Board of Career and Technology  
20 Education.

21 SECTION 22. There is hereby appropriated to the Oklahoma  
22 Educational Television Authority from any monies not otherwise  
23 appropriated from the General Revenue Fund of the State Treasury  
24 for the fiscal year ending June 30, 2015, the sum of Three

1 Million Six Hundred Twelve Thousand One Hundred Dollars  
2 (\$3,612,100.00) or so much thereof as may be necessary to  
3 perform the duties imposed upon the Oklahoma Educational  
4 Television Authority by law.

5 SECTION 23. There is hereby appropriated to the Oklahoma  
6 Department of Libraries from any monies not otherwise  
7 appropriated from the General Revenue Fund of the State Treasury  
8 for the fiscal year ending June 30, 2015, the sum of Five  
9 Million Five Hundred Seventy-four Thousand Two Hundred Eight  
10 Dollars (\$5,574,208.00) or so much thereof as may be necessary  
11 to perform the duties imposed upon the Oklahoma Department of  
12 Libraries by law.

#### 13 HIGHER EDUCATION

14 SECTION 24. There is hereby appropriated to the Oklahoma  
15 State Regents for Higher Education from any monies not otherwise  
16 appropriated from the General Revenue Fund of the State Treasury  
17 for the fiscal year ending June 30, 2015, the sum of Eight  
18 Hundred Thirty-five Million Sixty-four Thousand Nine Hundred Ten  
19 Dollars (\$835,064,910.00) or so much thereof as may be necessary  
20 for allocation by the Oklahoma State Regents for Higher  
21 Education pursuant to the provisions of Article XIII-A of the  
22 Oklahoma Constitution for the education and general operating  
23 budgets of the institutions and for other programs,  
24 construction, renovations or repairs administered by the

1 Oklahoma State Regents for Higher Education. Of those funds  
2 appropriated, the sum of Three Million Eight Hundred Thirty  
3 Thousand Thirty-eight Dollars (\$3,830,038.00) shall be  
4 transferred to the Oklahoma Tuition Equalization Grant Trust  
5 Fund to implement the provisions of the Oklahoma Tuition  
6 Equalization Grant Act.

7 SECTION 25. The Oklahoma State Regents for Higher Education  
8 are hereby authorized to expend, from the Special Cash Fund of  
9 the State Treasury the sum of Ten Million Dollars  
10 (\$10,000,000.00) or so much thereof as may be necessary for  
11 allocation by the Oklahoma State Regents for Higher Education  
12 pursuant to the provisions of Article XIII-A of the Oklahoma  
13 Constitution for the education and general operating budgets of  
14 the institutions and for other programs, construction,  
15 renovations or repairs administered by the Oklahoma State  
16 Regents for Higher Education.

17 SECTION 26. The Oklahoma State Regents for Higher Education  
18 are hereby authorized to expend during the fiscal year ending  
19 June 30, 2015, the sum of Forty-seven Million Three Hundred  
20 Seventy-two Thousand Two Hundred Ninety-nine Dollars  
21 (\$47,372,299.00) from the Higher Education Capital Revolving  
22 Fund of the State Treasury for allocation by the Oklahoma State  
23 Regents for Higher Education pursuant to the provisions of  
24 Article XIII-A of the Oklahoma Constitution for the education

1 and general operating budgets of the institutions and for other  
2 programs, construction, renovations or repairs administered by  
3 the Oklahoma State Regents for Higher Education.

4 SECTION 27. The Oklahoma State Regents for Higher Education  
5 are hereby authorized to expend during the fiscal year ending  
6 June 30, 2015, the sum of Forty-seven Million Three Hundred  
7 Seventy-two Thousand Two Hundred Ninety-nine Dollars  
8 (\$47,372,299.00) from the Oklahoma Student Aid Revolving Fund of  
9 the State Treasury for allocation by the Oklahoma State Regents  
10 for Higher Education pursuant to the provisions of Article XIII-  
11 A of the Oklahoma Constitution for the education and general  
12 operating budgets of the institutions and for other programs,  
13 construction, renovations or repairs administered by the  
14 Oklahoma State Regents for Higher Education.

15 SECTION 28. There is hereby appropriated to the Oklahoma  
16 State Regents for Higher Education from any monies not otherwise  
17 appropriated from the Special Cash Fund of the State Treasury  
18 the sum of Fifteen Million Dollars (\$15,000,000.00) for  
19 allocation by the Oklahoma State Regents for Higher Education  
20 pursuant to the provisions of Article XIII-A of the Oklahoma  
21 Constitution for the education and general operating budgets of  
22 the institutions and for other programs, construction,  
23 renovations or repairs administered by the Oklahoma State  
24 Regents for Higher Education.

1       SECTION 29. There is hereby appropriated to the Oklahoma  
2 State Regents for Higher Education from any monies not otherwise  
3 appropriated from the General Revenue Fund of the State Treasury  
4 for the fiscal year ending June 30, 2015, the sum of One Million  
5 Two Hundred Thirty-four Thousand One Hundred Seventy-four  
6 Dollars (\$1,234,174.00) or so much thereof as may be necessary  
7 for expenditures for concurrent enrollment pursuant to Section  
8 628.13 of Title 70 of the Oklahoma Statutes.

9       SECTION 30. There is hereby appropriated to the Oklahoma  
10 State Regents for Higher Education from any monies not otherwise  
11 appropriated from the Oklahoma Education Lottery Trust Fund of  
12 the State Treasury for the fiscal year ending June 30, 2015, the  
13 sum of Twenty-two Million Six Hundred Eighteen Thousand Nine  
14 Hundred Forty-four Dollars (\$22,618,944.00) pursuant to  
15 paragraph 2 of subsection C of Section 713 of Title 3A of the  
16 Oklahoma Statutes for allocation by the Oklahoma State Regents  
17 for Higher Education pursuant to the provisions of Article XIII-  
18 A of the Oklahoma Constitution for construction, renovations or  
19 repairs administered by the Oklahoma State Regents for Higher  
20 Education or for any other purpose authorized by paragraph 2 of  
21 subsection C of Section 713 of Title 3A of the Oklahoma  
22 Statutes.

23       SECTION 31. There is hereby appropriated to the Oklahoma  
24 State Regents for Higher Education from any monies not otherwise

1 appropriated from the Oklahoma Education Lottery Trust Fund of  
2 the State Treasury for the fiscal year ending June 30, 2013, the  
3 sum of Four Million Nine Hundred Eighty-three Thousand Eight  
4 Hundred Thirty Dollars (\$4,983,830.00) pursuant to paragraph 2  
5 of subsection C of Section 713 of Title 3A of the Oklahoma  
6 Statutes for allocation by the Oklahoma State Regents for Higher  
7 Education pursuant to the provisions of Article XIII-A of the  
8 Oklahoma Constitution for construction, renovations or repairs  
9 administered by the Oklahoma State Regents for Higher Education  
10 or for any other purpose authorized by paragraph 2 of subsection  
11 C of Section 713 of Title 3A of the Oklahoma Statutes.

12 SECTION 32. There is hereby appropriated to the Oklahoma  
13 State Regents for Higher Education from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury  
15 for the fiscal year ending June 30, 2015, the sum of Four  
16 Million Nine Hundred Two Thousand Five Hundred Fifty Dollars  
17 (\$4,902,550.00) or so much thereof as may be necessary for the  
18 general operating budget of the Administrative Offices of the  
19 Oklahoma State Regents for Higher Education.

20 SECTION 33. There is hereby appropriated to the Physician  
21 Manpower Training Commission from any monies not otherwise  
22 appropriated from the General Revenue Fund of the State Treasury  
23 for the fiscal year ending June 30, 2015, the sum of Three  
24 Million Seven Hundred Thirty-eight Thousand Three Hundred

1 Ninety-five Dollars (\$3,738,395.00) or so much thereof as may be  
2 necessary to perform the duties imposed upon the Physician  
3 Manpower Training Commission by law.

4 SECTION 34. There is hereby appropriated to the Physician  
5 Manpower Training Commission from any monies not otherwise  
6 appropriated from the Special Cash Fund of the State Treasury  
7 the sum of Four Hundred Thousand Dollars (\$400,000.00) or so  
8 much thereof as may be necessary to perform the duties imposed  
9 upon the Physician Manpower Training Commission by law.

10 SECTION 35. There is hereby appropriated to the Oklahoma  
11 Center for the Advancement of Science and Technology from any  
12 monies not otherwise appropriated from the General Revenue Fund  
13 of the State Treasury for the fiscal year ending June 30, 2015,  
14 the sum of Sixteen Million Eight Hundred Thirty-one Thousand  
15 Eight Hundred Nineteen Dollars (\$16,831,819.00) or so much  
16 thereof as may be necessary to perform the duties imposed upon  
17 the Oklahoma Center for the Advancement of Science and  
18 Technology by law. Of those funds appropriated, the sum of  
19 Twelve Million Four Hundred Thirty-four Thousand One Hundred Six  
20 Dollars (\$12,434,106.00) shall be deposited in the Research  
21 Support Revolving Fund, created pursuant to Section 5060.11 of  
22 Title 74 of the Oklahoma Statutes. Of those funds appropriated,  
23 the sum of Three Million Seven Hundred Forty-eight Thousand Two  
24 Hundred Five Dollars (\$3,748,205.00) shall be deposited in the

1 Seed-capital Revolving Fund, created pursuant to Section 5060.21  
2 of Title 74 of the Oklahoma Statutes.

3 GENERAL GOVERNMENT AND TRANSPORTATION

4 SECTION 36. There is hereby appropriated to the Office of  
5 the State Auditor and Inspector from any monies not otherwise  
6 appropriated from the General Revenue Fund of the State Treasury  
7 for the fiscal year ending June 30, 2015, the sum of Four  
8 Million One Hundred Fifty-eight Thousand Nine Hundred Seventy-  
9 six Dollars (\$4,158,976.00) or so much thereof as may be  
10 necessary to perform the duties imposed upon the Office of the  
11 State Auditor and Inspector by law.

12 SECTION 37. There is hereby appropriated to the Office of  
13 the State Auditor and Inspector from any monies not otherwise  
14 appropriated from the General Revenue Fund of the State Treasury  
15 for the fiscal year ending June 30, 2015, the sum of Two Hundred  
16 Eighty-nine Thousand One Hundred Twenty-six Dollars  
17 (\$289,126.00) or so much thereof as may be necessary to perform  
18 the duties imposed upon the Commission on County Government  
19 Personnel Education and Training. The appropriation made in  
20 this section shall be expended exclusively for the purpose so  
21 stated and shall not be transferable.

22 SECTION 38. There is hereby appropriated to the Office of  
23 the State Bond Advisor from any monies not otherwise  
24 appropriated from the General Revenue Fund of the State Treasury



1 for the fiscal year ending June 30, 2015, the sum of One Hundred  
2 Thirty-five Thousand Two Hundred Forty Dollars (\$135,240.00) or  
3 so much thereof as may be necessary to perform the duties  
4 imposed upon the Office of the State Bond Advisor by law.

5 SECTION 39. There is hereby appropriated to the State  
6 Election Board from any monies not otherwise appropriated from  
7 the General Revenue Fund of the State Treasury for the fiscal  
8 year ending June 30, 2015, the sum of Five Million Three Hundred  
9 Five Thousand Eight Hundred Eight Dollars (\$5,305,808.00) or so

21 necessary for watershed flood control programs.

22 SECTION 140. There is hereby appropriated to the Scenic  
23 Rivers Commission from any monies not otherwise appropriated  
24 from the General Revenue Fund of the State Treasury for the

1 fiscal year ending June 30, 2013, the sum of Ninety-four  
2 Thousand Dollars (\$94,000.00) or so much thereof as may be  
3 necessary to perform the duties imposed upon the Scenic Rivers  
4 Commission by law.

5 SECTION 141. There is hereby appropriated to the Oklahoma  
6 Water Resources Board from any monies not otherwise appropriated  
7 from the General Revenue Fund of the State Treasury for the  
8 fiscal year ending June 30, 2013, the sum of One Million Five
