7 A Joint Resolution directing the Secretary of State
8 to refer to the people for their approval or
9 rejection a proposed amendment to Section 12 of
10 Article II of the Oklahoma Constitution; providing
11 that certain provision not be construed to prohibit
12 certain military service; allowing Legislature to
13 enact implementing laws; providing ballot title; and
14 directing filing.

15 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
16 1ST SESSION OF THE 54TH OKLAHOMA LEGISLATURE:

17 SECTION 1. The Secretary of State shall refer to the people for
18 their approval or rejection, as and in the manner provided by law,
19 the following proposed amendment to Section 12 of Article II of the
20 Oklahoma Constitution to read as follows:

21 Section 12. No member of Congress from this State, or person
22 holding any office of trust or profit under the laws of any other
23 State, or of the United States, shall hold any office of trust or
24 profit under the laws of this State; provided, neither the
provisions of this section nor any other provision of this
Constitution or state law shall be construed to prohibit the

1 following officeholders from holding at the same time any other
2 office of trust or profit:

- 3 1. Officers and enlisted members of the National Guard;
- 4 2. Officers and enlisted members of the National Guard Reserve;
- 5 3. Officers of the Officers Reserve Corps of the United States;
- 6 4. Enlisted members of the Organized Reserves of the United
7 States; and

8 5. Officers and enlisted members of the Oklahoma State Guard
9 and any other active militia or military force organized under state
10 law.

11 The Legislature shall have the power to enact laws to further
12 implement the provisions of this section.

13 SECTION 2. The Ballot Title for the proposed Constitutional
14 amendment as set forth in SECTION 1 of this resolution shall be in
15 the following form:

18 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

19 This measure amends Section 12 of Article 2 of the state
20 Constitution. This section prohibits the holding of more than
21 one office at the same time. It applies to certain offices.
22 This measure would not allow the law to be construed to keep
23 some people from holding two offices at the same time. It would
24 apply to officers and enlisted members of the National Guard,

1 and the National Guard Reserve. It would also apply to the
2 Oklahoma State Guard and any other active militia or military
3 force organized under state law. It would also apply to
4 officers of the Officers Reserve Corps of the United States and
5 enlisted members of the Organized Reserves of the United States.
6 The Legislature could pass laws to put these changes in place.
