6 Food, and Forestry, the Oklahoma Department of
7 Commerce, the Rural Economic Action Plan Fund, the
8 Oklahoma Conservation Commission, the Department of
9 Consumer Credit, the Corporation Commission, the
10 Department of Environmental Quality, the Oklahoma
11 Historical Society, the Oklahoma Horse Racing
12 Commission, the Insurance Department, the J.M. Davis
13 Memorial Commission, the Department of Labor, the
14 Department of Mines, the Scenic Rivers Commission,
15 the Oklahoma Tourism and Recreation Department, the
16 Oklahoma Water Resources Board, the Will Rogers
17 Memorial Commission, the Alcoholic Beverage Laws
18 Enforcement Commission, the Department of
19 Corrections, the Office of the State Fire Marshal,
20 the Oklahoma State Bureau of Investigation, the
21 Council on Law Enforcement Education and Training,
22 the Board of Medicolegal Investigations, the Oklahoma
23 State Bureau of Narcotics and Dangerous Drugs
24 Control, the Department of Public Safety, the Office
of the Attorney General, district attorneys and the
District Attorneys Council, the Court of Criminal
Appeals, the Supreme Court, the Oklahoma Indigent
Defense System, the Pardon and Parole Board, and the
Workers' Compensation Court; stating amounts of the
appropriations; stating purposes and restrictions;
authorizing and requiring certain expenditures;
authorizing and requiring certain transfers;
requiring certain deposit; reappropriating and
redesignating certain funds; and providing effective
dates.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

COMMON EDUCATION

SECTION 1. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the

1 General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2014, the sum of Nine Hundred Eighty-six Million Six
3 Hundred Seventy-two Thousand Eight Hundred Seventy-six Dollars
4 (\$986,672,876.00) or so much thereof as may be necessary for the
5 financial support of public schools.

6 SECTION 2. There is hereby appropriated to the State Board of
7 Education from any monies not otherwise appropriated from the
8 Education Reform Revolving Fund created in Section 34.89 of Title 62
9 of the Oklahoma Statutes, the sum of Seven Hundred Sixty-seven
10 Million Six Hundred Ninety-one Thousand Seven Hundred Fourteen
11 Dollars (\$767,691,714.00) or so much thereof as may be necessary for
12 the financial support of public schools.

13 SECTION 3. The State Board of Education is hereby authorized to
14 expend during the fiscal year ending June 30, 2014, from the Common
15 Education Technology Revolving Fund of the State Treasury, the sum
16 of Forty-seven Million Three Hundred Seventy-two Thousand Two
17 Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as
18 may be necessary for the financial support of public schools.

19 SECTION 4. There is hereby appropriated to the State Board of
20 Education from any monies not otherwise appropriated from the
21 Mineral Leasing Fund of the State Treasury for the fiscal year
22 ending June 30, 2014, the sum of Three Million Three Hundred Twenty-
23 five Thousand Dollars (\$3,325,000.00) or so much thereof as may be
24 necessary for the financial support of public schools.

1 SECTION 5. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Mineral Leasing Fund of the State Treasury for the fiscal year
4 ending June 30, 2012, the sum of One Million Seven Hundred Fifty-six
5 Thousand Four Hundred Twenty-two Dollars (\$1,756,422.00) or so much
6 thereof as may be necessary for the financial support of public
7 schools.

8 SECTION 6. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2014, the sum of Twenty-five Million One
12 Hundred Fifty-seven Thousand Six Hundred Forty-nine Dollars
13 (\$25,157,649.00) or so much thereof as may be necessary for the
14 financial support of public schools.

15 SECTION 7. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2012, the sum of Five Million Five
19 Hundred Ninety-four Thousand Eight Hundred Nineteen Dollars
20 (\$5,594,819.00) or so much thereof as may be necessary for the
21 financial support of public schools.

22 SECTION 8. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2014, the sum of Five Hundred Seven Million Seven
2 Hundred Seventy-two Thousand Seven Hundred Eighty-one Dollars
3 (\$507,772,781.00) or so much thereof as may be necessary for the
4 support of public schools activities.

5 SECTION 9. There is hereby appropriated to the State Board of
6 Education from any monies not otherwise appropriated from the
7 General Revenue Fund of the State Treasury for the fiscal year
8 ending June 30, 2012, the sum of Thirty-three Million Dollars
9 (\$33,000,000.00) or so much thereof as may be necessary for the
10 purchase of textbooks and instructional materials.

11 SECTION 10. There is hereby appropriated to the State Board of
12 Education from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2014, the sum of Twenty-two Million Four Hundred
15 Twenty-six Thousand Six Hundred Forty-two Dollars (\$22,426,642.00)
16 or so much thereof as may be necessary for administrative and
17 support functions of the State Department of Education.

18 SECTION 11. There is hereby appropriated to the State Board of
19 Education from any monies not otherwise appropriated from the
20 Oklahoma Education Lottery Trust Fund of the State Treasury for the
21 fiscal year ending June 30, 2014, the sum of Two Million Seven
22 Hundred Ninety-five Thousand Two Hundred Ninety-four Dollars
23 (\$2,795,294.00) or so much thereof as may be necessary for transfer
24 to the School Consolidation Assistance Fund.

1 SECTION 12. There is hereby appropriated to the State Board of
2 Education from any monies not otherwise appropriated from the
3 Oklahoma Education Lottery Trust Fund of the State Treasury for the
4 fiscal year ending June 30, 2012, the sum of Six Hundred Twenty-one
5 Thousand Six Hundred Forty-six Dollars (\$621,646.00) or so much
6 thereof as may be necessary for transfer to the School Consolidation
7 Assistance Fund.

8 SECTION 13. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 Oklahoma Education Lottery Trust Fund of the State Treasury for the
11 fiscal year ending June 30, 2014, the sum of Two Million Seven
12 Hundred Ninety-five Thousand Two Hundred Ninety-four Dollars
13 (\$2,795,294.00) or so much thereof as may be necessary for transfer
14 to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

15 SECTION 14. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 Oklahoma Education Lottery Trust Fund of the State Treasury for the
18 fiscal year ending June 30, 2012, the sum of Six Hundred Twenty-one
19 Thousand Six Hundred Forty-six Dollars (\$621,646.00) or so much
20 thereof as may be necessary for transfer to the Teachers' Retirement
21 System Dedicated Revenue Revolving Fund.

22 SECTION 15. There is hereby appropriated to the Oklahoma Arts
23 Council from any monies not otherwise appropriated from the General
24 Revenue Fund of the State Treasury for the fiscal year ending June

1 30, 2014, the sum of Four Million Ten Thousand Eighty-seven Dollars
2 (\$4,010,087.00) or so much thereof as may be necessary to perform
3 the duties imposed upon the Oklahoma Arts Council by law.

4 SECTION 16. There is hereby appropriated to the Commissioners
5 of the Land Office from any monies not otherwise appropriated from
6 the Commissioners of the Land Office Fund of the State Treasury for
7 the fiscal year ending June 30, 2014, the sum of Fifteen Million
8 Sixty-two Thousand Two Hundred Fifty Dollars (\$15,062,250.00) or so
9 much thereof as may be necessary to perform the duties imposed upon
10 the Commissioners of the Land Office by law.

11 SECTION 17. There is hereby appropriated to the Board of
12 Trustees of the Oklahoma School of Science and Mathematics from any
13 monies not otherwise appropriated from the General Revenue Fund of
14 the State Treasury for the fiscal year ending June 30, 2014, the sum
15 of Six Million Three Hundred Thirty-two Thousand Two Hundred
16 Seventy-four Dollars (\$6,332,274.00) or so much thereof as may be
17 necessary to perform the duties imposed upon the Board of Trustees
18 of the Oklahoma School of Science and Mathematics by law.

19 SECTION 18. There is hereby appropriated to the Office of
20 Educational Quality and Accountability from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2014, the sum of Six Hundred Sixty-
23 one Thousand Two Hundred Seventy-one Dollars (\$661,271.00) or so
24 much thereof as may be necessary for the Office of Educational

1 Quality and Accountability to perform the duties imposed upon the
2 Office of Educational Quality and Accountability by law.

3 SECTION 19. There is hereby appropriated to the Oklahoma
4 Commission for Teacher Preparation from any monies not otherwise
5 appropriated from the General Revenue Fund of the State Treasury for
6 the fiscal year ending June 30, 2014, the sum of One Million Five
7 Hundred Twenty-six Thousand One Hundred Seventy-nine Dollars
8 (\$1,526,179.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Oklahoma Commission for Teacher
10 Preparation by law.

11 CAREER AND TECHNOLOGY EDUCATION

12 SECTION 20. There is hereby appropriated to the State Board of
13 Career and Technology Education from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2014, the sum of One Hundred Thirty-
16 four Million Three Hundred Eighty-three Thousand Nine Hundred
17 Eighty-four Dollars (\$134,383,984.00) or so much thereof as may be
18 necessary to perform the duties imposed upon the State Board of
19 Career and Technology Education by law.

20 SECTION 21. There is hereby appropriated to the State Board of
21 Career and Technology Education from any monies not otherwise
22 appropriated from the Oklahoma Education Lottery Trust Fund of the
23 State Treasury for the fiscal year ending June 30, 2014, the sum of
24 Three Million Seventy-four Thousand Eight Hundred Twenty-three

1 Dollars (\$3,074,823.00) pursuant to paragraph 2 of subsection C of
2 Section 713 of Title 3A of the Oklahoma Statutes for allocation by
3 the State Board of Career and Technology Education for the education
4 and general operating budgets of the institutions and for other
5 programs, construction, renovations or repairs administered by the
6 State Board of Career and Technology Education.

7 SECTION 22. There is hereby appropriated to the State Board of
8 Career and Technology Education from any monies not otherwise
9 appropriated from the Oklahoma Education Lottery Trust Fund of the
10 State Treasury for the fiscal year ending June 30, 2012, the sum of
11 Six Hundred Eighty-three Thousand Eight Hundred Eleven Dollars
12 (\$683,811.00) pursuant to paragraph 2 of subsection C of Section 713
13 of Title 3A of the Oklahoma Statutes for allocation by the State
14 Board of Career and Technology Education for the education and
15 general operating budgets of the institutions and for other
16 programs, construction, renovations or repairs administered by the
17 State Board of Career and Technology Education.

18 SECTION 23. There is hereby appropriated to the Oklahoma
19 Educational Television Authority from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2014, the sum of Three Million Eight
22 Hundred Twenty-two Thousand Three Hundred Twenty-eight Dollars
23 (\$3,822,328.00) or so much thereof as may be necessary to perform
24

1 the duties imposed upon the Oklahoma Educational Television
2 Authority by law.

3 SECTION 24. There is hereby appropriated to the Oklahoma
4 Department of Libraries from any monies not otherwise appropriated
5 from the General Revenue Fund of the State Treasury for the fiscal
6 year ending June 30, 2014, the sum of Five Million Eight Hundred
7 Ninety-eight Thousand Six Hundred Thirty-three Dollars
8 (\$5,898,633.00) or so much thereof as may be necessary to perform
9 the duties imposed upon the Oklahoma Department of Libraries by law.

10 HIGHER EDUCATION

11 SECTION 25. There is hereby appropriated to the Oklahoma State
12 Regents for Higher Education from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2014, the sum of Eight Hundred Ten
15 Million Six Hundred Seventy-three Thousand Eight Hundred Fifty-two
16 Dollars (\$810,673,852.00) or so much thereof as may be necessary for
17 allocation by the Oklahoma State Regents for Higher Education
18 pursuant to the provisions of Article XIII-A of the Oklahoma
19 Constitution for the education and general operating budgets of the
20 institutions and for other programs, construction, renovations or
21 repairs administered by the Oklahoma State Regents for Higher
22 Education. Of those funds appropriated, the sum of Three Million
23 Eight Hundred Thirty Thousand Thirty-eight Dollars (\$3,830,038.00)
24 shall be transferred to the Oklahoma Tuition Equalization Grant

1 Trust Fund to implement the provisions of the Oklahoma Tuition
2 Equalization Grant Act.

3 SECTION 26. The Oklahoma State Regents for Higher Education are
4 hereby authorized to expend during the fiscal year ending June 30,
5 2014, the sum of Forty-seven Million Three Hundred Seventy-two
6 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
7 Higher Education Capital Revolving Fund of the State Treasury for
8 allocation by the Oklahoma State Regents for Higher Education
9 pursuant to the provisions of Article XIII-A of the Oklahoma
10 Constitution for the education and general operating budgets of the
11 institutions and for other programs, construction, renovations or
12 repairs administered by the Oklahoma State Regents for Higher
13 Education.

14 SECTION 27. The Oklahoma State Regents for Higher Education are
15 hereby authorized to expend during the fiscal year ending June 30,
16 2014, the sum of Forty-seven Million Three Hundred Seventy-two
17 Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the
18 Oklahoma Student Aid Revolving Fund of the State Treasury for
19 allocation by the Oklahoma State Regents for Higher Education
20 pursuant to the provisions of Article XIII-A of the Oklahoma
21 Constitution for the education and general operating budgets of the
22 institutions and for other programs, construction, renovations or
23 repairs administered by the Oklahoma State Regents for Higher
24 Education.

1 SECTION 28. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the Special Cash Fund of the State Treasury the
4 sum of Fifty Million Dollars (\$50,000,000.00) for allocation by the
5 Oklahoma State Regents for Higher Education pursuant to the
6 provisions of Article XIII-A of the Oklahoma Constitution for the
7 education and general operating budgets of the institutions and for
8 other programs, construction, renovations or repairs administered by
9 the Oklahoma State Regents for Higher Education.

10 SECTION 29. There is hereby appropriated to the Oklahoma State
11 Regents for Higher Education from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for
13 the fiscal year ending June 30, 2014, the sum of One Million Two
14 Hundred Thirty-four Thousand One Hundred Seventy-four Dollars
15 (\$1,234,174.00) or so much thereof as may be necessary for
16 expenditures for concurrent enrollment pursuant to Section 628.13 of
17 Title 70 of the Oklahoma Statutes.

18 SECTION 30. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the Oklahoma Education Lottery Trust Fund of the
21 State Treasury for the fiscal year ending June 30, 2014, the sum of
22 Twenty-two Million Eighty-two Thousand Eight Hundred Twenty-five
23 Dollars (\$22,082,825.00) pursuant to paragraph 2 of subsection C of
24 Section 713 of Title 3A of the Oklahoma Statutes for allocation by

1 the Oklahoma State Regents for Higher Education pursuant to the
2 provisions of Article XIII-A of the Oklahoma Constitution for
3 construction, renovations or repairs administered by the Oklahoma
4 State Regents for Higher Education or for any other purpose
5 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
6 of the Oklahoma Statutes.

7 SECTION 31. There is hereby appropriated to the Oklahoma State
8 Regents for Higher Education from any monies not otherwise
9 appropriated from the Oklahoma Education Lottery Trust Fund of the
10 State Treasury for the fiscal year ending June 30, 2012, the sum of
11 Four Million Nine Hundred Eleven Thousand Eight Dollars
12 (\$4,911,008.00) pursuant to paragraph 2 of subsection C of Section
13 713 of Title 3A of the Oklahoma Statutes for allocation by the
14 Oklahoma State Regents for Higher Education pursuant to the
15 provisions of Article XIII-A of the Oklahoma Constitution for
16 construction, renovations or repairs administered by the Oklahoma
17 State Regents for Higher Education or for any other purpose
18 authorized by paragraph 2 of subsection C of Section 713 of Title 3A
19 of the Oklahoma Statutes.

20 SECTION 32. There is hereby appropriated to the Oklahoma State
21 Regents for Higher Education from any monies not otherwise
22 appropriated from the General Revenue Fund of the State Treasury for
23 the fiscal year ending June 30, 2014, the sum of Four Million Nine
24 Hundred Two Thousand Five Hundred Fifty Dollars (\$4,902,550.00) or

1 so much thereof as may be necessary for the general operating budget
2 of the Administrative Offices of the Oklahoma State Regents for
3 Higher Education.

4 SECTION 33. There is hereby appropriated to the Physician
5 Manpower Training Commission from any monies not otherwise
6 appropriated from the General Revenue Fund of the State Treasury for
7 the fiscal year ending June 30, 2014, the sum of Three Million Nine
8 Hundred Seventy-nine Thousand Two Hundred Fifty-four Dollars
9 (\$3,979,254.00) or so much thereof as may be necessary to perform
10 the duties imposed upon the Physician Manpower Training Commission
11 by law.

12 SECTION 34. There is hereby appropriated to the Physician
13 Manpower Training Commission from any monies not otherwise
14 appropriated from the Special Cash Fund of the State Treasury, the
15 sum of Four Hundred Thousand Dollars (\$400,000.00) or so much
16 thereof as may be necessary to perform the duties imposed upon the
17 Physician Manpower Training Commission by law.

18 SECTION 35. There is hereby appropriated to the Oklahoma Center
19 for the Advancement of Science and Technology from any monies not
20 otherwise appropriated from the General Revenue Fund of the State
21 Treasury for the fiscal year ending June 30, 2014, the sum of
22 Seventeen Million Eight Hundred Eleven Thousand Four Hundred Forty-
23 nine Dollars (\$17,811,449.00) or so much thereof as may be necessary
24 to perform the duties imposed upon the Oklahoma Center for the

1 Advancement of Science and Technology by law. Of those funds
2 appropriated, the sum of Thirteen Million One Hundred Fifty-seven
3 Thousand Seven Hundred Eighty-four Dollars (\$13,157,784.00) shall be
4 deposited in the Research Support Revolving Fund created pursuant to
5 Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those
6 funds appropriated, the sum of Three Million Nine Hundred Sixty-Six
7 Thousand Three Hundred Fifty-five Dollars (\$3,966,355.00) shall be
8 deposited in the Seed-Capital Revolving Fund created pursuant to
9 Section 5060.21 of Title 74 of the Oklahoma Statutes.

10 GENERAL GOVERNMENT AND TRANSPORTATION

11 SECTION 36. There is hereby appropriated to the Office of the
12 State Auditor and Inspector from any monies not otherwise
13 appropriated from the General Revenue Fund of the State Treasury for
14 the fiscal year ending June 30, 2014, the sum of Four Million Three
15 Hundred Ninety-nine Thousand Eight Hundred Twenty Dollars
16 (\$4,399,820.00) or so much thereof as may be necessary to perform
17 the duties imposed upon the Office of the State Auditor and
18 Inspector by law.

19 SECTION 37. There is hereby appropriated to the Office of the
20 State Auditor and Inspector from any monies not otherwise
21 appropriated from the General Revenue Fund of the State Treasury for
22 the fiscal year ending June 30, 2014, the sum of Three Hundred Seven
23 Thousand One Hundred Sixty-six Dollars (\$307,166.00) or so much
24 thereof as may be necessary to perform the duties imposed upon the

1 Commission on County Government Personnel Education and Training.
2 The appropriation made in this section shall be expended exclusively
3 for the purpose so stated and shall not be transferable.

4 SECTION 38. There is hereby appropriated to the Office of the
5 State Bond Advisor from any monies not otherwise appropriated from
6 the General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2014, the sum of One Hundred Forty-three Thousand
8 One Hundred Twelve Dollars (\$143,112.00) or so much thereof as may
9 be necessary to perform the duties imposed upon the Office of the
10 State Bond Advisor by law.

11 SECTION 39. There is hereby appropriated to the State Election
12 Board from any monies not otherwise appropriated from the General
13 Revenue Fund of the State Treasury for the fiscal year ending June
14 30, 2014, the sum of Seven Million Eight Hundred Five Thousand Eight
15 Hundred Eight Dollars (\$7,805,808.00) or so much thereof as may be
16 necessary to perform the duties imposed upon the State Election
17 Board by law.

18 SECTION 40. There is hereby appropriated to the Oklahoma
19 Department of Emergency Management from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2014, the sum of Six Hundred Fifty-
22 one Thousand One Hundred Seventy-nine Dollars (\$651,179.00) or so
23 much thereof as may be necessary to perform the duties imposed upon
24 the Oklahoma Department of Emergency Management by law.

1 SECTION 41. There is hereby appropriated to the Ethics
2 Commission from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2014, the sum of Seven Hundred Thirty-eight Thousand

10 SECTION 95. There is hereby appropriated to the Oklahoma
11 Tourism and Recreation Department from any monies not otherwise
12 appropriated from the General Revenue Fund of the State Treasury for
13 the fiscal year ending June 30, 2014, the sum of Twenty-one Million
14 Eight Hundred Three Thousand Three Dollars (\$21,803,003.00) or so
15 much thereof as may be necessary to perform the duties imposed upon
16 the Oklahoma Tourism and Recreation Department by law.

17 SECTION 96. There is hereby appropriated to the Oklahoma Water
18 Resources Board from any monies not otherwise appropriated from the
19 General Revenue Fund of the State Treasury for the fiscal year

2 Resources Board from any monies not otherwise appropriated from the
3 Special Cash Fund of the State Treasury, the sum of Three Million
4 Dollars (\$3,000,000.00) or so much thereof as may be necessary for
5 drought relief programs.

6 SECTION 98. There is hereby appropriated to the Will Rogers
7 Memorial Commission from any monies not otherwise appropriated from
8 the General Revenue Fund of the State Treasury for the fiscal year
9 ending June 30, 2014, the sum of Seven Hundred Forty Thousand Four
10 Hundred Eighty-six Dollars (\$740,486.00) or so much thereof as may
11 be necessary to perform the duties imposed upon the Will Rogers
12 Memorial Commission by law.

13 PUBLIC SAFETY

14 SECTION 99. There is hereby appropriated to the Alcoholic
15 Beverage Laws Enforcement Commission from any monies not otherwise
16 appropriated from the General Revenue Fund of the State Treasury for
17 the fiscal year ending June 30, 2014, the sum of Three Million One
18 Hundred Forty Thousand Three Hundred Thirty-four Dollars
19 (\$3,140,334.00) or so much thereof as may be necessary to perform
20 the duties imposed upon the Alcoholic Beverage Laws Enforcement
21 Commission by law.

22 SECTION 100. There is hereby appropriated to the Department of
23 Corrections from any monies not otherwise appropriated from the
24 Special Cash Fund of the State Treasury, the sum of Seven Million

1 Eight Hundred Sixty-nine Thousand Seven Hundred Thirty-four Dollars
2 (\$7,869,734.00) or so much thereof as may be necessary to perform
3 the duties imposed upon the Department of Corrections by law.

4 SECTION 101. There is hereby appropriated to the Department of
5 Corrections from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2012, the sum of Twelve Million One Hundred Thirty
8 Thousand Two Hundred Sixty-six Dollars (\$12,130,266.00) or so much
9 thereof as may be necessary to perform the duties imposed upon the
10 Department of Corrections by law.

11 SECTION 102. There is hereby appropriated to the Department of
12 Corrections from any monies not otherwise appropriated from the
13 General Revenue Fund of the State Treasury for the fiscal year
14 ending June 30, 2014, the sum of Four Hundred Forty-three Million
15 Seven Hundred Thirty-one Thousand Sixty-eight Dollars
16 (\$443,731,068.00) or so much thereof as may be necessary to perform

22 six Thousand Seven Hundred Sixty-four Dollars (\$1,796,764.00) or so
23 much thereof as may be necessary to perform the duties imposed upon
24 the Office of the State Fire Marshal by law.

1 SECTION 104. There is hereby appropriated to the Oklahoma State
2 Bureau of Investigation from any monies not otherwise appropriated
3 from the General Revenue Fund of the State Treasury for the fiscal
4 year ending June 30, 2014, the sum of Fourteen Million Two Hundred
5 Eighty-three Thousand Fifty-nine Dollars (\$14,283,059.00) or so much
6 thereof as may be necessary to perform the duties imposed upon the
7 Oklahoma State Bureau of Investigation by law. Of the funds
8 appropriated herein, a maximum of One Hundred Thousand Dollars

22 Eight Hundred Ninety-eight Dollars (\$3,160,898.00) or so much
23 thereof as may be necessary to perform the duties imposed upon the
24 Council on Law Enforcement Education and Training by law.

1 SECTION 106. There is hereby appropriated to the Council on Law
2 Enforcement Education and Training from any monies not otherwise
3 appropriated from the C.L.E.E.T. Fund for the fiscal year ending
4 June 30, 2012, the sum of One Hundred Forty-four Thousand Five
5 Hundred Seventy Dollars (\$144,570.00) or so much thereof as may be
6 necessary to perform the duties imposed upon the Council on Law
7 Enforcement Education and Training by law.

8 SECTION 107. There is hereby appropriated to the Council on Law
9 Enforcement Education and Training from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2012, the sum of Four Hundred Fifty-
12 two Thousand Ninety-two Dollars (\$452,092.00) or so much thereof as
13 may be necessary to perform the duties imposed upon the Council on
14 Law Enforcement Education and Training by law.

15 SECTION 108. There is hereby appropriated to the Board of
16 Medicolegal Investigations from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2014, the sum of Eight Million Six
19 Hundred Ninety-eight Thousand Two Hundred Eighty-one Dollars
20 (\$8,698,281.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Board of Medicolegal Investigations by
22 law.

23 SECTION 109. There is hereby appropriated to the Oklahoma State
24 Bureau of Narcotics and Dangerous Drugs Control from any monies not

1 otherwise appropriated from the General Revenue Fund of the State
2 Treasury for the fiscal year ending June 30, 2014, the sum of Three
3 Million Six Hundred Sixteen Thousand Four Hundred Eighteen Dollars
4 (\$3,616,418.00) or so much thereof as may be necessary to perform
5 the duties imposed upon the Oklahoma State Bureau of Narcotics and

7 SECTION 110. There is hereby appropriated to the Department of
8 Public Safety from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2014, the sum of Ninety Million Four Hundred Sixteen
11 Thousand Seven Hundred Ninety Dollars (\$90,416,790.00) or so much
12 thereof as may be necessary to perform the duties imposed upon the
13 Department of Public Safety by law.

15 SECTION 111. There is hereby appropriated to the Office of the
16 Attorney General from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2014, the sum of Fourteen Million Three Hundred
19 Twenty-three Thousand Four Hundred Fifteen Dollars (\$14,323,415.00)
20 or so much thereof as may be necessary to perform the duties imposed
21 upon the Office of the Attorney General by law.

22 SECTION 112. There is hereby appropriated to the Office of the
23 Attorney General from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2014, the sum of Nine Hundred Four Thousand Seven
2 Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal
3 Services Revolving Fund created pursuant to subsection G of Section
4 921.1 of Title 12 of the Oklahoma Statutes.

5 SECTION 113. For the fiscal year ending June 30, 2014, the
6 Office of the Attorney General is authorized to transfer an amount
7 not to exceed Three Hundred Twenty Thousand Four Hundred Thirty
8 Dollars (\$320,430.00) from the Office of the Attorney General's
9 Evidence Fund (700 Fund), created by Section 19 of Title 74 of the
10 Oklahoma Statutes to the Office of the Attorney General's Revolving
11 Fund (200 Fund) created by Section 20 of Title 74 of the Oklahoma
12 Statutes.

13 SECTION 114. There is hereby appropriated to the District
14 Attorneys Council from any monies not otherwise appropriated from
15 the General Revenue Fund of the State Treasury for the fiscal year
16 ending June 30, 2014, the sum of Thirty-nine Million Six Hundred
17 Eighty-seven Thousand Two Hundred Fifty-eight Dollars
18 (\$39,687,258.00) or so much thereof as may be necessary to perform
19 the duties imposed upon the district attorneys and the District
20 Attorneys Council by law. Of the funds appropriated herein, the
21 District Attorneys Council shall transfer up to the sum of Four
22 Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so
23 much thereof as may be required by the district attorneys and
24 District Attorneys Council to the District Attorneys Evidence Fund

1 for necessary expenses relative to any case within the official

21 created by Section 142.17 of Title 21 of the Oklahoma Statutes, to

1 SECTION 118. For the fiscal year ending June 30, 2014, up to
2 One Million Five Hundred One Thousand Three Hundred Seventy-five
3 Dollars (\$1,501,375.00) is authorized to be transferred from the
4 Crime Victims Compensation Revolving Fund, created by Section 142.17
5 of Title 21 of the Oklahoma Statutes, to the District Attorneys
6 Council for duties to support Victim-Witness Services.

7 SECTION 119. There is hereby appropriated to the Court of
8 Criminal Appeals from any monies not otherwise appropriated from the
9 General Revenue Fund of the State Treasury for the fiscal year
10 ending June 30, 2014, the sum of Three Million Six Hundred Thirty-
11 four Thousand Six Hundred Thirty-one Dollars (\$3,634,631.00) or so
12 much thereof as may be necessary to perform the duties imposed upon
13 the Court of Criminal Appeals by law.

14 SECTION 120. The Supreme Court is hereby authorized to expend
15 during the fiscal year ending June 30, 2014, from the State Judicial
16 Revolving Fund of the State Treasury, the sum of Forty-three Million
17 Dollars (\$43,000,000.00) or so much thereof as may be necessary for
18 the financial support of the District Courts.

19 SECTION 121. There is hereby appropriated to the Supreme Court
20 from any monies not otherwise appropriated from the General Revenue
21 Fund of the State Treasury for the fiscal year ending June 30, 2014,
22 the sum of Sixteen Million Six Hundred Thousand Dollars
23 (\$16,600,000.00) or so much thereof as may be necessary to perform
24 the duties imposed upon the District Courts by law.

1 SECTION 122. For the fiscal year ending June 30, 2014, the
2 Office of Management and Enterprise Services shall, at the request
3 of the Administrative Director of the Courts, transfer from the
4 State Judicial Revolving Fund to the Supreme Court Administrative
5 Revolving Fund an amount not to exceed Two Million Dollars
6 (\$2,000,000.00) that the Administrative Director of the Courts, with

3 SECTION 125. There is hereby appropriated to the Pardon and
4 Parole Board from any monies not otherwise appropriated from the
5 General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2014, the sum of Two Million Two Hundred Seventeen
7 Thousand Four Hundred Fifty-four Dollars (\$2,217,454.00) or so much
8 thereof as may be necessary to perform the duties imposed upon the
9 Pardon and Parole Board by law.

10 SECTION 126. There is hereby appropriated to the Pardon and
11 Parole Board from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2012, the sum of Seventy-five Thousand Dollars
14 (\$75,000.00) or so much thereof as may be necessary to perform the
15 duties imposed upon the Pardon and Parole Board by law.

16 SECTION 127. There is hereby appropriated to the Supreme Court
17 from any monies not otherwise appropriated from the General Revenue
18 Fund of the State Treasury for the fiscal year ending June 30, 2014,
19 the sum of Seventeen Million Three Hundred Thousand Dollars
20 (\$17,300,000.00) or so much thereof as may be necessary to perform
21 the duties imposed upon the Supreme Court or Court of Civil Appeals
22 by law.

23 SECTION 128. There is hereby appropriated to the Workers'
24 Compensation Court from any monies not otherwise appropriated from

1 the General Revenue Fund of the State Treasury for the fiscal year
2 ending June 30, 2014, the sum of Five Million Seven Hundred Forty-
3 seven Thousand One Hundred Sixty-six Dollars (\$5,747,166.00) or so
4 much thereof as may be necessary to perform the duties imposed upon
5 the Workers' Compensation Court by law.

6 SECTION 129. From the appropriation made in Section 128 of this
7 act, beginning on the effective date of Section 28 of Enrolled
8 Senate Bill No. 1062 of the 1st Session of the 54th Oklahoma
9 Legislature, the Director of the Office of Management and Enterprise
10 Services shall transfer, for the fiscal year ending June 30, 2014,
11 an amount not to exceed One Million Five Hundred Thousand Dollars
12 (\$1,500,000.00) to the Workers' Compensation Fund created pursuant
13 to Section 28 of Enrolled Senate Bill No. 1062 of the 1st Session of

16 SECTION 130. There is hereby appropriated to the Oklahoma State
17 University Medical Authority from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the Fiscal year ending June 30, 2014, the sum of Thirteen Million
20 Dollars (\$13,000,000.00) or so much thereof as may be necessary for
21 the purposes of the support of the graduate medical education
22 programs affiliated with the OSU Medical Center and/or the OSU
23 Center for Health Sciences. Funds appropriated shall be retained
24 and not expended by the Oklahoma State University Medical Authority

1 for the support of the graduate medical education programs
2 affiliated with the OSU Medical Center until such time as the
3 Oklahoma State University Medical Authority has clear title to the
4 assets, licenses, property and has all necessary functional
5 authorities of the OSU Medical Center.

6 SECTION 131. There is hereby appropriated to the Maintenance of
7 State Buildings Revolving Fund from any monies not otherwise
8 appropriated from the Special Cash Fund of the State Treasury, the
9 sum of Thirty Million Dollars (\$30,000,000.00) or so much thereof as
10 may be necessary for maintaining and repairing state-owned
11 properties and buildings.

12 SECTION 132. TRANSFER The Director of the Office of
13 Management and Enterprise Services shall transfer the sum of Eighty-
14 two Thousand Six Hundred Forty-seven Dollars (\$82,647.00) from the
15 Voluntary Buyout Agency Reimbursement Revolving Fund for the Office
16 of State Finance established pursuant to Section 840-2.28B of Title
17 74 of the Oklahoma Statutes to the Special Cash Fund of the State
18 Treasury.

19 SECTION 133. TRANSFER The Director of the Office of
20 Management and Enterprise Services shall transfer the sum of Two
21 Million Dollars (\$2,000,000.00) from the Revolving Fund for the
22 Office of the Secretary of State established pursuant to Section
23 276.1 of Title 62 of the Oklahoma Statutes to the Special Cash Fund
24 of the State Treasury.

1 SECTION 134. TRANSFER The Director of the Office of
2 Management and Enterprise Services shall transfer the sum of Thirty-
3 five Million Dollars (\$35,000,000.00) from the Unclaimed Property
4 Fund established pursuant to Section 668 of Title 60 of the Oklahoma
5 Statutes to the Special Cash Fund of the State Treasury.

6 SECTION 135. TRANSFER The Director of the Office of
7 Management and Enterprise Services shall transfer the sum of Eight
8 Million Dollars (\$8,000,000.00) from the State Insurance
9 Commissioner Revolving Fund ("200 Fund") to the Special Cash Fund of
10 the State Treasury.

11 SECTION 136. TRANSFER The Director of the Office of
12 Management and Enterprise Services shall transfer the sum of Eleven
13 Million Two Hundred Thousand Dollars (\$11,200,000.00) from the
14 Oklahoma Tax Commission and Office of State Finance Joint Computer
15 Enhancement Fund (210 Fund) to the Special Cash Fund of the State
16 Treasury.

17 SECTION 137. TRANSFER The Director of the Office of
18 Management and Enterprise Services shall transfer the sum of Seventy
19 Million Dollars (\$70,000,000.00) from the Cash-flow Reserve Fund of
20 the Office of Management and Enterprise Services to the Special Cash
21 Fund of the State Treasury.

22 SECTION 138. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 General Revenue Fund of the State Treasury for the fiscal year

1 ending June 30, 2012, the sum of Eight Million Four Hundred Forty-
2 seven Thousand Six Hundred Seventy-three Dollars (\$8,447,673.00) to
3 be transferred to the Ad Valorem Reimbursement Fund created pursuant
4 to Section 193 of Title 62 of the Oklahoma Statutes for the purpose
5 of reimbursing counties for school districts that claim a loss of
6 revenue due to a tax exemption granted pursuant to the provisions of
7 Section 6B of Article X of the Oklahoma Constitution.

8 SECTION 139. There is hereby appropriated to the State Board of
9 Education from any monies not otherwise appropriated from the
10 General Revenue Fund of the State Treasury for the fiscal year
11 ending June 30, 2012, the sum of Five Million Six Hundred Two
12 Thousand Three Hundred Fifty Dollars (\$5,602,350.00) or so much
13 thereof as may be necessary to provide funding for the Certified
14 Employee Health Benefit Allowance.

15 SECTION 140. There is hereby appropriated to the State Board of
16 Education from any monies not otherwise appropriated from the
17 General Revenue Fund of the State Treasury for the fiscal year
18 ending June 30, 2012, the sum of Two Million Eight Hundred Ninety-
19 seven Thousand Six Hundred Fifty Dollars (\$2,897,650.00) or so much
20 thereof as may be necessary to provide funding for the Support
21 Personnel Health Benefit Allowance.

22 SECTION 141. There is hereby appropriated to the Oklahoma
23 Department of Emergency Management from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2012, the sum of One Million Two
2 Hundred Thousand Dollars (\$1,200,000.00) or so much thereof as may
3 be necessary for maintenance, repair and upgrades to the Oklahoma
4 Mesonet.

5 SECTION 142. REAPPROPRIATION AND REDESIGNATION The
6 amount of Four Hundred Twenty-nine Thousand One Hundred Fifty-two
7 Dollars (\$429,152.00) of the original appropriation of One Million
8 Two Hundred Thousand Dollars (\$1,200,000.00), appropriated to the
9 Oklahoma House of Representatives by Section 148, Chapter 303,
10 O.S.L. 2011, from any monies not otherwise appropriated from the
11 General Revenue Fund of the State Treasury, for the fiscal year
12 ending June 30, 2010, for the purchase of Oklahoma Statutes and
13 Session Laws pursuant to the provisions of Sections 13 and 14 of
14 Title 75 of the Oklahoma Statutes, is hereby reappropriated and
15 redesignated for the purchase of Oklahoma Statute Supplements and
16 Session Laws pursuant to the provisions of Sections 13 and 14 of
17 Title 75 of the Oklahoma Statutes. If, on the date this act is
18 approved, any of the amount originally appropriated, as adjusted by
19 expenditures, encumbrances and transfers, results in an unencumbered
20 balance less than the reappropriated and redesignated amount, that
21 reappropriated and redesignated amount is reduced to the
22 unencumbered amount.

23 SECTION 143. Sections 1 through 136 of this act shall become
24 effective July 1, 2013.

SECTION 144. Section 137 of this act shall become effective July 15, 2013.
