An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the Commissioners of the Land Office, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Office of Educational Quality and Accountability, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Oklahoma Educational Television Authority, the Oklahoma Department of Libraries, the Oklahoma State Regents for Higher Education, the Physician Manpower Training Commission, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of Management and Enterprise Services, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Department of Transportation, the Oklahoma Space Industry Development Authority, the State Department of Health, the Oklahoma Health Care Authority, the J.D. McCarty Center for Children with Developmental Disabilities, the Department of Mental Health and

Substance Abuse Services, the University Hospitals Authority, the Oklahoma Department of Veterans Affairs, the Oklahoma Commission on Children and Youth, the Office of Disability Concerns, the Department of Human Services, the Office of Juvenile Affairs, the State Department of Rehabilitation Services, the Oklahoma Department of Agriculture, Food, and Forestry, the Oklahoma Department of Commerce, the Rural Economic Action Plan Fund, the Oklahoma Conservation Commission, the Department of Consumer Credit, the Corporation Commission, the Department of Environmental Quality, the Oklahoma Historical Society, the Oklahoma Horse Racing Commission, the Insurance Department, the J.M. Davis Memorial Commission, the Department of Labor, the Department of Mines, the Scenic Rivers Commission, the Oklahoma Tourism and Recreation Department, the Oklahoma Water Resources Board, the Will Rogers Memorial Commission, the Alcoholic Beverage Laws Enforcement Commission, the Department of Corrections, the Office of the State Fire Marshal, the Oklahoma State Bureau of Investigation, the Council on Law Enforcement Education and Training, the Board of Medicolegal Investigations, the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control, the Department of Public Safety, the Office of the Attorney General, district attorneys and the District Attorneys Council, the Court of Criminal Appeals, the Supreme Court, the Oklahoma Indigent Defense System, the Pardon and Parole Board, and the Workers' Compensation Court; stating amounts of the appropriations; stating purposes and restrictions; authorizing and requiring certain expenditures; authorizing and requiring certain transfers; requiring certain deposit; reappropriating and redesignating certain funds; and providing effective dates.

SUBJECT: General appropriations

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

COMMON EDUCATION

SECTION 1. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Nine Hundred Eighty-six Million Six Hundred Seventy-two Thousand Eight Hundred Seventy-six Dollars (\$986,672,876.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 2. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Education Reform Revolving Fund created in Section 34.89 of Title 62 of the Oklahoma Statutes, the sum of Seven Hundred Sixty-seven Million Six Hundred Ninety-one Thousand Seven Hundred Fourteen Dollars (\$767,691,714.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 3. The State Board of Education is hereby authorized to expend during the fiscal year ending June 30, 2014, from the Common Education Technology Revolving Fund of the State Treasury, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 4. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Million Three Hundred Twenty-five Thousand Dollars (\$3,325,000.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 5. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Mineral Leasing Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Seven Hundred Fifty-six Thousand Four Hundred Twenty-two Dollars (\$1,756,422.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 6. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Twenty-five Million One Hundred Fifty-seven Thousand Six Hundred Forty-nine Dollars

(\$25,157,649.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 7. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Five Million Five Hundred Ninety-four Thousand Eight Hundred Nineteen Dollars (\$5,594,819.00) or so much thereof as may be necessary for the financial support of public schools.

SECTION 8. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Five Hundred Seven Million Seven Hundred Seventy-two Thousand Seven Hundred Eighty-one Dollars (\$507,772,781.00) or so much thereof as may be necessary for the support of public schools activities.

SECTION 9. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Thirty-three Million Dollars (\$33,000,000.00) or so much thereof as may be necessary for the purchase of textbooks and instructional materials.

SECTION 10. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Twenty-two Million Four Hundred Twenty-six Thousand Six Hundred Forty-two Dollars (\$22,426,642.00) or so much thereof as may be necessary for administrative and support functions of the State Department of Education.

SECTION 11. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Two Million Seven Hundred Ninety-five Thousand Two Hundred Ninety-four Dollars (\$2,795,294.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 12. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the

fiscal year ending June 30, 2012, the sum of Six Hundred Twenty-one Thousand Six Hundred Forty-six Dollars (\$621,646.00) or so much thereof as may be necessary for transfer to the School Consolidation Assistance Fund.

SECTION 13. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Two Million Seven Hundred Ninety-five Thousand Two Hundred Ninety-four Dollars (\$2,795,294.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 14. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Six Hundred Twenty-one Thousand Six Hundred Forty-six Dollars (\$621,646.00) or so much thereof as may be necessary for transfer to the Teachers' Retirement System Dedicated Revenue Revolving Fund.

SECTION 15. There is hereby appropriated to the Oklahoma Arts Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Four Million Ten Thousand Eighty-seven Dollars (\$4,010,087.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Arts Council by law.

SECTION 16. There is hereby appropriated to the Commissioners of the Land Office from any monies not otherwise appropriated from the Commissioners of the Land Office Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Fifteen Million Sixty-two Thousand Two Hundred Fifty Dollars (\$15,062,250.00) or so much thereof as may be necessary to perform the duties imposed upon the Commissioners of the Land Office by law.

SECTION 17. There is hereby appropriated to the Board of Trustees of the Oklahoma School of Science and Mathematics from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Six Million Three Hundred Thirty-two Thousand Two Hundred Seventy-four Dollars (\$6,332,274.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Trustees of the Oklahoma School of Science and Mathematics by law.

SECTION 18. There is hereby appropriated to the Office of Educational Quality and Accountability from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Six Hundred Sixty-one Thousand Two Hundred Seventy-one Dollars (\$661,271.00) or so much thereof as may be necessary for the Office of Educational Quality and Accountability to perform the duties imposed upon the Office of Educational Quality and Accountability by law.

SECTION 19. There is hereby appropriated to the Oklahoma Commission for Teacher Preparation from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of One Million Five Hundred Twenty-six Thousand One Hundred Seventy-nine Dollars (\$1,526,179.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Commission for Teacher Preparation by law.

CAREER AND TECHNOLOGY EDUCATION

SECTION 20. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of One Hundred Thirty-four Million Three Hundred Eighty-three Thousand Nine Hundred Eighty-four Dollars (\$134,383,984.00) or so much thereof as may be necessary to perform the duties imposed upon the State Board of Career and Technology Education by law.

SECTION 21. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Million Seventy-four Thousand Eight Hundred Twenty-three Dollars (\$3,074,823.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 22. There is hereby appropriated to the State Board of Career and Technology Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of

Six Hundred Eighty-three Thousand Eight Hundred Eleven Dollars (\$683,811.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the State Board of Career and Technology Education for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the State Board of Career and Technology Education.

SECTION 23. There is hereby appropriated to the Oklahoma Educational Television Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Million Eight Hundred Twenty-two Thousand Three Hundred Twenty-eight Dollars (\$3,822,328.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Educational Television Authority by law.

SECTION 24. There is hereby appropriated to the Oklahoma Department of Libraries from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Five Million Eight Hundred Ninety-eight Thousand Six Hundred Thirty-three Dollars (\$5,898,633.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Libraries by law.

HIGHER EDUCATION

SECTION 25. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Eight Hundred Ten Million Six Hundred Seventy-three Thousand Eight Hundred Fifty-two Dollars (\$810,673,852.00) or so much thereof as may be necessary for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education. Of those funds appropriated, the sum of Three Million Eight Hundred Thirty Thousand Thirty-eight Dollars (\$3,830,038.00) shall be transferred to the Oklahoma Tuition Equalization Grant Trust Fund to implement the provisions of the Oklahoma Tuition Equalization Grant Act.

SECTION 26. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2014, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the Higher Education Capital Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 27. The Oklahoma State Regents for Higher Education are hereby authorized to expend during the fiscal year ending June 30, 2014, the sum of Forty-seven Million Three Hundred Seventy-two Thousand Two Hundred Ninety-nine Dollars (\$47,372,299.00) from the Oklahoma Student Aid Revolving Fund of the State Treasury for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 28. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury the sum of Fifty Million Dollars (\$50,000,000.00) for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 29. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of One Million Two Hundred Thirty-four Thousand One Hundred Seventy-four Dollars (\$1,234,174.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 30. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise

appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Twenty-two Million Eighty-two Thousand Eight Hundred Twenty-five Dollars (\$22,082,825.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 31. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Million Nine Hundred Eleven Thousand Eight Dollars (\$4,911,008.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

SECTION 32. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Four Million Nine Hundred Two Thousand Five Hundred Fifty Dollars (\$4,902,550.00) or so much thereof as may be necessary for the general operating budget of the Administrative Offices of the Oklahoma State Regents for Higher Education.

SECTION 33. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Million Nine Hundred Seventy-nine Thousand Two Hundred Fifty-four Dollars (\$3,979,254.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 34. There is hereby appropriated to the Physician Manpower Training Commission from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Four Hundred Thousand Dollars (\$400,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Physician Manpower Training Commission by law.

SECTION 35. There is hereby appropriated to the Oklahoma Center for the Advancement of Science and Technology from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Seventeen Million Eight Hundred Eleven Thousand Four Hundred Forty-nine Dollars (\$17,811,449.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Center for the Advancement of Science and Technology by law. Of those funds appropriated, the sum of Thirteen Million One Hundred Fifty-seven Thousand Seven Hundred Eighty-four Dollars (\$13,157,784.00) shall be deposited in the Research Support Revolving Fund created pursuant to Section 5060.11 of Title 74 of the Oklahoma Statutes. Of those funds appropriated, the sum of Three Million Nine Hundred Sixty-six Thousand Three Hundred Fifty-five Dollars (\$3,966,355.00) shall be deposited in the Seed-Capital Revolving Fund created pursuant to Section 5060.21 of Title 74 of the Oklahoma Statutes.

GENERAL GOVERNMENT AND TRANSPORTATION

SECTION 36. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Four Million Three Hundred Ninety-nine Thousand Eight Hundred Twenty Dollars (\$4,399,820.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Auditor and Inspector by law.

SECTION 37. There is hereby appropriated to the Office of the State Auditor and Inspector from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Hundred Seven Thousand One Hundred Sixty-six Dollars (\$307,166.00) or so much thereof as may be necessary to perform the duties imposed upon the Commission on County Government Personnel Education and Training. The appropriation made in this section shall be expended exclusively for the purpose so stated and shall not be transferable.

SECTION 38. There is hereby appropriated to the Office of the State Bond Advisor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of One Hundred Forty-three Thousand One Hundred Twelve Dollars (\$143,112.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the State Bond Advisor by law.

SECTION 39. There is hereby appropriated to the State Election Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Seven Million Eight Hundred Five Thousand Eight Hundred Eight Dollars (\$7,805,808.00) or so much thereof as may be necessary to perform the duties imposed upon the State Election Board by law.

SECTION 40. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Six Hundred Fifty-one Thousand One Hundred Seventy-nine Dollars (\$651,179.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Department of Emergency Management by law.

SECTION 41. There is hereby appropriated to the Ethics Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Seven Hundred Thirty-eight Thousand One Hundred Twenty-nine Dollars (\$738,129.00) or so much thereof as may be necessary to perform the duties imposed upon the Ethics Commission by law.

SECTION 42. There is hereby appropriated to the Office of the Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Two Million One Hundred Seventy-two Thousand Nine Hundred Dollars (\$2,172,900.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Governor by law.

SECTION 43. There is hereby appropriated to the Oklahoma House of Representatives from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Sixteen Million Five Hundred Seventy-four Thousand Six Hundred Eighty-two Dollars

(\$16,574,682.00) or so much thereof as may be necessary to pay the salaries, per diem and expenses of the members of the Oklahoma House of Representatives, the salaries of the employees of the Oklahoma House of Representatives, and other necessary expenses. Claims and payrolls filed against the appropriation made to the Oklahoma House of Representatives for the fiscal year ending June 30, 2014, shall be approved by the Speaker of the Oklahoma House of Representatives.

SECTION 44. There is hereby appropriated to the Legislative Service Bureau from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Nine Million Eight Hundred Ninety-two Thousand Eight Hundred Thirty-five Dollars (\$9,892,835.00) or so much thereof as may be necessary to perform the duties imposed upon the Legislative Service Bureau by law.

SECTION 45. There is hereby appropriated to the Office of the Lieutenant Governor from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Five Hundred Six Thousand Five Hundred Ninety-one Dollars (\$506,591.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Lieutenant Governor by law.

SECTION 46. There is hereby appropriated to the Office of Management and Enterprise Services from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Twenty-six Million One Hundred Seventy-nine Thousand One Hundred Eighty-six Dollars (\$26,179,186.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Management and Enterprise Services by law.

SECTION 47. There is hereby appropriated to the Office of Management and Enterprise Services from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Eleven Million Two Hundred Thousand Dollars (\$11,200,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of Management and Enterprise Services by law.

SECTION 48. There is hereby appropriated to the Office of Management and Enterprise Services from any monies not otherwise appropriated from the Public Building Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Two Million Thirty-three Thousand Ninety-five Dollars (\$2,033,095.00) to be transferred

to the Building and Facility Revolving Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes for the purpose of maintaining state buildings operated by the Office of Management and Enterprise Services.

SECTION 49. SECTION 52. There is hereby appropriated to the Oklahoma State Senate from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the following amount, or so much thereof as may be necessary to pay monthly salaries, per diem, and expenses of the members of the Senate and the salaries of the Secretary of the Senate and employees, and such contingent expenses as may be ordered paid therefrom, including the preparation and printing of the journals and calendars of the Senate, and including the preparation and printing of the permanent journals thereof, in accordance with the following amount herein set forth:

SECTION 53. There is hereby appropriated to the Oklahoma Tax Commission from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Forty-six Million Nine Hundred Fifteen Thousand Nine Hundred Forty-four Dollars (\$46,915,944.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Tax Commission by law.

SECTION 54. SECTION 107. There is hereby appropriated to the Council on Law Enforcement Education and Training from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Four Hundred Fifty-two Thousand Ninety-two Dollars (\$452,092.00) or so much thereof as may be necessary to perform the duties imposed upon the Council on Law Enforcement Education and Training by law.

SECTION 108. There is hereby appropriated to the Board of Medicolegal Investigations from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Eight Million Six Hundred Ninety-eight Thousand Two Hundred Eighty-one Dollars (\$8,698,281.00) or so much thereof as may be necessary to perform the duties imposed upon the Board of Medicolegal Investigations by law.

SECTION 109. There is hereby appropriated to the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Million Six Hundred Sixteen Thousand Four Hundred Eighteen Dollars (\$3,616,418.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma State Bureau of Narcotics and Dangerous Drugs Control by law.

SECTION 110. There is hereby appropriated to the Department of Public Safety from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Ninety Million Four Hundred Sixteen Thousand Seven Hundred Ninety Dollars (\$90,416,790.00) or so much

thereof as may be necessary to perform the duties imposed upon the Department of Public Safety by law.

JUDICIARY

SECTION 111. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Fourteen Million Three Hundred Twenty-three Thousand Four Hundred Fifteen Dollars (\$14,323,415.00) or so much thereof as may be necessary to perform the duties imposed upon the Office of the Attorney General by law.

SECTION 112. There is hereby appropriated to the Office of the Attorney General from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Nine Hundred Four Thousand Seven Hundred Twenty-six Dollars (\$904,726.00) to transfer to the Legal Services Revolving Fund created pursuant to subsection G of Section 921.1 of Title 12 of the Oklahoma Statutes.

SECTION 113. For the fiscal year ending June 30, 2014, the Office of the Attorney General is authorized to transfer an amount not to exceed Three Hundred Twenty Thousand Four Hundred Thirty Dollars (\$320,430.00) from the Office of the Attorney General's Evidence Fund (700 Fund), created by Section 19 of Title 74 of the Oklahoma Statutes to the Office of the Attorney General's Revolving Fund (200 Fund) created by Section 20 of Title 74 of the Oklahoma Statutes.

SECTION 114. There is hereby appropriated to the District Attorneys Council from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Thirty-nine Million Six Hundred Eighty-seven Thousand Two Hundred Fifty-eight Dollars (\$39,687,258.00) or so much thereof as may be necessary to perform the duties imposed upon the district attorneys and the District Attorneys Council by law. Of the funds appropriated herein, the District Attorneys Council shall transfer up to the sum of Four Hundred Ninety-one Thousand Fourteen Dollars (\$491,014.00) or so much thereof as may be required by the district attorneys and District Attorneys Council to the District Attorneys Evidence Fund for necessary expenses relative to any case within the official responsibility of the offices of the district attorneys as provided by Section 215.40 of Title 19 of the Oklahoma Statutes.

SECTION 115. For the fiscal year ending June 30, 2014, the District Attorneys Council is authorized to transfer an amount not to exceed Nine Hundred Seventy-five Thousand Dollars (\$975,000.00), on an as-needed basis, from the Crime Victims Compensation Revolving Fund created by Section 142.17 of Title 21 of the Oklahoma Statutes to the Sexual Assault Examination Fund created by Section 142.20 of Title 21 of the Oklahoma Statutes.

SECTION 116. For the fiscal year ending June 30, 2014, the District Attorneys Council is authorized to transfer an amount not to exceed Twenty-five Thousand Dollars (\$25,000.00) from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for the purchase of statewide forensic sexual assault examination kits.

SECTION 117. For the fiscal year ending June 30, 2014, up to Eight Hundred Sixty Thousand Dollars (\$860,000.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council to support the Crime Victims Compensation Board.

SECTION 118. For the fiscal year ending June 30, 2014, up to One Million Five Hundred One Thousand Three Hundred Seventy-five Dollars (\$1,501,375.00) is authorized to be transferred from the Crime Victims Compensation Revolving Fund, created by Section 142.17 of Title 21 of the Oklahoma Statutes, to the District Attorneys Council for duties to support Victim-Witness Services.

SECTION 119. There is hereby appropriated to the Court of Criminal Appeals from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Three Million Six Hundred Thirty-four Thousand Six Hundred Thirty-one Dollars (\$3,634,631.00) or so much thereof as may be necessary to perform the duties imposed upon the Court of Criminal Appeals by law.

SECTION 120. The Supreme Court is hereby authorized to expend during the fiscal year ending June 30, 2014, from the State Judicial Revolving Fund of the State Treasury, the sum of Forty-three Million Dollars (\$43,000,000.00) or so much thereof as may be necessary for the financial support of the District Courts.

SECTION 121. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Sixteen Million Six Hundred Thousand Dollars (\$16,600,000.00) or so much thereof as may be necessary to perform the duties imposed upon the District Courts by law.

SECTION 122. For the fiscal year ending June 30, 2014, the Office of Management and Enterprise Services shall, at the request of the Administrative Director of the Courts, transfer from the State Judicial Revolving Fund to the Supreme Court Administrative Revolving Fund an amount not to exceed Two Million Dollars (\$2,000,000.00) that the Administrative Director of the Courts, with the approval of the Chief Justice of the Supreme Court in his or her sole discretion, shall deem appropriate or necessary including, but not limited to, appellate and district court expenditures.

SECTION 123. For the fiscal year ending June 30, 2014, the Office of Management and Enterprise Services shall, at the request of the Administrative Director of the Courts, transfer from the Lengthy Trial Fund to the Supreme Court Administrative Revolving Fund an amount not to exceed One Million Dollars (\$1,000,000.00) that the Administrative Director of the Courts, with the approval of the Chief Justice of the Supreme Court in his or her sole discretion, shall deem appropriate or necessary including, but not limited to, appellate and district court expenditures.

SECTION 124. There is hereby appropriated to the Oklahoma Indigent Defense System from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Fifteen Million Six Hundred Ninety-nine Thousand Three Hundred Fifty-three Dollars (\$15,699,353.00) or so much thereof as may be necessary to perform the duties imposed upon the Oklahoma Indigent Defense System by law.

SECTION 125. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Two Million Two Hundred Seventeen Thousand Four Hundred Fifty-four Dollars (\$2,217,454.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 126. There is hereby appropriated to the Pardon and Parole Board from any monies not otherwise appropriated from the

General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Seventy-five Thousand Dollars (\$75,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Pardon and Parole Board by law.

SECTION 127. There is hereby appropriated to the Supreme Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Seventeen Million Three Hundred Thousand Dollars (\$17,300,000.00) or so much thereof as may be necessary to perform the duties imposed upon the Supreme Court or Court of Civil Appeals by law.

SECTION 128. There is hereby appropriated to the Workers' Compensation Court from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of Five Million Seven Hundred Forty-seven Thousand One Hundred Sixty-six Dollars (\$5,747,166.00) or so much thereof as may be necessary to perform the duties imposed upon the Workers' Compensation Court by law.

SECTION 129. From the appropriation made in Section 128 of this act, beginning on the effective date of Section 28 of Enrolled Senate Bill No. 1062 of the 1st Session of the 54th Oklahoma Legislature, the Director of the Office of Management and Enterprise Services shall transfer, for the fiscal year ending June 30, 2014, an amount not to exceed One Million Five Hundred Thousand Dollars (\$1,500,000.00) to the Workers' Compensation Fund created pursuant to Section 28 of Enrolled Senate Bill No. 1062 of the 1st Session of the 54th Oklahoma Legislature for the performance of the duties imposed upon the Workers' Compensation Commission by law.

SECTION 130. There is hereby appropriated to the Oklahoma State University Medical Authority from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the Fiscal year ending June 30, 2014, the sum of Thirteen Million Dollars (\$13,000,000.00) or so much thereof as may be necessary for the purposes of the support of the graduate medical education programs affiliated with the OSU Medical Center and/or the OSU Center for Health Sciences. Funds appropriated shall be retained and not expended by the Oklahoma State University Medical Authority for the support of the graduate medical education programs affiliated with the OSU Medical Center until such time as the Oklahoma State University Medical Authority has clear title to the

assets, licenses, property and has all necessary functional authorities of the OSU Medical Center.

SECTION 131. There is hereby appropriated to the Maintenance of State Buildings Revolving Fund from any monies not otherwise appropriated from the Special Cash Fund of the State Treasury, the sum of Thirty Million Dollars (\$30,000,000.00) or so much thereof as may be necessary for maintaining and repairing state-owned properties and buildings.

SECTION 132. TRANSFER The Director of the Office of Management and Enterprise Services shall transfer the sum of Eighty-two Thousand Six Hundred Forty-seven Dollars (\$82,647.00) from the Voluntary Buyout Agency Reimbursement Revolving Fund for the Office of State Finance established pursuant to Section 840-2.28B of Title 74 of the Oklahoma Statutes to the Special Cash Fund of the State Treasury.

SECTION 133. TRANSFER The Director of the Office of Management and Enterprise Services shall transfer the sum of Two Million Dollars (\$2,000,000.00) from the Revolving Fund for the Office of the Secretary of State established pursuant to Section 276.1 of Title 62 of the Oklahoma Statutes to the Special Cash Fund of the State Treasury.

SECTION 134. TRANSFER The Director of the Office of Management and Enterprise Services shall transfer the sum of Thirty-five Million Dollars (\$35,000,000.00) from the Unclaimed Property Fund established pursuant to Section 668 of Title 60 of the Oklahoma Statutes to the Special Cash Fund of the State Treasury.

SECTION 135. TRANSFER The Director of the Office of Management and Enterprise Services shall transfer the sum of Eight Million Dollars (\$8,000,000.00) from the State Insurance Commissioner Revolving Fund ("200 Fund") to the Special Cash Fund of the State Treasury.

SECTION 136. TRANSFER The Director of the Office of Management and Enterprise Services shall transfer the sum of Eleven Million Two Hundred Thousand Dollars (\$11,200,000.00) from the Oklahoma Tax Commission and Office of State Finance Joint Computer Enhancement Fund (210 Fund) to the Special Cash Fund of the State Treasury.

SECTION 137. TRANSFER The Director of the Office of Management and Enterprise Services shall transfer the sum of Seventy Million Dollars (\$70,000,000.00) from the Cash-flow Reserve Fund of the Office of Management and Enterprise Services to the Special Cash Fund of the State Treasury.

SECTION 138. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Eight Million Four Hundred Forty-seven Thousand Six Hundred Seventy-three Dollars (\$8,447,673.00) to be transferred to the Ad Valorem Reimbursement Fund created pursuant to Section 193 of Title 62 of the Oklahoma Statutes for the purpose of reimbursing counties for school districts that claim a loss of revenue due to a tax exemption granted pursuant to the provisions of Section 6B of Article X of the Oklahoma Constitution.

SECTION 139. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Five Million Six Hundred Two Thousand Three Hundred Fifty Dollars (\$5,602,350.00) or so much thereof as may be necessary to provide funding for the Certified Employee Health Benefit Allowance.

SECTION 140. There is hereby appropriated to the State Board of Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of Two Million Eight Hundred Ninety-seven Thousand Six Hundred Fifty Dollars (\$2,897,650.00) or so much thereof as may be necessary to provide funding for the Support Personnel Health Benefit Allowance.

SECTION 141. There is hereby appropriated to the Oklahoma Department of Emergency Management from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2012, the sum of One Million Two Hundred Thousand Dollars (\$1,200,000.00) or so much thereof as may be necessary for maintenance, repair and upgrades to the Oklahoma Mesonet.

SECTION 142. REAPPROPRIATION AND REDESIGNATION The amount of Four Hundred Twenty-nine Thousand One Hundred Fifty-two Dollars (\$429,152.00) of the original appropriation of One Million Two Hundred Thousand Dollars (\$1,200,000.00), appropriated to the

Oklahoma House of Representatives by Section 148, Chapter 303, O.S.L. 2011, from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury, for the fiscal year ending June 30, 2010, for the purchase of Oklahoma Statutes and Session Laws pursuant to the provisions of Sections 13 and 14 of Title 75 of the Oklahoma Statutes, is hereby reappropriated and redesignated for the purchase of Oklahoma Statute Supplements and Session Laws pursuant to the provisions of Sections 13 and 14 of Title 75 of the Oklahoma Statutes. If, on the date this act is approved, any of the amount originally appropriated, as adjusted by expenditures, encumbrances and transfers, results in an unencumbered balance less than the reappropriated and redesignated amount, that reappropriated and redesignated amount is reduced to the unencumbered amount.

SECTION 143. Sections 1 through 136 of this act shall become effective July 1, 2013.

SECTION 144. Section 137 of this act shall become effective July 15, 2013.
