- "SECTION 5. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 149.1 of Title 70, unless there is created a duplication in numbering, reads as follows:
- A. There is hereby created the Oklahoma School Security Institute (OSSI). The OSSI will operate under the Oklahoma Office of Homeland Security and will be a center of best practices and a resource for schools across the state to make their school environments safer. As the OSSI develops, some long term study goals may focus on School Resource Officers, school architectural design and bullying, as well as other security issues.
- B. The OSSI will be the focal point for coordinating and providing training in school safety and security procedures to Oklahoma schools in order to provide a safe and secure environment for students, teachers, and staff members.
- C. The OSSI will serve as a complete provider of standardized safety and security training for Oklahoma. The OSSI will coordinate with other agencies to provide training to law enforcement in response to security incidents that occur in schools. The OSSI may also coordinate training opportunities to any discipline that interacts with schools in an effort to increase safety and security. Working with subject matter experts, the OSSI will identify training needs and work to provide training courses to satisfy those needs.
- SECTION 6. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 149.2 of Title 70, unless there is created a duplication in numbering, reads as follows:

- A. School intruder drills should be conducted by school districts across the state along with fire and tornado drills. By including these school intruder drills, school personnel are given extra training they can use in the event of an unforeseen intrusion.
- B. Each public school in the State of Oklahoma should conduct a minimum of ten (10) school safety drills per school year in which all students, school employees and visitors participate.
- C. Such drills shall conform to the written plans and procedures produced by the Oklahoma School Security Institute established in Section 5 of this act and adopted by the district for protecting against natural and man-made disasters and emergencies. The drills shall include fire, tornado and school intruder drills any additional drills the school wants to conduct as each school district deems appropriate.
- SECTION 7. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 149.3 of Title 70, unless there is created a duplication in numbering, reads as follows:

The principal or school administrator of the school site where a firearm is discovered shall immediately report the discovery of the firearm to the local law enforcement authority having jurisdiction for that school district.

SECTION 8. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 149.4 of Title 70, unless there is created a duplication in numbering, reads as follows:

A telephone tip line shall be reinstituted and available for parents, teachers, students and administrators to call to report suspicious activity. The Oklahoma Commission on School Security directs that the

telephone tip line be operated by the Oklahoma School Security Institute as established in Section 5 of this act in coordination with additional law enforcement agencies, as needed.

- SECTION 9. NEW LAW A new section of law to be codified in the Oklahoma Statutes as Section 149.5 of Title 70, unless there is created a duplication in numbering, reads as follows:
- A. There is hereby established a Mental Health First Aid Training
 Pilot Program. The pilot program shall be voluntary and incorporate the
 Oklahoma Department of Mental Health and Substance Abuse Services and
 district superintendents in its formation.
 - B. The pilot program shall study and consider the following:
- 1. Establishing a training model for use by teachers and school personnel; and
 - 2. Certified mental health training by teachers and school personnel.
- C. All aspects of the Mental Health First Aid Training Pilot Program shall not place any additional mandates upon school personnel."
