"Retail electric supplier" means an entity engaged in the 19 furnishing of retail electric service within the State of Oklahoma 20 and is rate regulated by the Oklahoma Corporation Commission. 21 B. No public utility retail electric supplier shall increase 22 rates charged or enforce a surcharge on the basis of the use or 23
