8                               COMMITTEE SUBSTITUTE

9           An Act relating to prevention programs; creating the  
10          Prevention Programs Accountability Act; requiring the  
11          state to return certain federal grant monies;  
12          directing state agencies to suspend home visitation  
13          programs for one year; mandating State Auditor to  
14          sequester funds related to the programs; providing  
15          for an audit and evaluation of the funds; directing  
16          State Auditor to examine national programs and report  
17          findings to the Legislature; requiring State Auditor  
18          to establish evaluation standards and report its  
19          findings annually; repealing 63 O.S. 2011, Section 1-  
20          110.1, as amended by Section 477, Chapter 304, O.S.L.  
21          2012 (63 O.S. Supp. 2012, Section 1-110.1), which  
22          relates to the Children First Fund; providing for  
23          noncodification; providing for codification; and  
24          providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1.           NEW LAW           A new section of law not to be  
codified in the Oklahoma Statutes reads as follows:

1 This act shall be known and may be cited as the "Prevention  
2 Programs Accountability Act".

3 SECTION 2. NEW LAW A new section of law to be codified  
4 in the Oklahoma Statutes as Section 1-110.2 of Title 63, unless  
5 there is created a duplication in numbering, reads as follows:

6 A. Effective November 1, 2013, the state of Oklahoma shall  
7 immediately return all federal grant funding from the Maternal,  
8 Infant, and Early Childhood Home Visiting Program to the United  
9 States Department of Health and Human Services.

10 B. Effective January 1, 2014, the Department of Human Services,  
11 the State Department of Health and the State Board of Education  
12 shall suspend, for one year, all home visitation programs limited to  
13 SafeCare, Start Right and Oklahoma Parents as Teachers. The State  
14 Auditor shall sequester all funds related to these programs and  
15 conduct a full audit of the funds and evaluation of the efficacy and  
16 cost-effectiveness of the programs. The State Auditor shall examine  
17 all nationally recognized evidence-based home visitation programs  
18 and make recommendations to the Legislature. The State Auditor  
19 shall develop standards for evaluating and annually report on the  
20 return on investment, efficiency and effectiveness of the home  
21 visitation programs operated by the state.

1       SECTION 3.       REPEALER       63 O.S. 2011, Section 1-110.1, as  
2 amended by Section 477, Chapter 304, O.S.L. 2012 (63 O.S. Supp.  
3 2012, Section 1-110.1), is hereby repealed.

4       SECTION 4. This act shall become effective November 1, 2013.
