BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 63 O.S. 2011, Section 1-738k, is amended to read as follows:

Section 1-738k. A. Subsections B and C of this section shall become operative on the later of:

1. April 1, 2012; or

2. Thirty (30) calendar days following the date on which the State Department of Health posts on its website the Individual Abortion Form and instructions concerning its electronic submission referenced in this section.

1 B. The Department shall post the Individual Abortion Form and
2 instructions concerning its electronic submission on its stable
3 Internet website. Nothing in the Individual Abortion Form shall
4 contain the name, address, hometown, county of residence, or any
5 other information specifically identifying any patient. The
6 Department's Individual Abortion Form shall be substantially similar
7 to, but need not be in the specific format, provided in subsection F
8 of this section.

9 C. Any physician performing abortions shall fully complete and
10 submit, electronically, an Individual Abortion Form to the State
11 Department of Health by the last business day of the calendar month
12 following the month in which the physician performs an abortion, for
13 each abortion the physician performs.

14 D. In cases in which a physician or the agent of a physician:

15 1. Mails the printed materials described in Section 1-738.3 of
16 ~~Title 63 of the Oklahoma Statutes~~ this title to a female
17 specifically to comply with division (1) of subparagraph d of
18 paragraph 2 of subsection B of Section 1-738.2 of ~~Title 63 of the~~
19 ~~Oklahoma Statutes~~ this title;

20 2. Gives or mails the printed materials described in Section 1-
21 738.10 of ~~Title 63 of the Oklahoma Statutes~~ this title to a female
22 specifically to comply with subsection A of Section 1-738.8 of ~~Title~~
23 ~~63 of the Oklahoma Statutes~~ this title; or
24

1 3. Provides notice to a parent in compliance with Section 1-
2 740.2 of ~~Title 63 of the Oklahoma Statutes~~ this title,
3 but does not subsequently perform an abortion on the female or
4 minor, the physician shall electronically submit a completed
5 Individual Abortion Form to the State Department of Health, and
6 shall mark as "not applicable" those items of information that may
7 accurately be provided only when an abortion is performed. The
8 physician shall not submit such a form if the physician knows that
9 an abortion was subsequently performed on the female or minor by
10 another physician. Individual Abortion Forms required by this
11 subsection shall be submitted by the last business day of the second
12 calendar month following the calendar month in which the physician
13 mails the printed materials or provides notice to a parent.

14 E. The Individual Abortion Form shall contain a notice
15 containing an assurance that, in accordance with subsection F of
16 Section ~~5~~ 1-738m of this ~~act~~ title, public reports based on the form
17 submitted will not contain the name, address, hometown, county of
18 residence, or any other identifying information of any individual
19 female, that the State Department of Health will take care to ensure
20 that none of the information included in its public reports could
21 reasonably lead to the identification of any individual female about
22 whom information is reported in accordance with the Statistical
23 Abortion Reporting Act or of any physician providing information in
24

1 accordance with the Statistical Abortion Reporting Act, and that
2 such information is not subject to the Oklahoma Open Records Act.

4 Abortion Form shall be substantially similar to, but need not be in

16 amended to read as follows:

17 Section 1-738m. A. Beginning in 2013, by June 1 of each year,
18 the Department shall issue, on its stable Internet website, a public
19 Annual Abortion Report providing statistics for the previous
20 calendar year compiled from all of the reports covering that year
21 submitted in accordance with the Statistical Abortion Reporting Act.

22 B. The Department's public report shall also provide statistics
23 for all previous calendar years for which abortion-reporting
24

1 requirements have been in effect, adjusted to reflect any additional
2 information from late or corrected reports.

3 C. The Annual Abortion Report shall include, but not be limited
4 to, the following information:

5 1. The number of induced abortions performed in the previous
6 calendar year, broken down by month and county in which the abortion
7 was performed;

8 2. The number of abortions classified by:

9 a. the state or foreign country of residence of the
10 mother,

11 b. the age, marital status, and race of the mother, and

12 c. the number of years of education of the mother;

13 3. The number of abortions classified by:

14 a. the number of previous pregnancies of the mother,

15 b. previous live births to the mother,

16 c. previous miscarriages, and

17 d. previous induced abortions;

18 4. The number of abortions by week of gestational age;

19 5. The number of abortions performed by each reported method;

21 resulting from incest committed against a minor, the
22 number of perpetrators of incest in such cases
23 reported to law enforcement authorities, general
24 categories of law enforcement authorities to whom

1 reports were made and the number made to each
2 category, and a statistical summary of the length of
3 time between the dates of reporting to law enforcement
4 authorities and the dates of the abortions;

5 26. The number of females to a parent of whom the physician
6 provided notice as required by Section 1-740.2 of ~~Title 63 of the~~
7 ~~Oklahoma Statutes~~ this title; of that number, the number provided
8 personally as described in that section, and the number provided by
9 mail as described in that section, and of each of those numbers, the
10 number of females who, to the best of the information and belief of
11 the reporting physician, went on to obtain the abortion;

12 27. The number of females upon whom the physician performed an
13 abortion without the notice to or consent of the parent of the minor
14 required by Section 1-740.2 of ~~Title 63 of the Oklahoma Statutes~~
15 this title; of that number, the number who were emancipated minors
16 and the number who suffered from a medical emergency, and of the
17 latter, the number of cases in which a parent was notified
18 subsequently and the number of cases in which a judicial waiver was
19 obtained. In the case of medical emergencies in which a parent was
20 informed subsequently, a statistical summary of the period of time
21 elapsed before notification;

22 28. The number of abortions performed after receiving judicial
23 authorization to do so without parental notice and consent;

24

1 29. The number of abortions performed on minors after judicial
2 authorizations were granted because of a finding that the minor girl
3 was mature and capable of giving informed consent; ~~and~~

4 30. The number of abortions performed on minors after judicial
5 authorizations were granted because of a finding that the
6 performance of the abortion without parental notification and
7 consent was in the best interest of the minor;

8 31. The number of abortions performed after which the remains
9 of the fetus after the abortion were examined to ensure that all
10 such remains were evacuated from the mother's body;

11 32. The number of male children aborted and female children
12 aborted, as determined from the examination of fetal remains after
13 abortion;

14 33. The number of male children aborted and female children
15 aborted, as determined by any method other than those reported in
16 paragraph 32 of this subsection;

17 34. The number of instances in which the mother was informed
18 prior to the abortion that the child to be aborted was a female;

19 35. The number of abortions performed without surgery but
20 rather as the results of the administration of chemicals;

21 36. The number of abortions performed as reported in paragraph
22 35 of this subsection, in which the physician was present in the
23 same room as the woman to whom the chemicals were administered at
24 the time any such chemicals were first administered;

1 37. The number of abortions performed for each hospital at
2 which the abortionist had hospital privileges at the time of the
3 abortion;

4 38. The number of abortions performed at which ultrasound
5 equipment was used before the abortion;

6 39. The number of abortions reported in paragraph 38 of this
7 subsection, during which the mother was under the effect of
8 anesthesia at the time of the ultrasound;

9 40. The number of abortions performed at which ultrasound
10 equipment was used during the abortion;

11 41. The number of abortions reported in paragraph 40 of this
12 subsection, during which the mother was under the effect of
13 anesthesia at the time of the ultrasound;

14 42. The number of abortions performed at which ultrasound
15 equipment was used after the abortion;

16 43. The number of abortions reported in paragraph 42 of this
17 subsection, during which the mother was under the effect of
18 anesthesia at the time of the ultrasound;

19 44. The mean gestational age of the fetus at the time of the
20 abortion, as determined by ultrasounds reported;

21 45. The number of abortions for which no determination of
22 probable postfertilization age was made as required by Section 1-
23 745.5 of this title; and

1 46. The number of abortions in which the pregnant woman was
2 told that it may be possible to make the embryonic or fetal
3 heartbeat of the unborn child audible for the pregnant woman to
4 hear; the number of abortions in which the pregnant woman was asked
5 if she would like to hear the heartbeat; and the number of abortions
6 in which the embryonic or fetal heartbeat of the unborn child was
7 made audible for the pregnant woman to hear, using a Doppler fetal
8 heart rate monitor.

9 D. Beginning in 2013, by June 1 of each year, the State
10 Department of Health shall post, on its stable Internet website, a
11 public Annual Judicial Bypass of Abortion Parental Consent Summary
12 Report providing statistics which shall be compiled and supplied to
13 the Department by the Administrative Office of the Courts giving the
14 total number of petitions or motions filed under Section 1-740.3 of
15 ~~Title 63 of the Oklahoma Statutes~~ this title and of that number, the
16 number in which:

- 17 1. The court appointed a guardian ad litem;
- 18 2. The court appointed counsel;
- 19 3. The judge issued an order authorizing an abortion without
20 parental notification or consent, and of those:
 - 21 a. the number authorized due to a determination by the
22 judge that the minor was mature and capable of giving
23 consent to the proposed abortion, and
24

1 b. the number authorized due to a determination by the
2 judge that an abortion was in the best interest of the
3 minor; and

4 4. The judge denied such an order, and of this, the number of:

5 a. denials from which an appeal was filed,

6 b. the appeals that resulted in the denial being
7 affirmed, and

8 c. appeals that resulted in reversals of the denials.

9 E. Each Annual Judicial Bypass of Abortion Parental Consent

10 Summary Report shall also provide the statistics for all previous
11 calendar years for which the public statistical report was required
12 to be issued, adjusted to reflect any additional information from
13 late or corrected reports.

14 F. The Department's public reports shall not contain the name,
15 address, hometown, county of residence, or any other identifying
16 information of any individual female, and shall take care to ensure
17 that none of the information included in its public reports could
18 reasonably lead to the identification of any individual female about
19 whom information is reported in accordance with the Statistical
20 Abortion Reporting Act or of any physician providing information in
21 accordance with the Statistical Abortion Reporting Act. Nor shall
22 the information described in the preceding sentence be subject to
23 the Oklahoma Open Records Act.

1 SECTION 3. AMENDATORY 63 O.S. 2011, Section 1-738n, is
2 amended to read as follows:

3 Section 1-738n. A. The State Board of Medical Licensure and
4 Supervision and the State Board of Osteopathic Examiners shall
5 notify, by March 1, 2012, all physicians licensed to practice in
6 this state over whom they have licensure authority of the
7 requirements of the Statistical Abortion Reporting Act and of the
8 addresses of the pages on the State Department of Health's secure
9 Internet website providing access to the forms it requires and
10 instructions for their electronic submission. The respective Board
11 shall also notify each physician who subsequently becomes newly
12 licensed to practice in this state, at the same time as an official
13 notification to that physician, that the physician is so licensed.

14 B. Individual Abortion Forms or Complications of Induced
15 Abortion Reports that are not submitted by the end of a grace period
16 of thirty (30) days following the due date shall be subject to a
17 late fee of Five Hundred Dollars (\$500.00) for each additional
18 thirty-day period the forms or reports are overdue. Any monies
19 collected under this subsection shall be deposited into an account
20 created within the Department, which shall be used for the
21 administration of the Statistical Abortion Reporting Act. Any
22 physician required to report in accordance with the Statistical
23 Abortion Reporting Act who has not completed and electronically
24 submitted a form or report, or has submitted only an incomplete form

1 or report, more than one (1) year following the due date shall be
2 precluded from renewing his or her license until such fines are paid
3 in full and outstanding forms or reports are submitted, and may, in
4 an action brought by the State Department of Health, be directed by
5 a court of competent jurisdiction to electronically submit completed
6 forms or reports within a period stated by court order or be subject
7 to sanctions for civil contempt.

8 C. Anyone who knowingly or recklessly fails to submit an
9 Individual Abortion Form or Complications of Induced Abortion
10 Report, or submits false information under the Statistical Abortion
11 Reporting Act, shall be guilty of a misdemeanor.

12 D. The Department, the State Board of Medical Licensure and
13 Supervision and the State Board of Osteopathic Examiners shall
14 ensure compliance with the Statistical Abortion Reporting Act and
15 shall verify the data provided by periodic inspections of places
16 where the Department, the State Board of Medical Licensure and
17 Supervision or the State Board of Osteopathic Examiners know or have
18 reason to believe abortions are performed.

19 E. The Department may promulgate rules in accordance with the
20 Administrative Procedures Act to alter the dates established by the
21 Statistical Abortion Reporting Act to achieve administrative
22 convenience, fiscal savings, or to reduce the burden of reporting
23 requirements, so long as the forms and reports are made available,
24 on its stable Internet website, to all licensed physicians in this

1 state, and the public reports described in Section ~~5~~ 1-738m of this
2 ~~act~~ title are issued at least once every year.

3 F. If the Department fails to issue the public reports
4 described in Section ~~5~~ 1-738m of this ~~act~~ title, an action pursuant
5 to Chapter 26 of Title 12 of the Oklahoma Statutes may be initiated.
6 If judgment is rendered in favor of the plaintiff in any action
7 described in this subsection, the court shall also render judgment
8 for a reasonable attorney fee in favor of the plaintiff against the
9 defendant. If judgment is rendered in favor of the defendant and
10 the court finds that the plaintiff's suit was frivolous and brought
11 in bad faith, the court shall also render judgment for a reasonable
12 attorney fee in favor of the defendant against the plaintiff.

13 G. If an abortion provider fails to submit any report required
14 pursuant to Section 1-738k of this title, upon the refusal, failure
15 or neglect of the State Commissioner of Health, within twenty (20)
16 days after written demand signed, verified and served upon the State
17 Department of Health by at least ten registered voters of the state,
18 to institute or diligently prosecute proper proceedings at law or in
19 equity to compel an abortion provider to submit any report required
20 pursuant to Section 1-738k of this title but not yet submitted to
21 the State Department of Health, any resident taxpayer of the state
22 after serving the notice aforesaid may in the name of the State of
23 Oklahoma as plaintiff, institute and maintain any proper action
24 which the State Department of Health might institute and maintain to

1 compel the abortion provider to file such report. If a court of
2 competent jurisdiction determines the claims to be meritorious, the
3 abortionist shall be compelled to file the report and to pay the
4 fee(s) prescribed in subsection B of this section, with costs and
5 reasonable attorney fees. If all claims stated by the resident
6 taxpayers in the written demand are determined in a court of
7 competent jurisdiction to be frivolous and brought in bad faith, the
8 resident taxpayers who signed such demand and who are parties to the
9 lawsuit in which such claims are determined to be frivolous and
10 brought in bad faith shall be jointly and severally liable for all
11 reasonable attorney fees and court costs incurred by the
12 abortionist.

13 SECTION 4. NEW LAW A new section of law to be codified
14 in the Oklahoma Statutes as Section 1-738q of Title 63, unless there
15 is created a duplication in numbering, reads as follows:

16 If some or all of the provisions of Sections 1-738k, 1-738m and
17 1-738n of Title 63 of the Oklahoma Statutes, as amended by Sections
18 1, 2 and 3 of this act, are ever temporarily or permanently
19 restrained or enjoined by judicial order, these sections shall be
20 enforced as though such restrained or enjoined provisions had not
21 been adopted; provided, however, that whenever such temporary or
22 permanent restraining order or injunction is stayed or dissolved, or
23 otherwise ceases to have effect, such provisions shall have full
24 force and effect.

SECTION 5. This act shall become effective November 1, 2013.
