An Act relating to crimes and punishments; amending 21 O.S. 2011, Section 1280.1, as last amended by Section 2, Chapter 344, O.S.L. 2013 (21 O.S. Supp. 2013, Section 1280.1), which relates to the possession of firearms on school property; adding exception to certain prohibited act; and providing an effective date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY 21 O.S. 2011, Section 1280.1, as last amended by Section 2, Chapter 344, O.S.L. 2013 (21 O.S. Supp. 2013, Section 1280.1), is amended to read as follows:

Section 1280.1

POSSESSION OF FIREARM ON SCHOOL PROPERTY

A. It shall be unlawful for any person to have in his or her possession on any public or private school property or while in any school bus or vehicle used by any school for transportation of students or teachers any firearm or weapon designated in Section

1 1272 of this title, except as provided in subsection C of this
2 section or as otherwise authorized by law.

3 B. For purposes of this section:

4 1. "School property" means any publicly owned property held for
5 purposes of elementary, secondary or vocational-technical education,
6 and shall not include property owned by public school districts or
7 where such property is leased or rented to an individual or
8 corporation and used for purposes other than educational; and

9 2. "Private school" means a school that offers a course of
10 instruction for students in one or more grades from prekindergarten
11 through grade twelve and is not operated by a governmental entity.

12 C. Firearms and weapons are allowed on school property and
13 deemed not in violation of subsection A of this section as follows:

14 1. A gun or knife designed for hunting or fishing purposes kept
15 in a privately owned vehicle and properly displayed or stored as
16 required by law, or a handgun carried in a vehicle pursuant to a
17 valid handgun license authorized by the Oklahoma Self-Defense Act,
18 provided such vehicle containing said gun or knife is driven onto
19 school property only to transport a student to and from school and
20 such vehicle does not remain unattended on school property;

21 2. A gun or knife used for the purposes of participating in the
22 Oklahoma Department of Wildlife Conservation certified hunter
23 training education course or any other hunting, fishing, safety or
24 firearms training courses, or a recognized firearms sports event,

1 team shooting program or competition, or living history reenactment,
2 provided the course or event is approved by the principal or chief
3 administrator of the school where the course or event is offered,
4 and provided the weapon is properly displayed or stored as required
5 by law pending participation in the course, event, program or
6 competition;

7 3. Weapons in the possession of any peace officer or other
8 person authorized by law to possess a weapon in the performance of
9 his or her duties and responsibilities; ~~and~~

10 4. A concealed or unconcealed weapon carried onto private
11 school property or in any school bus or vehicle used by any private
12 school for transportation of students or teachers by a person who is
13 licensed pursuant to the Oklahoma Self-Defense Act, provided a
14 policy has been adopted by the governing entity of the private
15 school that authorizes the possession of a weapon on private school
16 property or in any school bus or vehicle used by a private school.
17 Except for acts of gross negligence or willful or wanton misconduct,
18 a governing entity of a private school that adopts a policy which
19 authorizes the possession of a weapon on private school property, a
20 school bus or vehicle used by the private school shall be immune
21 from liability for any injuries arising from the adoption of the
22 policy. The provisions of this paragraph shall not apply to claims
23 pursuant to the Workers' Compensation Code; and

1 5. A gun, knife, bayonet or other weapon in the possession of a
2 member of a veterans group, the national guard, active military, the
3 reserve officers' training corps (ROTC) or junior ROTC, in order to
4 participate in a ceremony, assembly or educational program approved
5 by the principal or chief administrator of a school or school
6 district where the ceremony, assembly or educational program is
7 being held; provided, however, the gun or other weapon that uses
8 projectiles is not loaded and is inoperable at all times while on
9 school property.

10 D. Any person violating the provisions of this section shall,
11 upon conviction, be guilty of a felony punishable by a fine of not
12 to exceed Five Thousand Dollars (\$5,000.00), and imprisonment in the
13 custody of the Department of Corrections for not more than two (2)
14 years. Any person convicted of violating the provisions of this
15 section after having been issued a handgun license pursuant to the
16 provisions of the Oklahoma Self-Defense Act shall have the license
17 permanently revoked and shall be liable for an administrative fine
18 of One Hundred Dollars (\$100.00) upon a hearing and determination by
19 the Oklahoma State Bureau of Investigation that the person is in
20 violation of the provisions of this section.

21 SECTION 2. This act shall become effective November 1, 2014.
