8	A Resolution recognizing and celebrating the careers and accomplishments of certain judges; applauding
9	them for their dedication; thanking them for their service; and directing distribution.

12	WHEREAS, throughout history, African Americans have played a
13	significant role in every facet of the history and culture of the
14	State of Oklahoma, and continue to do so; and
15	WHEREAS, Judge Vicki Miles-LaGrange, Justice Tom Colbert, Judge
16	David Lewis and Judge Carlos Chappelle through hard work and
17	perseverance have or will become the first African Americans to
18	serve on their respective courts; and
19	WHEREAS, Judge Vicki Miles-LaGrange was the first African
20	American elected Chief Judge of the U.S. District Court for the
21	Western District of Oklahoma in 2008, having been the first African
22	American woman to be sworn in as U.S. attorney for the same court in
23	1998. She was also one of the first African American females
24	elected to the Oklahoma State Senate in 1987; and

1 WHEREAS, appointed by Governor Brad Henry in 2004 as the first 2 African American to serve on the Oklahoma Supreme Court, Justice Tom 3 Colbert made Oklahoma history by becoming the first African American to serve as Chief Justice of the state's highest court, the Oklahoma 4 5 Supreme Court, and holds the distinction of being the first African American Vice Chief Justice of the Oklahoma Supreme Court. He also 6 was the first African American to serve on the Court of Civil 7 Appeals where he was elected to serve as chief judge; and 8

9 WHEREAS, appointed by Governor Brad Henry on August 4, 2005, 10 Judge David Lewis was the first African American to serve on the 11 Court of Criminal Appeals for the 5th Judicial District. He 12 continued to make history when he was sworn in as the first African 13 American to serve as chief judge of the Court of Criminal Appeals, 14 the state's highest court with appellate jurisdiction in criminal 15 cases, on January 23, 2013; and

WHEREAS, appointed district judge for Tulsa County by Governor 16 Brad Henry in 2009 and reelected without opposition in 2010, Judge 17 Carlos Chappelle became the first African American to be appointed a 18 District Judge for Tulsa County. In September 2011, he was the 19 first African American elected Presiding Judge Elect and in January 20 2014, he will become the first African American to be Presiding 21 Judge for the 14th Judicial District of the State of Oklahoma, 22 covering Tulsa and Pawnee counties. 23
