AS INTRODUCED

An Act relating to general appropriations for the expenses of various agencies of the executive, legislative and judicial departments of the state; making appropriations to the State Board of Education, the Oklahoma Arts Council, the Commissioners of the Land Office, the Board of Trustees of the Oklahoma School of Science and Mathematics, the Oklahoma Commission for Teacher Preparation, the State Board of Career and Technology Education, the Oklahoma Educational Television Authority, Oklahoma Department of Libraries, the Oklahoma State Regents for Higher Education, the Physician Manpower Training Commission, the Oklahoma Center for the Advancement of Science and Technology, the Office of the State Auditor and Inspector, the Office of the State Bond Advisor, the State Election Board, the Oklahoma Department of Emergency Management, the Ethics Commission, the Office of the Governor, the Oklahoma House of Representatives, the Legislative Service Bureau, the Office of the Lieutenant Governor, the Office of Management and Enterprise Services, the Oklahoma Merit Protection Commission, the Military Department of the State of Oklahoma, the Oklahoma State Senate, the Oklahoma Tax Commission, the Office of the State Treasurer, the Department of Transportation, the Oklahoma Space Industry Development Authority, the State Department of Health, the Oklahoma Health Care Authority, the J.D. 12 Historical Society, the Oklahoma Horse Racing
13 Commission, the Insurance Department, the J.M. Davis
14 Memorial Commission, the Department of Labor, the
15 Department of Mines, the Scenic Rivers Commission,
16 the Oklahoma Tourism and Recreation Department, the
17 Oklahoma Water Resources Board, the Will Rogers
18 Memorial Commission, the Alcoholic Beverage Laws
19 Enforcement Commission, the Department of
20 Corrections, the Office of the State Fire Marshal,
21 the Oklahoma State Bureau of Investigation, the
22 Council on Law Enforcement Education and Training,
23 the Board of Medicolegal Investigations, the Oklahoma
24 State Bureau of Narcotics and Dangerous Drugs
Control, the Department of Public Safety, the Office
of the Attorney General, district attorneys and the
District Attorneys Council, the Court of Criminal
Appeals, the Supreme Court, the Oklahoma Indigent
Defense System, the Pardon and Parole Board and the
Workers' Compensation Court; stating amounts of the
appropriations; stating purposes and restrictions;
authorizing and requiring certain expenditures;
authorizing and requiring certain transfers;
requiring certain deposit; and providing an effective
date.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

COMMON EDUCATION

SECTION 1. There is hereby appropriated to the State Board of
Education from any monies not otherwise appropriated from the

1 Education Reform Revolving Fund created in Section 34.89 of Title 62
2 of the Oklahoma Statutes, the sum of _____ Dollars (\$0.00) or
3 so much thereof as may be necessary for the financial support of
4 public schools.

5 SECTION 2. The State Board of Education is hereby authorized to
6 expend during the fiscal year ending June 30, 2014, from the Common
7 Education Technology Revolving Fund of the State Treasury, the sum
8 of _____ Dollars (\$0.00) or so much thereof as may be necessary
9 for the financial support of public schools.

10 SECTION 3. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 Mineral Leasing Fund of the State Treasury for the fiscal year
13 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
14 much thereof as may be necessary for the financial support of public
15 schools.

16 SECTION 4. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Mineral Leasing Fund of the State Treasury for the fiscal year
19 ending June 30, 2012, the sum of _____ Dollars (\$0.00) or so
20 much thereof as may be necessary for the financial support of public
21 schools.

22 SECTION 5. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2014, the sum of _____ Dollars
2 (\$0.00) or so much thereof as may be necessary for the financial
3 support of public schools.

4 SECTION 6. There is hereby appropriated to the State Board of
5 Education from any monies not otherwise appropriated from the
6 General Revenue Fund of the State Treasury for the fiscal year
7 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
8 much thereof as may be necessary for the support of public schools
9 activities.

10 SECTION 7. There is hereby appropriated to the State Board of
11 Education from any monies not otherwise appropriated from the
12 General Revenue Fund of the State Treasury for the fiscal year
13 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
14 much thereof as may be necessary for administrative and support
15 functions of the State Department of Education.

16 SECTION 8. There is hereby appropriated to the State Board of
17 Education from any monies not otherwise appropriated from the
18 Oklahoma Education Lottery Trust Fund of the State Treasury for the
19 fiscal year ending June 30, 2014, the sum of _____ Dollars
20 (\$0.00) or so much thereof as may be necessary for transfer to the
21 School Consolidation Assistance Fund.

22 SECTION 9. There is hereby appropriated to the State Board of
23 Education from any monies not otherwise appropriated from the
24 Oklahoma Education Lottery Trust Fund of the State Treasury for the

1 fiscal year ending June 30, 2014, the sum of _____ Dollars
2 (\$0.00) or so much thereof as may be necessary for transfer to the
3 Teachers' Retirement System Dedicated Revenue Revolving Fund.

4 SECTION 10. There is hereby appropriated to the Oklahoma Arts
5 Council from any monies not otherwise appropriated from the General
6 Revenue Fund of the State Treasury for the fiscal year ending June
7 30, 2014, the sum of _____ Dollars (\$0.00) or so much thereof
8 as may be necessary to perform the duties imposed upon the Oklahoma
9 Arts Council by law.

10 SECTION 11. There is hereby appropriated to the Commissioners
11 of the Land Office from any monies not otherwise appropriated from
12 the Commissioners of the Land Office Fund of the State Treasury for
13 the fiscal year ending June 30, 2014, the sum of _____ Dollars
14 (\$0.00) or so much thereof as may be necessary to perform the duties
15 imposed upon the Commissioners of the Land Office by law.

16 SECTION 12. There is hereby appropriated to the Board of
17 Trustees of the Oklahoma School of Science and Mathematics from any
18 monies not otherwise appropriated from the General Revenue Fund of
19 the State Treasury for the fiscal year ending June 30, 2014, the sum
20 of _____ Dollars (\$0.00) or so much thereof as may be necessary
21 to perform the duties imposed upon the Board of Trustees of the
22 Oklahoma School of Science and Mathematics by law.

23 SECTION 13. There is hereby appropriated to the Oklahoma
24 Commission for Teacher Preparation from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2014, the sum of _____ Dollars
3 (\$0.00) or so much thereof as may be necessary to perform the duties
4 imposed upon the Oklahoma Commission for Teacher Preparation by law.

5 CAREER AND TECHNOLOGY EDUCATION

6 SECTION 14. There is hereby appropriated to the State Board of
7 Career and Technology Education from any monies not otherwise
8 appropriated from the General Revenue Fund of the State Treasury for
9 the fiscal year ending June 30, 2014, the sum of _____ Dollars
10 (\$0.00) or so much thereof as may be necessary to perform the duties
11 imposed upon the State Board of Career and Technology Education by
12 law.

13 SECTION 15. There is hereby appropriated to the State Board of
14 Career and Technology Education from any monies not otherwise
15 appropriated from the Oklahoma Education Lottery Trust Fund of the
16 State Treasury for the fiscal year ending June 30, 2014, the sum of
17 _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection C
18 of Section 713 of Title 3A of the Oklahoma Statutes for allocation
19 by the State Board of Career and Technology Education for the
20 education and general operating budgets of the institutions and for
21 other programs, construction, renovations or repairs administered by
22 the State Board of Career and Technology Education.

23 SECTION 16. There is hereby appropriated to the Oklahoma
24 Educational Television Authority from any monies not otherwise

1 appropriated from the General Revenue Fund of the State Treasury for
2 the fiscal year ending June 30, 2014, the sum of _____ Dollars
3 (\$0.00) or so much thereof as may be necessary to perform the duties
4 imposed upon the Oklahoma Educational Television Authority by law.

5 SECTION 17. There is hereby appropriated to the Oklahoma
6 Department of Libraries from any monies not otherwise appropriated
7 from the General Revenue Fund of the State Treasury for the fiscal
8 year ending June 30, 2014, the sum of _____ Dollars (\$0.00) or
9 so much thereof as may be necessary to perform the duties imposed
10 upon the Oklahoma Department of Libraries by law.

11 HIGHER EDUCATION

12 SECTION 18. There is hereby appropriated to the Oklahoma State
13 Regents for Higher Education from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2014, the sum of _____ Dollars
16 (\$0.00) or so much thereof as may be necessary for allocation by the
17 Oklahoma State Regents for Higher Education pursuant to the
18 provisions of Article XIII-A of the Oklahoma Constitution for the
19 education and general operating budgets of the institutions and for
20 other programs, construction, renovations or repairs administered by
21 the Oklahoma State Regents for Higher Education. Of those funds
22 appropriated, the sum of _____ Dollars (\$0.00) shall be
23 transferred to the Oklahoma Tuition Equalization Grant Trust Fund to
24

1 implement the provisions of the Oklahoma Tuition Equalization Grant
2 Act.

3 SECTION 19. The Oklahoma State Regents for Higher Education are
4 hereby authorized to expend during the fiscal year ending June 30,
5 2014, the sum of _____ Dollars (\$0.00) from the Higher
6 Education Capital Revolving Fund of the State Treasury for
7 allocation by the Oklahoma State Regents for Higher Education
8 pursuant to the provisions of Article XIII-A of the Oklahoma
9 Constitution for the education and general operating budgets of the
10 institutions and for other programs, construction, renovations or
11 repairs administered by the Oklahoma State Regents for Higher
12 Education.

13 SECTION 20. The Oklahoma State Regents for Higher Education are
14 hereby authorized to expend during the fiscal year ending June 30,
15 2014, the sum of _____ Dollars (\$0.00) from the Oklahoma
16 Student Aid Revolving Fund of the State Treasury for allocation by
17 the Oklahoma State Regents for Higher Education pursuant to the
18 provisions of Article XIII-A of the Oklahoma Constitution for the
19 education and general operating budgets of the institutions and for
20 other programs, construction, renovations or repairs administered by
21 the Oklahoma State Regents for Higher Education.

22 SECTION 21. There is hereby appropriated to the Oklahoma State
23 Regents for Higher Education from any monies not otherwise
24 appropriated from the Special Cash Fund of the State Treasury the

1 sum of _____ Dollars (\$0.00) for allocation by the Oklahoma
2 State Regents for Higher Education pursuant to the provisions of
3 Article XIII-A of the Oklahoma Constitution for the education and
4 general operating budgets of the institutions and for other
5 programs, construction, renovations or repairs administered by the
6 Oklahoma State Regents for Higher Education.

7 SECTION 22. There is hereby appropriated to the Oklahoma State
8 Regents for Higher Education from any monies not otherwise
9 appropriated from the proceeds of the sale of bonds deposited in the
10 Oklahoma Building Bonds of 1992 Fund A in the State Treasury, the
11 sum of _____ Dollars (\$0.00) or so much thereof as may be
12 necessary for allocation by the Oklahoma State Regents for Higher
13 Education pursuant to the provisions of Article XIII-A of the
14 Oklahoma Constitution for the education and general operating
15 budgets of the institutions and for other programs, construction,
16 renovations or repairs administered by the Oklahoma State Regents
17 for Higher Education.

18 SECTION 23. There is hereby appropriated to the Oklahoma State
19 Regents for Higher Education from any monies not otherwise
20 appropriated from the proceeds of the sale of bonds deposited in the
21 Oklahoma Building Bonds of 1992 Fund B in the State Treasury, the
22 sum of _____ Dollars (\$0.00) or so much thereof as may be
23 necessary for allocation by the Oklahoma State Regents for Higher
24 Education pursuant to the provisions of Article XIII-A of the

Oklahoma Constitution for the education and general operating budgets of the institutions and for other programs, construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education.

SECTION 24. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the General Revenue Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so much thereof as may be necessary for expenditures for concurrent enrollment pursuant to Section 628.13 of Title 70 of the Oklahoma Statutes.

SECTION 25. There is hereby appropriated to the Oklahoma State Regents for Higher Education from any monies not otherwise appropriated from the Oklahoma Education Lottery Trust Fund of the State Treasury for the fiscal year ending June 30, 2014, the sum of _____ Dollars (\$0.00) pursuant to paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes for allocation by the Oklahoma State Regents for Higher Education pursuant to the provisions of Article XIII-A of the Oklahoma Constitution for construction, renovations or repairs administered by the Oklahoma State Regents for Higher Education or for any other purpose authorized by paragraph 2 of subsection C of Section 713 of Title 3A of the Oklahoma Statutes.

1 SECTION 26. There is hereby appropriated to the Oklahoma State
2 Regents for Higher Education from any monies not otherwise
3 appropriated from the General Revenue Fund of the State Treasury for
4 the fiscal year ending June 30, 2014, the sum of _____ Dollars
5 (\$0.00) or so much thereof as may be necessary for the general
6 operating budget of the Administrative Offices of the Oklahoma State
7 Regents for Higher Education.

8 SECTION 27. There is hereby appropriated to the Oklahoma State
9 Regents for Higher Education from any monies not otherwise
10 appropriated from the General Revenue Fund of the State Treasury for
11 the fiscal year ending June 30, 2014, the sum of _____ Dollars
12 (\$0.00) or so much thereof as may be necessary for the Office of
13 Educational Quality and Accountability to perform the duties imposed
14 upon the Office of Educational Quality and Accountability. by law.

15 SECTION 28. There is hereby appropriated to the Physician
16 Manpower Training Commission from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2014, the sum of _____ Dollars
19 (\$0.00) or so much thereof as may be necessary to perform the duties
20 imposed upon the Physician Manpower Training Commission by law.

21 SECTION 29. There is hereby appropriated to the Physician
22 Manpower Training Commission from any monies not otherwise
23 appropriated from the Special Cash Fund of the State Treasury, the
24 sum of _____ Dollars (\$0.00) or so much thereof as may be

1 necessary to perform the duties imposed upon the Physician Manpower
2 Training Commission by law.

3 SECTION 30. There is hereby appropriated to the Oklahoma Center
4 for the Advancement of Science and Technology from any monies not
5 otherwise appropriated from the General Revenue Fund of the State
6 Treasury for the fiscal year ending June 30, 2014, the sum of
7 _____ Dollars (\$0.00) or so much thereof as may be necessary to
8 perform the duties imposed upon the Oklahoma Center for the
9 Advancement of Science and Technology by law.

11 GENERAL GOVERNMENT AND TRANSPORTATION

12 SECTION 31. There is hereby appropriated to the Office of the
13 State Auditor and Inspector from any monies not otherwise
14 appropriated from the General Revenue Fund of the State Treasury for
15 the fiscal year ending June 30, 2014, the sum of _____ Dollars
16 (\$0.00) or so much thereof as may be necessary to perform the duties
17 imposed upon the Office of the State Auditor and Inspector by law.

18 SECTION 32. There is hereby appropriated to the Office of the
19 State Auditor and Inspector from any monies not otherwise
20 appropriated from the General Revenue Fund of the State Treasury for
21 the fiscal year ending June 30, 2014, the sum of _____ Dollars
22 (\$0.00) or so much thereof as may be necessary to perform the duties
23 imposed upon the Commission on County Government Personnel Education
24 and Training. The appropriation made in this section shall be

1 expended exclusively for the purpose so stated and shall not be
2 transferable.

3 SECTION 33. There is hereby appropriated to the Office of the
4 State Bond Advisor from any monies not otherwise appropriated from
5 the General Revenue Fund of the State Treasury for the fiscal year
6 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary to perform the duties imposed upon
8 the Office of the State Bond Advisor by law.

9 SECTION 34. There is hereby appropriated to the State Election
10 Board from any monies not otherwise appropriated from the General
11 Revenue Fund of the State Treasury for the fiscal year ending June
12 30, 2014, the sum of _____ Dollars (\$0.00) or so much thereof
13 as may be necessary to perform the duties imposed upon the State
14 Election Board by law.

15 SECTION 35. There is hereby appropriated to the Oklahoma
16 Department of Emergency Management from any monies not otherwise
17 appropriated from the General Revenue Fund of the State Treasury for
18 the fiscal year ending June 30, 2014, the sum of _____ Dollars
19 (\$0.00) or so much thereof as may be necessary to perform the duties
20 imposed upon the Oklahoma Department of Emergency Management by law.

21 SECTION 36. There is hereby appropriated to the Ethics
22 Commission from any monies not otherwise appropriated from the
23 General Revenue Fund of the State Treasury for the fiscal year
24 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so

1 much thereof as may be necessary to perform the duties imposed upon
2 the Ethics Commission by law.

3 SECTION 37. There is hereby appropriated to the Office of the
4 Governor from any monies not otherwise appropriated from the General
5 Revenue Fund of the State Treasury for the fiscal year ending June
6 30, 2014, the sum of _____ Dollars (\$0.00) or so much thereof
7 as may be necessary to perform the duties imposed upon the Office of
8 the Governor by law.

9 SECTION 38. There is hereby appropriated to the Oklahoma House
10 of Representatives from any monies not otherwise appropriated from
11 the General Revenue Fund of the State Treasury for the fiscal year
12 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
13 much thereof as may be necessary to pay the salaries, per diem and
14 expenses of the members of the Oklahoma House of Representatives,
15 the salaries of the employees of the Oklahoma House of
16 Representatives, and other necessary expenses. Claims and payrolls
17 filed against the appropriation made to the Oklahoma House of
18 Representatives for the fiscal year ending June 30, 2014, shall be
19 approved by the Speaker of the Oklahoma House of Representatives.

20 SECTION 39. There is hereby appropriated to the Legislative
21 Service Bureau from any monies not otherwise appropriated from the
22 General Revenue Fund of the State Treasury for the fiscal year

3 SECTION 40. There is hereby appropriated to the Office of the

6 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
7 much thereof as may be necessary to perform the duties imposed upon
8 the Office of the Lieutenant Governor by law.

9 SECTION 41. There is hereby appropriated to the Office of
10 Management and Enterprise Services from any monies not otherwise
11 appropriated from the General Revenue Fund of the State Treasury for
12 the fiscal year ending June 30, 2014, the sum of _____ Dollars
13 (\$0.00) or so much thereof as may be necessary to perform the duties
14 imposed upon the Office of Management and Enterprise Services by
15 law.

16 SECTION 42. There is hereby appropriated to the Office of
17 Management and Enterprise Services from any monies not otherwise
18 appropriated from the General Revenue Fund of the State Treasury for
19 the fiscal year ending June 30, 2012, the sum of _____ Dollars
20 (\$0.00) or so much thereof as may be necessary to perform the duties
21 imposed upon the Office of Management and Enterprise Services by
22 law.

23 SECTION 43. There is hereby appropriated to the Office of
24 Management and Enterprise Services from any monies not otherwise

1 appropriated from the Public Building Fund of the State Treasury for
2 the fiscal year ending June 30, 2014, the sum of _____ Dollars
3 (\$0.00) to be transferred to the Building and Facility Revolving
4 Fund created in Section 63.1 of Title 74 of the Oklahoma Statutes
5 for the purpose of maintaining state buildings operated by the
6 Office of Management and Enterprise Services.

7 SECTION 44. There is hereby appropriated to the Office of
8 Management and Enterprise Services from any monies not otherwise
9 appropriated from the Public Building Fund of the State Treasury for
10 the fiscal year ending June 30, 2012, the sum of _____ Dollars
11 (\$0.00) or so much thereof as may be necessary to be transferred to
12 the Building and Facility Revolving Fund created in Section 63.1 of
13 Title 74 of the Oklahoma Statutes for the purpose of maintaining
14 state buildings operated by the Office of Management and Enterprise
15 Services.

16 SECTION 45. There is hereby appropriated to the Oklahoma Merit
17 Protection Commission from any monies not otherwise appropriated
18 from the General Revenue Fund of the State Treasury for the fiscal
19 year ending June 30, 2014, the sum of _____ Dollars (\$0.00) or
20 so much thereof as may be necessary to perform the duties imposed
21 upon the Oklahoma Merit Protection Commission by law.

22 SECTION 46. There is hereby appropriated to the Military
23 Department of the State of Oklahoma from any monies not otherwise
24 appropriated from the General Revenue Fund of the State Treasury for

1 the fiscal year ending June 30, 2014, the sum of _____ Dollars
2 (\$0.00) or so much thereof as may be necessary to perform the duties
3 imposed upon the Military Department of the State of Oklahoma by
4 law.

5 SECTION 47. There is hereby appropriated to the Oklahoma State
6 Senate from any monies not otherwise appropriated from the General
7 Revenue Fund of the State Treasury for the fiscal year ending June
8 30, 2014, the following amount, or so much thereof as may be
9 necessary to pay monthly salaries, per diem, and expenses of the
10 members of the Senate and the salaries of the Secretary of the
11 Senate and employees, and such contingent expenses as may be ordered
12 paid therefrom, including the preparation and printing of the
13 journals and calendars of the Senate, and including the preparation
14 and printing of the permanent journals thereof, in accordance with
15 the following amount herein set forth:

1 SECTION 48. There is hereby appropriated to the Oklahoma Tax
2 Commission from any monies not otherwise appropriated from the
3 General Revenue Fund of the State Treasury for the fiscal year
4 ending June 30, 2014, the sum of _____ Dollars (\$0.00) or so
5 much thereof as may be necessary to perform the duties imposed upon
6 the Oklahoma Tax Commission by law.

7 SECTION 49. From the appropriation made in Section 49 of this
8 act, the Oklahoma Tax Commission shall pay an amount not to exceed
9 _____ Dollars (\$0.00) for the personal services and other
10 operating expenses of the Office of the State Auditor and Inspector
11 in performing audits of the Oklahoma Tax Commission and motor
12 license agents as required by law.

13 SECTION 50. From the appropriation made in Section 49 of this
14 act, the Oklahoma Tax Commission shall pay an amount not to exceed
