L8	B. The Wildlife Conservation Commission shall decide the open

21	C. Persons who hunt and take black bear pursuant to this
22	section shall be required to attach a tag to a killed black bear.

1. For legal residents, One Hundred Dollars ($100.00); and

- 2. For nonresidents, Five Hundred Dollars (\$500.00); and
- 3. For legal residents who have a lifetime hunting license or a lifetime combination hunting and fishing license issued before July 1, 2012, there shall be no fee for a license issued pursuant to this section.
- $\frac{D}{C}$. Any person who fails to obtain a license as required in subsection A of this section and pay the fee as required in paragraph 1 of subsection $\frac{C}{C}$ of this section, upon conviction, shall be punished by a fine of not less than Two Hundred Dollars (\$200.00) nor more than Five Hundred Dollars (\$500.00) or by imprisonment in the county jail for a period not to exceed six (6) months, or by both said fine and imprisonment.
- $E ext{-} F.$ Any person who fails to obtain a license as required in subsection A of this section and pay the fee as required in paragraph 2 of subsection $E ext{-} D$ of this section, upon conviction, shall be punished by a fine of not less than Eight Hundred Dollars (\$800.00) nor more than One Thousand Dollars (\$1,000.00) or by imprisonment in the county jail for a period not to exceed six (6) months, or by both said fine and imprisonment.
- SECTION 2. This act shall become effective July 1, 2013.
- SECTION 3. It being immediately necessary for the preservation of the public peace, health and safety, an emergency is hereby
