PROPOSED COMMITTEE SUBSTITUTE

An Act relating to roads and bridges; amending
Section 4, Chapter 61, O.S.L. 2015 (69 O.S. Supp.
2015, Section 1698.215), which relates to memorial
highway designations; modifying designation of
certain highway; designating the J. Cooper West
Memorial Highway; requiring certain markers;
providing for codification; providing an effective
date; and declaring an emergency.

BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

SECTION 1. AMENDATORY Section 4, Chapter 61, O.S.L. 2015
(69 O.S. Supp. 2015, Section 1698.215), is amended to read as
follows:

Section 1698.215 The section of U.S. Highway 81 in Jefferson
County from the junction of U.S. Highway 81 and U.S. Highway 70
extending north and then northeast to the municipal limits of
Addington shall be designated as the "Congressional Medal of Honor

1 Recipient Command Sergeant Major Benny G. Adkins Highway". The
2 Department of Transportation shall cause suitable permanent markers
3 bearing that name to be placed on the highway.

4 SECTION 2. NEW LAW A new section of law to be codified
5 in the Oklahoma Statutes as Section 1698.231 of Title 69, unless
6 there is created a duplication in numbering, reads as follows:

7 The section of Interstate 40 Business extending west from the
8 Beckham County Line to one-quarter (1/4) of a mile west of the
9 Interstate 40 and State Highway 34 Interchange shall be designated
10 as the "J. Cooper West Memorial Highway". The Department of
11 Transportation shall cause suitable permanent markers bearing that
12 name to be placed on the highway.

13 SECTION 3. This act shall become effective July 1, 2016.

14 SECTION 4. It being immediately necessary for the preservation
15 of the public peace, health and safety, an emergency is hereby
16 declared to exist, by reason whereof this act shall take effect and
17 be in full force from and after its passage and approval.
