salaries; modifying and establishing salaries of
employees of Bureau upon certain funding; providing
an effective date; and declaring an emergency.

13 BE IT ENACTED BY THE PEOPLE OF THE STATE OF OKLAHOMA:

14 SECTION 1. AMENDATORY 74 O.S. 2011, Section 150.6a, as
15 amended by Section 2, Chapter 351, O.S.L. 2013 (74 O.S. Supp. 2014,
16 Section 150.6a), is amended to read as follows:

3 ~~Provided, however, no such employee shall receive less than the~~
4 ~~salary the employee received on December 31, 2006. Subject to the~~
5 ~~availability of funds, the annual salaries for Oklahoma State Bureau~~
6 ~~of Investigation employees shall be in accordance and conformity~~
7 ~~with the findings of the State of Oklahoma Total Remuneration Study~~
8 ~~of 2013, exclusive of longevity pay, as authorized by Section 840-~~
9 ~~2.18 of this title or the findings of state or agency salary,~~
10 ~~compensation, and remuneration studies or surveys approved by the~~
11 ~~Human Capital Management Division of the Office of Management and~~
12 ~~Enterprise Services.~~

13 Nothing in this section shall be construed to prohibit a
14 reduction in pay or salary due to involuntary leave without pay as
15 authorized in Section 840-2.27C of this title.

16 SECTION 2. This act shall become effective July 1, 2015.

17 SECTION 3. It being immediately necessary for the preservation
18 of the public peace, health and safety, an emergency is hereby
19 declared to exist, by reason whereof this act shall take effect and
20 be in full force from and after its passage and approval.
