5 A Joint Resolution directing the Secretary of State
6 to refer to the people for their approval or
7 rejection a proposed amendment to the Oklahoma
8 Constitution by adding a new Section 9A to Article
9 II; establishing full force and effect of certain
statutes; providing for validity of changes in
methods of execution; providing ballot title; and
directing filing.

11 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE
12 1ST SESSION OF THE 55TH OKLAHOMA LEGISLATURE:

13 SECTION 1. The Secretary of State shall refer to the people for
14 their approval or rejection, as and in the manner provided by law,
15 the following proposed amendment to the Oklahoma Constitution by
16 adding a new Section 9A to Article II to read as follows:

17 Section 9A. All statutes of this state requiring, authorizing,
18 imposing or relating to the death penalty are in full force and
19 effect, subject to legislative amendment or repeal by statute,
20 initiative or referendum. Any method of execution shall be allowed,
21 unless prohibited by the United States Constitution. Methods of
22 execution may be designated by the Legislature. A sentence of death
23 shall not be reduced on the basis that a method of execution is

1 invalid. In any case in which an execution method is declared
2 invalid, the death sentence shall remain in force until the sentence
3 can be lawfully executed by any valid method. The death penalty
4 provided for under such statutes shall not be deemed to be, or to
5 constitute, the infliction of cruel or unusual punishments, nor
6 shall such punishment be deemed to contravene any other provision of
7 this Constitution.

8 SECTION 2. The Ballot Title for the proposed Constitutional
9 amendment as set forth in SECTION 1 of this resolution shall be in
10 the following form:

12 Legislative Referendum No. _____ State Question No. _____

13 THE GIST OF THE PROPOSITION IS AS FOLLOWS:

14 This measure adds a new section to the Oklahoma Constitution. It
15 adds Section 9A of Article 2. It states that all death penalty
16 statutes are in effect. It states that methods of execution can
17 be changed. It states that the death penalty is not cruel and
18 unusual punishment.
