1 ENGROSSED SENATE JOINT 2 RESOLUTION NO. 45 By: Schulz and Ford of the Senate 3 and 4 Ortega of the House 5 6 7 A Joint Resolution directing the Secretary of State to refer to the people for their approval or rejection a proposed amendment to Sections 4 and 23 8 of Article VI of the Oklahoma Constitution; deleting 9 obsolete language; modifying limits on terms of office for certain elected officials; providing ballot title; and directing filing. 10 11 12 BE IT RESOLVED BY THE SENATE AND THE HOUSE OF REPRESENTATIVES OF THE 13 2ND SESSION OF THE 55TH OKLAHOMA LEGISLATURE: 14 15 SECTION 1. The Secretary of State shall refer to the people for 16 their approval or rejection, as and in the manner provided by law, the following proposed amendment to Sections 4 and 23 of Article VI 17 of the Oklahoma Constitution to read as follows: 18 Section 4. A. The term of office of the Governor, Lieutenant 19 Governor, State Auditor and Inspector, Attorney General, State 20 Treasurer, Commissioner of Labor and Superintendent of Public 21 Instruction shall be four (4) years from the second Monday of 22 January next after their election. The said officers shall be 23 24

- eligible to immediately succeed themselves except as otherwise provided in this section.
- B. 1. No person shall be eligible to serve as Governor for a period of time in excess of eight (8) years. Such years need not be consecutive. Any years served by a person serving as Governor for less than a full term to fill a vacancy in such office shall not be included in the eight-year limitation set forth herein.
- 2. Notwithstanding the provisions of this amendment, any person serving as Governor at the time of passage of this amendment shall be eligible to complete the term of office to which he or she was elected but shall not be eligible to serve as Governor for a period of time in excess of eight (8) years, excluding years served for less than a full term to fill a vacancy in such office. The provisions of this paragraph shall apply regardless of whether such years were served prior to or after passage of this amendment.
- C. No person shall be eligible to serve as Lieutenant Governor, State Auditor and Inspector, Attorney General, State Treasurer, Commissioner of Labor or Superintendent of Public Instruction for a period of time in excess of eight (8) twelve (12) years. Such years need not be consecutive. Any years served by a person elected or appointed to serve less than a full term to fill a vacancy in any such office shall not be included in the limitations set forth herein. Any person serving in such position at the time of passage of this amendment shall be eligible to complete the term for which

- he or she has been elected and shall be eligible to serve an

 additional eight (8) years thereafter for additional years such that

 the period of time served does not exceed twelve (12) years,

 excluding years not included in the limitations set forth herein,

 notwithstanding the provisions of this amendment.
 - D. The Legislature is hereby authorized to enact laws to implement the provisions of subsections B and C of this section.
 - Section 23. A. There shall be elected by the qualified electors of the State, at the first general election, a chief officer of the Insurance Department, who shall be styled the "Insurance Commissioner", whose term of office shall be four years: Provided, That the first term of the Insurance Commissioner so elected, shall expire at the time of the expiration of the term of office of the first Governor elected. The Insurance Commissioner shall be at least twenty-five (25) years of age and well versed in insurance matters.
 - B. No person shall be eligible to serve as Insurance Commissioner for a period of time in excess of eight (8) twelve (12) years. Such years need not be consecutive. Any years served by a person elected or appointed to serve less than a full term to fill a vacancy in such office shall not be included in the limitation set forth herein. Any person serving in such position at the time of passage of this amendment shall be eligible to complete the term for which he or she has been elected and shall be eligible to serve an

1 additional eight (8) years thereafter for additional years such that

2 the period of time served does not exceed twelve (12) years,

excluding years not included in the limitations set forth herein,

notwithstanding the provisions of this amendment. The Legislature

12 | THE GIST OF THE PROPOSITION IS AS FOLLOWS:

This measure amends Sections 4 and 23 of Article 6 of the Oklahoma Constitution. Under current law, persons are not eligible to serve as Governor, Lieutenant Governor, State Auditor and Inspector, Attorney General, State Treasurer, Commissioner of Labor, Superintendent of Public Instruction or Insurance Commissioner for more than 8 years, with certain exceptions. This measure changes the limit to 12 years for all these offices except Governor, which would stay at 8 years. Persons serving at the time of passage of this amendment may complete their current terms and serve additional years so that the total period of time served does not exceed 12 years. The measure also deletes some obsolete language.
